Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN THE SUPPLEMENTAL AGREEMENT FOR JANITORIAL SERVICES BETWEEN THE CITY GOVERNMENT OF BACOOR AND TOPSERVE SERVICE SOLUTIONS, INC. FOR THE FACILITATION OF PAYMENT REGARDING THE RETRO ADJUSTMENT DUE TO PREVIOUSLY DEPLOYED JANITORIAL PERSONNEL ASSIGNED IN THE CITY GOVERNMENT OF BACOOR AMOUNTING TO PHP526,562.64 – PCR·305·2023 dated May 22, 2023

Referred to this Committee on the 44th Regular Session is the above subject matter for appropriate action and recommendation.

In its Indorsement No. 280, Series of 2023, the Office of the City Legal Services thru Atty. Paul Michael G. Sanggalang, Office of the City Mayor, submitted for consideration of City Mayor, Hon. Strike B. Revilla the request of Topserve Service Solutions, Inc for the facilitation of payment relative to the retro adjustment of minimum wages in Region IV-A under Wage Order No. IVA-19 and increase of contributions under Philhealth Advisory No. 2022-0010 covering the janitorial personnel assigned in the City Government of Bacoor. In the same advice, the draft of Supplemental Agreement and the photocopies of the issuances are also submitted with the recommendation that the requests be approved and be endorsed to the Sangguniang Panlungsod for the issuance of authority to sign the Supplemental Agreement. The significant parts of the Indorsement 280, Series of 2023 are hereunder quoted:

All things having been found to be in order, we hereby endorse to your good office the above-mentioned Supplemental Agreement <u>FOR APPROVAL</u> of our Honorable Mayor Strike B. Revilla, and subsequent indorsement to the Sangguniang Panlungsod for the issuance of authorization to sign the Agreement."

During the committee hearing, the Honorable Chairman requested Ms. Elvinia Guerrero, City Budget Officer to comment on the funding of payment, and then called the attention and informed Atty. Paul Sanggalang that the particulars for the Philhealth adjustment of contributions in the stipulation under Item No. 1 of the draft of Supplemental Agreement is missing or is not mentioned.

In furtherance of the committee hearing, the following issues are resolved:

- The requests for payment of salary adjustment and increase in Philhealth contributions are mandatory obligations under the existing labor laws, policies, rules and regulations.
- The particulars for Philhealth retro billings shall be indicated in Item No. 1 of the Supplemental Agreement.
- The approval of City Resolution authorizing the City Mayor to sign the Supplemental Agreement shall be recommended by the Committee with the implementation of payment subject to the availability of fund.

RECOMMENDATION:

In view of the foregoing, and considering that there is no legal nor there is an administrative issue to cause the denial of the subject request, the Honorable Members of the Committee hereby recommend *TO APPROVE* the City Resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign the Supplemental Agreement with Topserve Solutions, Inc. relative to the payment of salary adjustment from July 1, 2022 to December 31, 2022 and the Philhealth Retro Billing from January 1, 2022 to June 30, 2022 involving the janitorial personnel assigned in the City Government of Bacoor. The implementation of the payment shall be subject to the availability of fund, accounting and auditing rules and regulations.

Kaya nga po sabi ni Mam Elvie tapos na yung Annual Budget. Nag take effect po kasi yung guidelines ng DOLE last June 14, 2022 kaya talaga pong late na yung aming supplemental reimbursement."

Ms. Elvinia S. Guerrero: "Pero yung Security Agency na Aquarius nakahabol sila, naibigay po natin yun naka charged sa 2022 budget natin yun."



RECITALS:

That, the CffY conducted the Public Bidding for the procurement of security services in accordance with RA No. 9184 and its IRR, to which the CONTRACTOR was determined to be the bidder with the Single Calculated and Responsive Bid in consideration of Fourteen Million One Hundred Three Thousand Seven Hundred Thirty-One Pesos and 88/100 Pesos (PhP14,103,731.88) bid and contract period of one year from 01 January 2022 to 31 December 2022:

That, the object of the contract between the CITY and the CONTRACTOR is the deployment of (orty-seven (47) janitorial manpower, live (5) team leaders and two (2) supervisors at the Bacoor City Government Center Compound and Hall of Justice, and all other inclusions in the contract.

That, the Wage Order No. IVA-19 issued by the Regional Tripartite Wages and Productivity Board Region IV-A CALABARZON on 30 May 2022 will take effect on 30 June 2022, imposing an increase of thirty Live Pesos (PhP35 00) on the basic daily wage of workers in Bacoor City, thereby setting the new minimum wage at Four Hundred Thirty Five Pesos (PhP435 00) per day for the cities of Bacoor and Imas, Province of Cavite:

NOW, the CITY and the CONTRACTOR expressed their intention to come into agreement once again in upholding the interest of public service particularly the protection to labor, and stipulate the following:

- 1. The CITY commits to pay the CONTRACTOR the supplemental amount of Five Hundred Twenty Six Thousand Five Hundred Sixty Two Pesos and 64/100 Pesos (PhP526, 562.64) representing the wage increase of (47) janutorial manpower, five (5) team leaders and two (2) supervisors of the CONTRACTOR computed for six (6) months from 01 July 2022 to 31 December 2022.
- The CONTRACTOR understands that the CITY fully complied with its contractual and statutory obligations with the former and holds the latter free from any liability or claim arising from the wage increase subject of this Supplemental Agreement.
- The provisions of the Contract Agreement entered into on 27 December 2021 shall remain in full force and effect and shall be read in harmony with this Supplemental Agreement until its complete performance.

WAGE ORDER NO. IVA-19

PROVIDING FOR A MINIMUM WAGE INCREASE IN REGION - 4A

WHEREAS, the Regional Tripartite Wages and Productivity Board - 4A is mandated under Republic Act No. 6727, otherwise known as The Wage Rationalization Act, to periodically assess the prevailing regional minimum wage rates and conduct continuing studies to determine whether these are still responsive to the economic condition in the region;

WHEREAS, pursuant to the Omnibus Rules on Minimum Wage Determination, the Board decided motu proprio to conduct virtual multisectoral public consultations and blended regional public hearing in view of the extraordinary increases in the price of petroleum products which triggered the increases in the prices of basic goods and services and clamor for wage and fare hikes;

WHEREAS, prior to the conduct of public hearing, the Board received on different dates, petitions for wage increase from the Federation of Free Workers, Metal Workers Alliance of the Philippines, the Association of Minimum Wage Earners and Advocates - PTGWO, and the Trade Union Congress of the Philippines, all of which were presented and discussed during the public hearing:

WHEREAS, in setting the new minimum wage rates for private sector workers in the region, the Board considered the petitions and positions of affected sectors on the wage issue, the results of public consultations and public hearing conducted, the prevailing socio-economic indicators and criteria for wage setting such as the amount to restore the purchasing power of the peso, the two-tiered wage system, poverty threshold, the impact of the Covid-19 pandemic, comparability of wages vis-a-vis benchmark regions and the dispersal of industries across the region among others;

NOW THEREFORE, by virtue of the power and authority vested under RA No. 5727, RTWPB-4A hereby issues this Wage Order.

Section 1. Amount of Increase. There shall be two Tranches of basic wage adjustments under this Wage Order. Upon effectivity of the 1st Tranche, minimum wage earners in the private sector in the Region shall receive three pesos (Php3.00) per day to forty-nine pesos (Php49.00) per day on top of their present minimum wage rates. Upon effectivity of the 2nd Tranche, they shall receive up to forty-eight pesos (Php48.00) per day on top of the 1st Tranche.

Section 2. New Minimum Wage Rates. The new daily minimum wage rates in Region- 4A upon effectivity and completion of the 2-tranche schedules under this Wage Order shall be:
