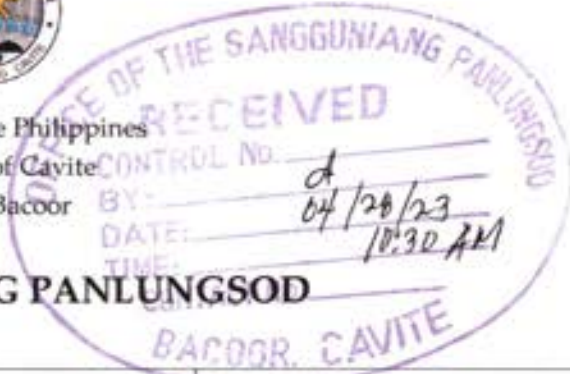

COMMITTEE REPORT NO. FBA-103C-S-2022

Referred to this Committee for appropriate action and recommendation the endorsement of the Office of the City Budget Officer, Bacoor City, relative the above-captioned subject matter.

As stated in the endorsement, the Office of the City Budget Officer have examined and reviewed the proposed Annual Budget of each barangay. The forms and contents of the proposed budgets are found to be in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

The proposed **ANNUAL BUDGET OF THE BARANGAYS FOR FY 2023** which consists and covers the twenty-six (26) barangays shall be utilized to finance the Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlays (CO), including their other respective expenditure programs, the basic services, barangay operations, barangay social welfare programs, and infrastructures as mandated under Republic Act No. 7160, known as the "Local Government Code of the Philippines" and Department of Budget and Management (DBM) Local Budget Circular No. 85 dated June 15, 2022.



**EXCERPT FROM THE MINUTES OF 1ST ONLINE SPECIAL SESSION
NO. FBA-103C-S-2022**

Honorable Councilor Reynaldo D. Palabrica, Pro Tempore/Acting Presiding Officer of the 5th Sangguniang Panlungsod called the session to Order at 4:00 P.M.

Atty. Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod, proceeded with the roll call, and the reading of proposed Ordinances and Resolution.

On motion by Honorable Councilor Rogelio M. Nolasco and unanimously seconded by the majority of the Honorable Members of 5th Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of proposed ordinance " **PNOA-066A-2022-PNOA-066Z-2022 - APPROVAL OF PROPOSED ANNUAL BUDGET OF VARIOUS BARANGAYS FOR THE CALENDAR YEAR 2023.**", Honorable Councilor Rogelio M. Nolasco, Chairman of the Committee on Finance, Budget and Appropriation informed the Body that the Committee have thoroughly reviewed the proposed budgets and the documents submitted by the twenty-six (26) barangays subject of the proposed ordinance.
