EXCERPT FROM THE MINUTES OF REGULAR SESSION NO. FBA-168-S-2023

Subject: AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 5, SERIES OF 2023, INVOLVING THE AMOUNT OF THIRTEEN MILLION TWO HUNDRED TWENTY THOUSAND PESOS (PHP 13,220,000.00) FOR CURRENT OPERATING EXPENDITURES AND CAPITAL OUTLAY OF THE CITY GOVERNMENT OF BACOOR FOR FISCAL YEAR 2023. – PCO-2023-139A dated November 20, 2023.
