During the 74th Regular Session, on 15 January 2024, the presiding officer referred to the abovementioned resolution to the committee on housing, land utilization, and urban development, chaired by Hon. Alde Joselito F. Pagulayan. Subsequently, during the 75th Regular Session, the resolution was transformed into an ordinance and amendments were made to the subject title.

Acting on authorizing the city mayor to initiate and file expropriation proceedings during the 75<sup>th</sup> Regular Session dated 22 January 2024, Hon. Pagulayan reports that:

According Section 19 of Republic Act No. 7160, a local government unit, through its chief executive and acting according to an ordinance, may exercise the power of eminent domain for public use, purpose, or welfare for the benefit of the poor and the landless, upon payment of just compensation, under the provisions of the Constitution and pertinent laws.

Exercising the above-mentioned fundamental power delegated to local government units, the City Government of Bacoor initiated the expropriation proceedings for a township project against Pilar Farms Inc. under Civil Case No. BSC 2018-16. The subject of said expropriation case is three hundred fifty-three thousand seven hundred and ninety-two (353,792) square meters under TCT No. 989493 and owned by Pilar Farms Inc., located at Barangay Molino IV. On 20 September 2023, Bacoor City RTC

Branch 112 granted the City Government of Bacoor a Writ of Possession of the subject property.

TCT NO. 989493 is surrounded by private properties. Adjacent to TCT NO. 989493 is the property of Brittany Corporation under TCT No. (057-T-1288796) (0022633) 167-2021003481.

A Letter/Offer to Buy was sent to Mr. Manuel Paolo A. Villar, Chairman of Brittany Corporation, on 13 December 2023. In the said letter, the City Government offered Seven Hundred Sixty-Five Thousand Pesos (Php 765,000.00) to purchase six thousand (6,000) square meters of the property to gain access to Villar Avenue. After a total of ten (10) calendar days were provided for Brittany Corporation to respond to the Letter/Offer to Buy, the City Government has yet to receive a response.

**FINDINGS:**

It is clearly shown that the City Government of Bacoor initiated expropriation proceedings against Pilar Farms Inc. for a township project. The property, TCT No. 989493, is surrounded by private properties and is owned by Brittany Corporation. The City Government offered Php 765,000.00 to purchase 6,000 square meters of the property to gain access to Villar Avenue. Despite ten days for Brittany Corporation to respond, the City Government has yet to receive a response. This case demonstrates the power of local government units to exercise eminent domain.

**RECOMMENDATION:**

In view of the foregoing, the committee respectfully recommends the APPROVAL of the said ordinance in order for the local government to demonstrate its power and exercise eminent domain.
