







Subject: AN ORDINANCE AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO INITIATE AND FILE EXPROPRIATION PROCEEDINGS OVER THE SEVENTY ONE THOUSAND THIRTY-SIX (71,036) SQUARE METER-LOT COVERED BY TCT NO T-79371 UNDER THE NAME OF TOMAS B. AGUIRRE, LOCATED IN BARANGAY MOLINO II, BACOOR CITY, CAVITE FOR THE ESTABLISHMENT AND CONSTRUCTION OF AN INCITY RESETTLEMENT AND RELOCATION TOWNSHIP PROJECT FOR THE BENEFIT OF INFORMAL SETTLER FAMILIES AND OTHER DEMOGRAPHIC SECTORS OF THE CITY OF BACOOR, CAVITE. (PCO 2024-176 dated 25 March 2024)

Acting on the authorization of the City Mayor to initiate and file expropriation proceedings covered by TCT NO T-79371 under the name of Tomas B. Aguirre, located in Barangay Molino II, Bacoor City, during the 90th Regular Session dated 13 May 2024, the said ordinance was referred during the 84th Regular Session dated 25 March 2024. Hence, the committee chair on housing, land utilization, and urban development, Hon. Alde Joselito F. Pagulayan, reports that:

Under Section 19 of the Local Government Code of 1991 (Republic Act No. 7160), local government units are empowered, through their chief executive and acting under an ordinance, to exercise the power of eminent domain for public use upon payment of just compensation.

The City Government of Bacoor (the City) has evaluated several sites for the establishment and construction of an in-city resettlement and relocation of informal settler families living in danger zones, coastal communities, roadways, railroads, and those affected by government projects. The best and most suitable site evaluated was identified in Barangay Molino II, Bacoor City, Cavite, more specifically described as follows:

It is necessary for the City to take or expropriate the whole property owned by Tomas B. Aguirre for the establishment and construction of an in-city resettlement and relocation of informal settler families living in danger zones, coastal communities, roadways, railroads, and those affected by government projects.

FINDINGS:

It is clearly shown that the City is willing to comply with the provisions of the Constitution, applicable laws, and other rules and regulations consisting of the observance and compliance with the due process requirements of the law. This includes the City issuing a proper notice to the registered owner with an offer to buy the aforestated property. Despite the effort made by the City, the registered owner has never responded to the said offer.

RECOMMENDATION:

After a thorough review, the committee recommends **TEMPORARILY ARCHIVING** the matter and referring it to the Office of the City Legal Services for further consolidation of the data required for the said proposed ordinance.

The proposal was declared TEMPORARILY ARCHIVED by the Acting Chair with no objections from the Council.

WHEREAS Section 19 of the Local Government Code of 1991 (Republic Act No. 7160) empowered local government units, through its chief executive and acting under an ordinance, to exercise the power of eminent domain for public use upon payment of just compensation;

WHEREAS, it is necessary for the City Government of Bacoor to take or expropriate the whole property owned by Tomas B. Aguirre for the establishment and construction of an in-city resettlement and relocation of informal settler families living in danger zones, coastal communities, roadways, railroads and those affected by government projects;

WHEREAS, the City Government of Baccor shall faithfully comply with the provision of our Constitution, applicable provisions of law and such other rules and regulations consistent with the observance and compilance with the due process requirements of the law, including, among others, the issuance of proper notice to the registered owner with offer to buy the afore-stated property, and that before taking, an amount equivalent to fifteen percent (15%) of the fair market value of the property as stated in its current tex declaration be deposited with the proper court;

WHEREAS, despite the offer made by the City Government of Baccor, the registered owner has never responded to the said offers to buy.

WHEREAS, considering the immediate need to develop an adequate in-city resettlement and relocation site in favor of the poor, the tandless, the underprivileged, and the homeless, the City Government of Baccor must acquire the entire property from Tomas B. Aguirre;

WHEREAS, before the City Government of Bacoor can commence expropriation proceedings under Section 19 of the Local Government Code, it is necessary that an ordinance be enacted authorizing the City Mayor to acquire, by expropriation, the above-described property:

NOW, THEREFORE, LET IT BE ORDAINED by the 5th Sangguniang Panlungsod of the City of Baccor, Province of Cavite, THAT.

Section 1. SHORT TITLE. This Ordinance shall be entitled "Ordinance Authorizing the Expropriation of the Private Property Covered by TCT No. T-79371 Located in Brgy, Molino II, Baccor City, Cavite".

Section 2. EMINENT DOMAIN. The City Mayor, in the name of the City Government of Baccor, is hereby authorized to exercise the power of eminent domain and for this purpose to commence and file with the proper court the appropriate and necessary action for expropriation of the abovementioned property covered by TCT No. T-79371 for the purpose of establishment and construction of an in-city resettlement and relocation of informal settler families living in danger zones, coastal communities, roadways, railroads and those affected by government projects.

Section 3. AUTHORIZED REPRESENTATIVE. The City Mayor or his duly authorized representatives, or through counsel, is authorized to initiate on behalf of the City Government of Baccor the filing of an action for expropriation in order to acquire the SEVENTY-ONE THOUSAND THIRTY-SIX SQUARE METER (71,036 sqm.) PROPERTY of TOMAS B. AGUIRRE.

Section 4. PUBLIC PURPOSE. The expropriation of the entire portion of the subject property is for the purpose of establishment and construction of an in-city resettlement and relocation of informal settler families living in danger zones, coastal communities, roadways, railroads and those affected by government projects.

Section 5. APPROPRIATION. The amount equivalent to the filing fees, deposit fees, cost of the property as determined by the appropriate Court, and other expenses necessary to the expropriation proceedings shall be appropriated or sourced from the General Fund of the City Government or from other lawful sources.

Section 6. Effectivity. This Ordinance shall take effect immediately upon approve by the City Mayor and its publication at least once in a newspaper of general circulation.
