







SEC. 11. Powers, Duties, Functions and Compensation. — (a) The sangguniang panlungsod, as the legislative body of the City, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the City and its inhabitants pursuant to Section 16 of the Local Government Code of 1991 and in the proper exercise of the corporate powers of the City as provided for under Section 22 of the Local Government Code of 1991, and shall:

(2) Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the City With particular attention to agro-industrial development and citywide growth and progress and, relative thereto, shall:

X X X

(ix) Enact integrated zoning ordinances in consonance with the approved comprehensive land-use plan, subject to existing laws, rules and regulations establish fire limits or zones particularly in populous centers; and regulate the construction, repair or modification of buildings within said limits or zones in accordance with the provisions of the Fire Code of the Philippines;

XXX

- (4) Regulate activities relative to the use of land; buildings and structures within the City in order to promote the general welfare and, for the said purpose, shall:
  - (ii) Require that buildings and the premises thereof and any land within the City be kept and maintained in a sanitary condition; impose penalties for any violation thereof or upon failure to comply with the said requirement, have the work done at the expense of the owner, administrator or tenant concerned; and require the filling up of any land or premises to a grade necessary for proper sanitation;"

#### OBJECTIVE OF THE PROPOSED AMENDMENT:

It has been observed by the City Government of Bacoor that there are unauthorized construction activities, particularly the absence of required building permits, which pose risks to public safety, orderly urban development and the integrity of zoning regulations.

In order to strengthen regulatory oversight, promote responsible development practices, and uphold public safety and welfare, and to deter unauthorized construction activities within the territorial jurisdiction of Bacoor City, there is a need for the Sangguniang Panlungsod to enact a city ordinance amending Section 193.1, Article 34 of 2013 Revenue Code of Bacoor City.

Under the "2013 Revenue Code of Bacoor City", and the succeeding "2022 Revised Revenue Code of Bacoor City", Section 193.1 of Article 34 states that:

## "ARTICLE 34 ZONING AND/OR LOCATIONAL CLEARANCE FEES

SECTION 193.1. Fine and Penalty. – Upon conviction by a court of law, a fine of Two Thousand Pesos (P2,000.00) shall be paid by the President or General Manager of the company developing a project, or by the contractor of the said project, covered by a development permit issued by the City Government for each that violate the various conditions of the said permit. However, if the

developer or the contractor complies with the said conditions upon its receipt of a notice of violation, the fine shall be limited to Five Thousand Pesos (P5,000.00) and no complaint shall be filed against them in court."

The proposed amendment is hereunder presented and written as follows:

"Section 193.1. Fine and Penalty. – In the event of non-compliance following the investigation conducted by the City, the President or general Manager of the entity undertaking a project, the Contractor engaged in said project, and the Owner of the building or property, whether subject to or exempt from a development permit issued by the City Government, shall incur a fine of Two Thousand Pesos (Php2,000.00) for each day of contravention of the conditions specified in the permit and/or each day of violation of the provisions delineated in City Ordinance No. 217-2022. Such fractions include, but are not limited to, failure to procure requisite permit and/or clearances prior to the commencement of the construction endeavor."

#### FINDINGS:

During the Committee hearing attended by resource persons from the Office of the City Legal Services, Office of the Building Officials and Zoning and Land Use Department, the following facts and issues have been considered by the Honorable Members of the Joint Committee:

- There are several unauthorized construction activities that have been inspected by the concerned city enforcement offices within the territorial jurisdiction of the City Government of Bacoor.
- The Zoning and Land Use Department is already implementing the proposed amendment.
- The filing of court cases involving the unauthorized construction activities takes time for the conviction of the perpetrators or violators.

The Joint Committee finds the request for the approval of the city ordinance amending Section 193.1, Article 34 of the 2013 Revenue Code of Bacoor City, and the succeeding "2022 Revised Revenue Code of Bacoor City" as timely, proper and justifiable.

Hon. Rogelio M. Nolasco: "For the record we acknowledge the presence of our Councilor's, nais ko pong ipakilala ang aking mga kasamang konsehal, Konsehal Reynaldo Palabrica, Konsehal Levy Tela, Konsehal Simplicio Dominguez, Konsehal Alejandro Gutierrez, and Konsehal Adrielito Gawaran for the record mag pakilala lang po ang ating mga resource persons."

With this proposed ordinance kahit wala na pong case or wala na pong conviction by court, pwede na po tayong makapag fine ng per day. So, no cases or conviction it will be necessary under the law."

Hon. Reynaldo Palabrica: "So, meaning the same provision aalisin lang yung imprisonment? Instead imposed per day monetary penalty?"

Atty. Joshua Flores: "Yes po, actually Konsi regarding per day doon po sa existing natin per day din naman po, however, kailangan po may conviction bago siya ma implement, with this existing per day din siya po Php 2,000.00 pero upon investigation ng City."

Hon. Reynaldo Palabrica: "So, meaning there will be no filing of case in the court? Eh pabor ako diyan."



Respectfully endorsing to your Office, the draft proposed city Ordinance amending the fine and penalty of Section 193.1, Article 34 of City Ordinance No. 2013-060, otherwise known as the 2013 Revenue Code of the City of Bacoar<sup>1</sup> for your consideration. This Ordinance seeks to amend the fine and penalty provisions outlined in Section 193.1. Article 34 of City Ordinance No. 2013-060, also known as the "2013 Revenue Code of the City of Bacoor." The amendment is driven by the powers vested in the Sanggunian to regulate land use, building activities, and revenue generation within its jurisdiction.

#### Key considerations include:

 City Charter and Sanggunian Authority: The ordinance aligns with the provisions of the City Charter of Bacoor and the powers vested in the Sanggunian to regulate land use, building activities, and revenue generation within the municipality. letter is the City Legal Opinion? written by the City Legal Office, which delineates the legal basis for the proposed amendment or supplement aimed at resolving the issue pertaining to the Bacoor City Revenue Code.

- Observations and Concerns: The Ordinance addresses concerns regarding unauthorized construction activities within Bacoor, particularly the absence of necessary permits, which pose risks to public safety, orderly urban development, and the integrity of zoning regulations.
- Purpose of Amendment: By amending the fine and penalty provisions, the
  Ordinance aims to deter unauthorized construction activities by imposing
  penalties on responsible parties, including company presidents, contractors, and
  property owners, tound non-compliant with permit requirements outlined in City
  Ordinance No. 217-2022.
- Fine and Penalty Specification: The amended section sets a fine of Two Thousand Pesos (Php 2,000.00) for each day of violation, encompassing non-compliance with permit conditions and provisions of the ordinance.

In summary, the Ordinance seeks to strengthen regulatory oversight, promote responsible development practices, and uphold public safety and welfare through the imposition of fines on parties engaging in unauthorized construction activities in Baccor, in line with the authority granted by the City Charter and the powers vested in the Sanggunian.

AN ORDINANCE AMENDING THE FINE AND PENALTY OF SECTION 193.1, ARTICLE 34 OF CITY ORDINANCE NO. 2013-060, OTHERWISE KNOWN AS THE 2013 REVENUE CODE OF THE CITY OF BACOOR

WHEREAS, recognizing the provisions of Sections 2 and 5. Article X of the Constitution, which affirm the autonomy of territorial and political subdivisions and grant each local government unit the power to establish its own revenue sources and levy taxes, fees, and charges in line with the principles of local autonomy;

**WHEREAS.** Section 16 of the Local Government Code acknowledges the authority of Local Government to exercise the powers expressly granted. Those necessarity implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, in accordance with Section 11(a)(4)(ii), Article IV of Republic Act No. 10160, commonly referred to as the ["Charter of the City of Baccor"), the Sanggunian is empowered to regulate activities related to the use of land, buildings, and structures within the City to promote the general welfare, may also mandate that buildings, premises, and any land within the City be kept and maintained in a sanitary condition, has the authority to impose penalties for violations or for failure to comply with these requirements, and if necessary, to have the work done at the expense of the owner, administrator, or tenant concerned;

**WHEREAS**, on 25 August 2022, the Sanggunlang Panlungsod passed City Ordinance Na. 217-2022 amending certain provisions of the Bacoor Revenue Code ("City Ordinance No. 2013-060");

WHEREAS, the Zoning and Land Development Department of the City of Baccar has observed a prevalent and concerning trend wherein individuals/contractors engage in the construction of buildings or houses without complying with the necessary legal procedures and obtaining the required permits, including but not limited to locational clearances and building permits:

**WHEREAS**, the failure to secure such essential permits not only confravenes established regulatory frameworks but also poses significant risks to public safety, undermines orderly urban development, and jeopardizes the overall integrity of zoning regulations and building standards:

WHEREAS, the unauthorized construction of buildings or houses without proper oversight and approval has the patential to lead to structural deficiencies, environmental hazards, and other adverse consequences that may endanger the well-being of occupants, neighboring properties, and the broader community;

**WHEREAS.** the enforcement of fines or penalties for non-compliance with permit requirements is vital to deter unauthorized construction activities, uphold the rule of law, and safeguard the interests of both present and future residents of the City of Baccor;

**WHEREAS.** It is imperative for Sanggunian to take decisive action to address this issue and ensure strict adherence to regulatory protocols, thereby promoting responsible development practices, preserving the integrity of urban landscapes, and fostering a safe and systalnable built environment for all.

NOW THEREFORE, upon majority vote of all the members of the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor. Cavite on regular session assemble, be it **ORDAINED** that:

**\$ECTION 1. Amendment to Section 193.1 of the Revenue Code of the City of Bacoor.** Section 193.1 of the Bacoor Revenue Code (the "Code") is hereby amended and shall henceforth read as follows:

"Section 193.1. Fine and Fencity. — In the event of non-compliance following an investigation conducted by the City, the President or General Manager of the entity undertaking a project, the Contractor engaged in said project, and the Owner of the building or property, whether subject to or exempt from a development permit issued by the City Government, shall incur a fine of Two Thousand Pesos (Php 2.000.00) for each day of contravention of the conditions specified in the permit and/or

each day of violation of the provisions delineated in City Ordinance No. 2)7-2022, Such infractions include, but are not limited to, the failure to procure requisite permits and/or clearances prior to the commencement of the construction endeavor."

**SECTION 2. Effectivity.** This Ordinance shall take effect immediately after it has been posted in at least three (3) conspicuous places and after it has been published in the newspaper of general circulation in the City of Baccor, Covite.

**SECTION 3. Separability.** In case any provision of this Ordinance is declared void or unconstitutional by a court of competent jurisdiction. The remaining provisions of this Ordinance or of Bacoor Revenue Code not affected by the said declaration shall remain valid and enforceable.

THE PROPOSED AMENDMENT IS TO BE READ AS FOLLOWS:

"Section 193.1. Fine and Penalty. – In the event of non-compliance following the investigation conducted by the City, the President or general Manager of the entity undertaking a project, the Contractor engaged in said project, and the Owner of the building or property, whether subject to or exempt from a development permit issued by the City Government, shall incur a fine of Two Thousand Pesos (Php2,000.00) for each day of contravention of the conditions specified in the permit and/or each day of violation of the provisions delineated in City Ordinance No. 217-2022. Such fractions include, but are not limited to, failure to procure requisite permit and/or clearances prior to the commencement of the construction endeavor."

ON AUGUST 25, 2022, THE SANGGUNIANG PANLUNGSOD APPROVED THE "2022 REVISED REVENUE CODE OF THE CITY OF BACOOR" UNDER CITY ORDINANCE NO. 217-2022.

WE QUOTE SECTION 193.1, ARTICLE 34 OF THE "2022 REVISED REVENUE CODE OF THE CITY OF BACOOR", AS FOLLOWS:

### "ARTICLE 34 ZONING AND/OR LOCATIONAL CLEARANCE FEES

SECTION 193.1. Fine and Penalty. – Upon conviction by a court of law, a fine of Two Thousand Pesos (P2,000.00) shall be paid by the President or General Manager of the company developing a project, or by the contractor of the said project, covered by a development permit issued by the City Government for each that violate the various conditions of the said permit. However, if the developer or the contractor complies with the said conditions upon its receipt of a notice of violation, the fine shall be limited to Five Thousand Pesos (P5,000.00) and no complaint shall be filed against them in court."
