#### COMMITTEE REPORT

CHS-PCO-2024-184

Subject: An ordinance promoting the right of persons deprived of liberty to have access to basic health care services through the establishment of a primary care clinic within the Bacoor City Jail and providing funds for its construction, maintenance and operation.

The above-mentioned proposed ordinance underwent its first reading on May 20, 2024 during the 91st Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon, Rowena Bautista Mendiola to the Committee on Health and Sanitation.

The Committee on Health and Sanitation sent out invitations to the resource persons and conducted a committee hearing on May 30, 2024 and July 11, 2024 at the Session Hall of the Sangguniang Panlungsod.

#### FINDINGS:

The severe overcrowding in jail facilities in the Philippines, persons deprived of liberty (PDL) detained at the said facilities are also often deprived of their fundamental right to health.

Due to the congestion of jail facilities in the City of Bacoor, PDL detained in the Bacoor City Jail are vulnerable to various diseases. Most PDL detained at the Bacoor City Jail are residents of the City and most of them still retain the right to vote and are entitled to receive basic health services from the City Government.

This proposed ordinance aims to establish a jail clinic within the Bacoor City Jail to be manned by healthcare professionals under the employ of the BJMP, to provide sufficient medicines, medical supplies, and healthcare equipment using City Government funds, and to give PDL detained in the Bacoor City Jail intemperate access to basic health care regardless of their legal situation.

JCINSP. JOY ANNE PASCUAL "Good morning, sir, Jail chief inspector Joy Anne Pascual from Bacoor City Jail female dorm sir."

COUN. REYNALDO C. PALABRICA "Thank you very much, next po."

JSUPT. CHRISTOPHER PENILLA "Good morning, sir, Jail superintendent, Christopher Penilla, warden, male dorm, sir."

CHRISTOPHER PENILLA "Good morning sir, the proposes sir of the Bureau of Jail and Management Penology, to establish a primary care clinic in all local jail sir, originated from our national headquarters, it was triggered because of the need of our PDL to have access to, at least primary or basic health care sir and also with alignment to the universal health care law sir and we believe sir that our PDL sir, our still residence of the city, for the municipality that they are detain and just recently also sir, we received the, yung sa supreme court sir, that the PDL sir are now able to participate in local elections, so, we fitting that for the next few years, our PDL will also received health care services that is prescribed by the universal health care sir."

COUN. REYNALDO C. PALABRICA "Hindi, tama naman kasi tao pa rin yung mga yun saka ang nasa inyo, hindi pa naman... ang nasa inyo ba mga convicted na ba iyon? Hindi pa naman ano?"

JSUPT. CHRISTOPHER PENILLA "No sir, most of them sir are still ongoing court hearings po."

COUN. REYNALDO C. PALABRICA "On trial pa sila."

JSUPT. CHRISTOPHER PENILLA "And likewise sir, we in line sir the, we prepared a new program sir for the Bacoor City Jail sir, entitled 'Strike goal' sir, "Strike goal for community reintegration" and letter of that sir is an enhanced emula justice health. So, this is also supportive of that one sir and its also a way to bring in health services sir without, bringing health services or we can partner other health institutions but to partner with them, there was a need for somehow participation sir with the local government unit sir and proposed ordinance there would facilitate sir."

COUN. REYNALDO C. PALABRICA "Okay, it is mentioned in the title, from the title alone, this is the establishment of primary care clinic. When we say primary care, maraming covered yun, ano-anong mga covered na health care services, so, pag sinabing primary care, may laboratory ba ito? Kasi primary eh, primary parang primary, pag sinabing primary, hospital, ganun din ang covered. Pag sinabi namang primary clinic, how do you define this?"

JSUPT. CHRISTOPHER PENILLA "With the proposed ordinance sir, the specifications mentioned here almost equivalent para maging health clinic sa DOH accredited facilities sir, so this is, leaning towards..."

So, right now depending on what the committee will dictate sir and to come up a way to both male and female can benefit using the existing space."

COUN. REYNALDO C. PALABRICA "Not under with the City Health Office?"

JSUPT. CHRISTOPHER PENILLA "Yes sir."

COUN. REYNALDO C. PALABRICA "So BJMP lang?"

JSUPT. CHRISTOPHER PENILLA "Yes sir."

COUN. REYNALDO C. PALABRICA "So meaning, the cost of operation is BJMP?"

JSUPT. CHRISTOPHER PENILLA "BJMP din sir."

COUN. REYNALDO C. PALABRICA "So BJMP ang mag proprovide ng doctors, nurses, and man power, medicines and everything?"

JSUPT. CHRISTOPHER PENILLA "Yes sir."

COUN. REYNALDO C. PALABRICA "So the only requirement for us is to pass this ordinance? Ganun ba ang ibig niyong sabihin?"

JSUPT. CHRISTOPHER PENILLA "Yes sir, mobile x-ray mga ganun sir, It's a consulta clinic sir, similar to a consult to a clinic sir,"

COUN. REYNALDO C. PALABRICA "Kung maeestimate mo? how much it will cost yung nirerequire na equipments? That will come from the funds the local."

JSUPT. CHRISTOPHER PENILLA "We have the list of equipments but on the cost of equipments sir we still have to come up with an estimate sir."

COUN. REYNALDO C. PALABRICA "Does the equipment, the required equipments please tell in the ordinance or hindi pa? nandito na ba? Wala pa?"

COUN. REYNALDO C. PALABRICA "Before I proceed, I would like the attention of or representative of the Legal Services, attorney Marco."

ATTY. REY MARCO B. MENDOZA "Your honor I would like to make clarifications of as to the statement of BJMP representative, kasi it was mentioned that the medicines, medical equipments, even the health care personnel will be under the supervision of, or under the funding of BJMP, however your proposal states

JOY ANNE PASCUAL "Sir, good morning, ma'am and sir, if I may clarify po, yes sir, our proposal is that LGU will support the medicines and other medical equipments stated po here in the draft po sir, with regards po to health workers, such as doctors and nurses will BJMP will provide po since at present po, roving doctors, and we also have stay in nurses in the facilities."

COUN. REYNALDO C. PALABRICA "Any comments? May sasabihin ka pa? Sige, kayo muna, tapusin niyo muna."

ATTY. REY MARCO B. MENDOZA "Question ko lang po, isa pa sa statement niyo kanina is yung project will not be under the supervision of the office of the city health services, but your technical working group provided na co-chairperson ng City Health Offices, diba dapat po kung ang BJMP ang talagang mag mamayari ng project? It should be the BJMP alone, no need for a technical working group."

COUN. REYNALDO C. PALABRICA "Any reaction from the BJMP? Hindi, tama naman sinasabi ni attorney Marco, you are manifesting before this committee yung sagot ng BJMP, lahat everything then, sa draft ordinance, baliktad, tapos hindi natin kailangan ng TWG in case na sinagot ng BJMP, the only rule of the local, to augment, for the resources needed ng propose ng primary health care clinic. So, any reactions?"

JSUPT. CHRISTOPHER PENILLA "With regards to the need for co-chairperson from the city health sir, its because of the limitations in terms of the knowledge how we can run a clinic, so this is where we looking at the aspect of having a co-chairperson coming from the city health services."

COUN. REYNALDO C. PALABRICA "If we look at the section 8, technical working group composition, before I proceed, for the record, I acknowledged the presence of honorable councilor Simplicio Dominguez."

COUN. SIMPLICIO DOMINGUEZ "Magandang umaga po sa ating lahat."

JOY ANNE PASCUAL "If I may po, because it will be the LGU who will provide the medicines and equipments, and such equipments will be issued to our clinic, so, it will be under the supervision of the city health office, like at present po, we are receiving some medicines, some equipments are from the city health office, under the consual of the city health office, under the contribution of BJMP po is that man power, but the equipment are..."

COUN. REYNALDO C. PALABRICA "Are provided by the local?"

JCINSP. JOY ANNE PASCUAL "Yes po."

COUN. REYNALDO C. PALABRICA "So, yung man power lang sa inyo? yung medicine, equipments, supervision sa local lahat? So baliktad yung sinasabi ni warden? Warden iba yung sinasabi mo kanina."

COUN. REYNALDO C. PALABRICA "Anyway, hanapan natin ng solusyon, as far as I know, based on my knowledge, ang local government to the City Health Office, ay nag proprovide, may two million yun na budget para sa medicine, annually, tama ba ako city health officer representative?"

DRA. IVY MARIE YRASTORZA "Previously po, one million, but this year po, two million, under the pops plan."

COUN. REYNALDO C. PALABRICA "Doon sa proposal naririnig mo naman kanina, the local will provide the medicines and the equipment, yung two million budget, puwede ba natin magamit yan? Para dyan sa proposal na yan."

DRA. IVY MARIE YRASTORZA "As I've said po, sa past plan po kasi pinapasok pagdating po sa mga project po or program na BJMP kasi it's not included po sa annual budget ng Office of the City Health Services, kasi kung sa amin pa po ibabawas yung ibibigay sa kanila, our budget is insufficient..."

COUN. REYNALDO C. PALABRICA "Hindi ko hinihingi yung bawas sainyo kasi alam ko kulang sainyo kasi hanggang ngayon kulang ang doctor natin, apat lang ata yung doctor sa buong city, imagine with the population of more than seven hundred thousand, we have only six active community doctors, for seven hundred people, kaya yan binabalanse natin, kaya kinaklaro ko kanina, na yung

COUN. REYNALDO C. PALABRICA "Mayroon nang temporary? So, puwede nating ilmprove, yung bigger structure, we can request at the congress or to our senator, para ma provide tayo ng structure puwede yun. Ang pinaka essential is the medicine and equipment, with the two million hindi pa natin kayang taasan yun, manggagaling pa sa pops plan yun, with the two million, with your familiarity with the prices and all doctora, yung two million, puwede na ba tayo mag start doon? Bumuli muna tayo ng hospital bed, mag start muna tayo hanggang sa ma improve, puwede naman yun diba?

JCINSP. JOY ANNE PASCUAL "Yes sir."

COUN. REYNALDO C. PALABRICA "Puwede kaya? Kakayanin kaya?

DRA. IVY MARIE YRASTORZA "Yung two million po, sufficient lang for medicines but if you will include the equipment, hindi po siya sufficient, especially po na ang gusto nila is primary care facility, when we say primary care facility, hindi lamang po iyan consultation, it also involves laboratory, yung x-ray, and then other preventive services po, so, medyo hindi po enough, hindi po talaga enough yung two million..."

COUN. REYNALDO C. PALABRICA "Magkano kailangan?"

DRA. IVY MARIE YRASTORZA "Sa DOH po, we we're given the budget by the DOH to construct a super health center, yun po yung equipment is almost complete po, nasa more than six million po siya."

COUN. REYNALDO C. PALABRICA "Six million?"

DRA. IVY MARIE YRASTORZA "From the Department of Health po iyan."

COUN. REYNALDO C. PALABRICA "So, may I ask my fellow councilors kung may tanong po kayo for clarification?"

COUN. REYNALDO C. PALABRICA "Councilor Bok may fanong ka? Wala na?"

AN ORDINANCE PROMOTING THE RIGHT OF PERSONS DEPRIVED OF LIBERTY TO HAVE ACCESS TO BASIC HEALTHCARE SERVICES THROUGH THE ESTABLISHMENT OF A JAIL CLINIC WITHIN THE BACOOR CITY JAIL AND PROVIDING FUNDS FOR ITS CONSTRUCTION, MAINTENANCE AND OPERATION.

WHEREAS, according to a survey conducted in 2023 by WorldAtlas.com, Philippine jails are the fourth most crowded in the whole world with an occupancy rate of 362%.

WHEREAS, due to the severe evercrowding in jail facilities in the Philippines, persons deprived of liberty (PDL) detained at the said facilities are also often deprived of their fundamental right to health.

WHEREAS, Section 9 of the United Nations' General Assembly Resolution No. 45/111 dated 14 December 1990 provides that "prisoners shall have access to the health services available in the country without discrimination on the grounds of their legal situation".

WHEREAS, Republic Act No. 11223 (the "Universal Health Care Act") provides, among others, that it is the policy of the State to protect and promote the right to health of all Filipinos and instill health consciousness among them and that the State shall adopt a health care model that provides all Filipinos access to a comprehensive set of quality and cost-effective, promotive, preventive, curative, rohabilitative and palliative health services without causing financial hardship, and prioritizes the needs of the population who cannot afford such services. (Underscoring supplied)

WHEREAS, due to the congestion of jail facilities in the City of Bacoor, Cavite, persons deprived of liberty detained in the Bacoor City Jail are vulnerable to various diseases.

WHEREAS, the incarceration of PDI. limits their easy access to healthcare services since the law requires a competent Court Order prior their visit to hospitals for medical checkup.

WHEREAS, allowing PDL to mingle with the general public while they are having medical check-ups or while receiving medical treatment entail the implementation of complicated and expensive security measures by the BJMP that cost significant amounts of taxpayers money.

## OFFICE OF THE SANGGUNIANG PANLUNGSOD BAGONG PHLIPINAS





WHEREAS, the Bureau of Jail Management and Penology (BJMP) has the needed manpower to provide health care services to PDL which include physicians, nurses, medical technologists, pharmacists, x-ray technicians and other ailied health professionals. However, the BJMP does not have enough funds to buy the medicines and equipment needed to maintain the health of persons deprived of liberty incarcerated at the Bacoor City Jail.

WHEREAS, following the Supreme Court ruling in Mandanas v. Ochoa (G.R. No. 199802, 3 July 2018), the task of providing for basic health services to the public has been devolved to local government units (LGUs).

WHEREAS, considering that most PDL now detained at the Bacoor City Jail are residents of the City and most of them still retain the right to vote, the PDL population at the said facility can be likened to a community or a barangay of city residents who are entitled to receive basic health services from the City Government.

WHEREAS, the Sangguniang Panlungsod believes that providing medicines and medical equipment for persons deprived of liberty detained at the Bacoor City Jall is a prudent public policy that should be promoted by the City Government as it creates favorable conditions for the eventual reintegration to society of former prisoners and will eventually lead to the creation of a more peaceful, law-abiding, and humane society.

NOW, THEREFORE, be it ordained by the 5th Sanggunlang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled THAT:

SECTION 1. TITLE. This Ordinance shall be known and referred to as the "Health Care for Persons Deprived of Liberty Ordinance of Baccor.

SECTION 2. PURPOSES. This Ordinance aims to: (1) establish a pell aline within the Bacoor City Jail to be manned by healthcare professionals under the employ of the BJMP, (2) to provide sufficient medicines, medical supplies, and healthcare equipment using City Government funds, and (3) to give persons deprived of liberty detained at the Bacoor City Jail unhampered access to basic health care regardless of their legal situation.

#### SECTION 3. OBJECTIVES. The objectives of this Ordinance are:

- a. To provide sufficient and unhampered basic health care services to persons deprived of liberty detained at the Baccor City Jail as they are entitled to the same health services as any Baccoreño.
- To assist in the guarantee of public safety and order by limiting the movement and interaction of PDL with the general public.
- To foster shared responsibility of government agencies and the local government of providing basic services to all individuals; and
- To assist in ensuring the successful reintegration into mainstream society of persons formerly deprived of liberty.

SECTION 4. DEFINITION OF TERMS. As used in this Ordinance, the following terms shall be defined as:

- Persons Deprived of Liberty are persons detained at the. Bacoor. City. Jail. awaiting the final outcome of their criminal cases pending trial before the appropriate courts of law.
- Bacoor City Jail are the jail facilities situated within the City of Bacoor under the management of the BJMP comprising of the Bacoor City Jail-Female Dorm and the Bacoor City Jail-Male Dorm.

SECTION 5. MINIMUM SPECIFICATIONS AND INCLUSIONS - The City Government shall fund the construction, repair, and maintenance of 0 the jail facility of the BACOOR CITY JAIL-FEMALE DORM and the BACOOR CITY JAIL-MALE DORM with the following minimum specifications and inclusions:

- a. An enclosed space with a minimum floor area of Illim-with a lavatory/sink, toilet
- b. A part of the floor area with at least 1m to be allotted for stenlization of equipment
- c. Medical equipment consisting of oxygen tank with regulator, nebulizer, suction machine, ultrasound, mobile x-ray, manual blood presums annoal stand type
- d. Medicines to include 1s line antibiotics, analgesics, anti-hypertensive and

SECTION 6. FUNDING. The Local Government of the City of Bacoor is hereby authorized to appropriate funds from all available and legally obtainable sources that may be utilized for the implementation of this ordinance subject to compliance to pertinent laws and government regulations.

SECTION 7. IMPLEMENTING RULES AND REGULATIONS (IRR). The City Legal Services Office is coordination with the City Health Office, the Committee on Finance and Budget Appropriations of the Sanggunlang Panhingsod , the City Treasurer Office, City Budget Office, the Committee on Peace and Order and Public Safety of the Sangguniang Panlungsod, the City Engineering Office, the General Services Office, Accounting Office, HJMP Bacoor City Jail-Female Dorm and the Bacoor City Jail-Male Dorm shall formulate the Implementing Rules and Regulations of this Ordinance subject to the approval of the City Mayor,

SECTION 8. REPEALING CLAUSE. All Ordinances, Resolutions, Local Executive Orders, Rules and Regulations or any part thereof inconsistent herewith are hereby deemed repealed, modified or amended accordingly.

SECTION 8. SEPARABILITY CLAUSE. In any case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 9. EFFECTIVITY. - This Ordinance shall take effect immediately upon its publication at least once in a newspaper of general circulation within the City of Bacoor, Cavite.
