**Subject: *An ordinance reorganizing the City Business Permit and Licensing Department of the City of Bacoor, Cavite, providing its new organizational structure, staffing pattern and functions. (PCO-2024-188 date referred June 10, 2024)***

The above-mentioned proposed ordinance underwent its first reading on June 10, 2024 during the 94<sup>th</sup> Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Ethics, Appointments, and Government Reorganization.

The Committee on Ethics, Appointments and Government Re-Organization sent out invitations to the resource persons and conducted a hearing on June 13, 2024, 9:30 a.m. at the Session Hall of the Sangguniang Panlungsod.

**FINDINGS:**

Bacoor City Mayor Hon. Strike B. Revilla endorsed to the members of Sangguniang Panlungsod for appropriate action, the proposed enactment of an ordinance creating and providing for the functions and duties of the Business Permit and Licensing Department.

During the committee hearing, BPLO-OIC Mr. Christian Gawaran explained that no record was found regarding an ordinance creating the Business Permit and Licensing Department. However, he mentioned that under Section 3 of the Appropriation Ordinance No. 2013-059 series of 2013, the Business Permit and Licensing Department was included in that appropriation ordinance.





in the budget and approved, it is also then created. She suggested that creation and not reorganization of the department would be more appropriate so that they can add employees to their Plantilla.

City Budget Officer Ms. Elvinia S. Guerrero suggested that since the department is already existing, formalizing the creation of BPLO to BPLD is more appropriate.

**RECOMMENDATION:**

After a thorough review of all the circumstances and statements from the resource persons, the Committee respectfully recommends that the Sangguniang Panlungsod approve the foregoing.



**COUN. REYNALDO C. PALABRICA** "May I request the resource person present to introduce themselves and their representation for record purposes, let's start with the city budget."

**ELVINIA S. GUERRERO** "Gandang umaga po sa ating lahat, Elvinia Guerrero, City Budget officer."

**COUN. REYNALDO C. PALABRICA** "HR."

**NATIVIDAD LUDWIG I. OPLE** "Magandang umaga po sa ating lahat, Natividad Ludwig Ople, from HRDMD."

**COUN. REYNALDO C. PALABRICA** "For the record, I commend the gesture sought by the HR, yun ang nasa ordinansa natin, 'mabuhay' ganyan. Thank you very much ma'am Natty, and of course, ang bida sa hearing na ito."

**CHRISTIAN T. GAWARAN** "Good morning and mabuhay, welcome to Bacoor. Christian Gawaran po, Business Permit and Licensing Department."

**COUN. REYNALDO C. PALABRICA** "Thank you very much."

**COUN. REYNALDO C. PALABRICA** "Mabilis lang naman itong hearing na ito, kasi parang ifoformalize lang natin yung creation ng department ng Business Permit and Licensing office dati, gagawing department and staffing pattern, walang pagbabago, I absorb lang. Maybe, may I ask the OIC chief of BPLO and now





will be BPLD. Mr. Christian Gawaran, to enlighten the committee about the proposed ordinance."

**CHRISTIAN T. GAWARAN** "Again, good morning po, actually po, upon the instructions ni Attorney Atega, hindi raw po makita sa record yung creation ng department sa Business Permit, nakita lang po doon sa appropriation ordinance number 2013-059 series of 2013 sa section 3, indicated po doon na Business Permit and Licensing Office, not department. So, wala daw po talaga pang ordinansa na nagrecreate as business permit na isang department, so, upon the advice of attorney Atega, sulat daw po ako kay Mayor Strike to request na magkaroon ng ordinance regarding sa department po."

**COUN. REYNALDO C. PALABRICA** "And the mayor agreed that's why they endorsed this proposal to this committee. So, any comments Ma'am Natty? Opinion?"

**NATIVIDAD LUDWIG I. OPLE** "Sir if I may, wala naman pong kasalanan ang SP noon, kasi yung tradition noon nilalagay lang natin sa ating budget and once it is approved, its created, so yun lang po. Wala namang pong premiss sa duties all sides, maganda rin po yung pag request, to formalize and to furnish in civil service commission of the creation of the said department."

**NATIVIDAD LUDWIG I. OPLE** "Ang comment ko lang po is doon sa proposed title, with regards doon sa word na 'organizing', I think ang dapat pong gamitin ay 'creation' kasi po, pag organizing po, ang effect ng plantilla positions ay hindi maaring makapag upwind or makapag hire ng iba, or magdagdag ng tao hangga't hindi po na fill-up nung mga nasa loob and sa history ng pag hire natin baka mas lalo tayong mahirapan, unless gamitin nalang po yung 'creation' kasi, pag reorganization po, kahit kayong nakaupo na mayroon ng plantilla item, kailangan niyo pa rin pong applyan at dumaan sa proseso ng hiring process, kung creation po, ang gagawin lang naman po dun ay I absorb lang. So, kung may idadagdag na plantilla at mayroon kayong ihire outside doon sa original ninyong mga tao, na nasa inyong organization or opisina, ay maari po, pero kung reorganization, yun po yung mga consequences."

**COUN. REYNALDO C. PALABRICA** "I agree with the HR, saka ang very purposes lang naman nito is create ang department, wala namang binago sa plantilla. Thank you very much for very wise opinion. Baka may gustong sabihin ang members of the council present?"

**COUN. REYNALDO C. PALABRICA** "Ma'am Elvi, wala namang pagbabago sa..."





**ELVINIA S. GUERRERO** "Good morning po ulit, I agree din po sa HR kay ma'am Natty, kasi po dati, yung mga creation natin, isinasabay po natin sa pag enact ng professional ordinance, pero po sa ngayon, sa Sangguniang Panlalawigan ang gusto nila, separate yung creation, yung ordinance ng creation, sa effect ng ating plantilla, kaya lang po, ang concern ko lang..."

**COUN. REYNALDO C. PALABRICA** "Yes po."

**ELVINIA S. GUERRERO** "Kung creation siya, ang term na creation, parang ngayon mo pa lang icrecreate..."

**COUN. REYNALDO C. PALABRICA** "Renaming siguro."

**ELVINIA S. GUERRERO** "Baka puwede pong gawing term, lagyan ng term na 'formalization' kasi existing na yung department, wala palang siyang ordinance na siya ay na create, although nakalagay sa appropriation ordinance 2013-059, na mayroon siyang new department, parang ifoformalize lang natin yung creation ng department."

**COUN. REYNALDO C. PALABRICA** "Formalizing the BPLO, from BPLO to BPLD, parang ganun."

**ELVINIA S. GUERRERO** "Parang ganun po."

**COUN. REYNALDO C. PALABRICA** "Tama naman, tama naman."

**ELVINIA S. GUERRERO** "Tsaka wala naman pong I request na additional position."

**COUN. REYNALDO C. PALABRICA** "Wala naman, I absorb lang."

**ELVINIA S. GUERRERO** "Opo. Tsaka wala naman po kaming objection doon."

**COUN. REYNALDO C. PALABRICA** "Ma'am Natty, any reactions to the opinion of our ma'am budget?"

**NATIVIDAD LUDWIG I. OPLE** "I agree with her po, nandito po pala nakalagay yung department, mangyayari lang po, papalitan ulit yung pangalan or unless babaguhin yung sa..."

**COUN. REYNALDO C. PALABRICA** "Papaano papalitan?"





**NATIVIDAD LUDWIG I. OPLE** "Kasi po nakalagay po dito, Business Permit and Licensing Office, so BPLO, eh yung ginagamit na po ngayon, under sa ISO, BPLO."

**COUN. REYNALDO C. PALABRICA** "So, formalizing nalang."

**NATIVIDAD LUDWIG I. OPLE** "Yes sir."

**COUN. REYNALDO C. PALABRICA** "So ang magiging title, 'An ordinance formalizing...' conversion ba or renaming? Papaano ba? From BPLO to BPLD. Converting BPLO, Business Permit and Licensing Office, from office to a department, magiging BPLD tama ba? Councilor Bok? Any opinion about that? Paki gamit lang ang microphone."

**COUN. REYNALDO C. PALABRICA** "Ah ganito nalang, we will take note on your opinion on that, very valid po ang inyong mga opinion, so the council will discern kung ano yung mga tamang terminology during our session, but definitely, this proposal will be favorably endorsed by the city council for approval. Any questions from the city council members? If there are being none, I request a motion for adjournment."

**COUN. ALEJANDRO GUTIERREZ** "Since there is no other matters and special concerns to be discussed, I moved for the adjournment of this morning session of the presiding officer..."

**COUN. REYNALDO C. PALABRICA** "Before we act the motion of councilor Gutierrez, I will take the opportunity para makausap lang si ma'am Natty, tungkol sa yosi natin na ordinance, I prepare niyo na kasi kaming mga nagyoyosi, decisive na kami, gagawin na naming yun. Pero sa rooftop nalang kami, hindi mo na kami makikita kung saan-saan, sekretong malupit lang. higitan natin, we will aim for the orbit award, na kahit upos ng sigarilyo walang makikita sa government center compound. Kaya? Kaya natin? Pati vape?"

**COUN. REYNALDO C. PALABRICA** "So, yung smoking area will be outside the jurisdiction or property of government center, kahit isang hakbang puwede na. Pero definitely we will strictly implement that ordinance, nag usap-usap na kami na gawin ito para sa bayan. Thank you very much ma'am Natty, siguro coordinate nalang kay ma'am Ivy, si doctora Ivy naman ang mag dedetermine according to the ordinance sa mga smoking areas within the city, buong city hindi lang ito government but of course, magiging example ang government sector."





**Section 5. Use of Savings and Augmentation.** Pursuant to Section 236 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor and the Presiding Officer of the Sangguniang Pangungsaod are hereby authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

For this purpose, the word "savings" refer to portions or balances of any programmed appropriation free from any obligation or encumbrance, not available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absence without pay.

"Augmentation" implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources is determined to be deficient.

**Section 6. Priority in the Use of Personal Services Savings.** Priority shall be given to the personal benefits of local employees in the use of Personal Services savings.

**Section 7. Separability Clause.** If, for any reason, any section or provision of this Appropriation Ordinance is declared during Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

**Section 8. Effectivity.** The provisions of this Appropriation Ordinance shall take effect on 01 January 2024.
