

Subject: An ordinance creating the Bacoor City Ceremonial Key Award, establishing the process of conferring the said honor, identifying the qualifications of future recipients and providing funds for the implementation hereof.

(PCO-2024-189-Date referred: June 24, 2024)

The above-mentioned proposed ordinance underwent its first reading on June 24, 2024 during the 96th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon, Rowena Bautista Mendiola to the Committee on Tourism, Culture and External Linkages.

The committee on Tourism, Culture and External Linkages sent out invitations to resource persons and conducted a committee hearing on July 19, 2024, 9:00 a.m at the Session Hall of the Sangguniang Panlungsod.

FINDINGS:

This proposed ordinance is intended to bestow recognition on the Mayor of a City of Local Government that entered into a Sisterhood Agreement or Local Government Unit Partnership Agreement to memorialize the signing of the said agreements. This would also serve as a reminder to the residents of Bacoor and of the said cities/localities of the lasting bonds of friendship they share.

The Bacoor City Tourism and Cultural Development Department, with the assistance of the City Legal Services Office, shall submit the Implementing Rules and Regulations of the proposed ordinance for the approval of the City Mayor.

PROPOSED CITY ORDINANCE NO. 2024-189 SERIES OF 2024

AN ORDINANCE CREATING THE BACOOR CITY CEREMONIAL KEY AWARD, ESTABLISHING THE PROCESS OF CONFERRING THE SAID HONOR, IDENTIFYING THE QUALIFICATIONS OF FUTURE RECIPIENTS AND PROVIDING FUNDS FOR THE IMPLEMENTATION HEREOF.

WHEREAS, medieval cities were once protected by massive walls that guests could only enter through fortified gates with the use of a special key. This is the origin of the modern practice of banding ceremonial keys to individuals who have given special services to a city.

WHEREAS, the City of Bacoor, Cavite has entered into several Twin Sister Agreements and Local Government Unit Partnership Agreements over the years and the signing of the said contracts have been marked by nothing except the legal instruments on which the said agreements have been written.

WHEREAS, the formal creation of an award that will memorialize the forging of tice-between the City of Baccoor and other cities all over the world will show how seriously Baccoreños consider the agreements that its elected leaders enter into and how hospitable they are to residents of cities with special relationships with Baccoor. By so doing, it is hoped that the same degree of hospitality shall be bestowed upon Baccoreños by the elected leaders of the said cities.

NOW THEREFORE, upon motion of Hon. duly approved by the members of the 5° Sangguniang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled, be it ordained that:

Section I. Title. This Ordinance shall be known as the "Bacoor Ceremonial Key Award Ordinance".

Section 2. Purpose. This Ordinance is intended to bestow special recognition on the Mayor of a city or local government that entered into a Twin Sister Agreement or I scal Government Unit Partnership Agreement to memorialize the signing of the said contracts and to serve as a reminder to the residents of Bacoor and of the said cities/localities of the lasting bonds of friendship they share.

Section 3. Creation of the Bacoor Ceremonial Key Award. The Bacoor Ceremonial Key Award (the "Bacoor Ceremonial Key") is hereby created. The Bacoor Ceremonial Key shall consist of a metal key about seven inches long, gilded in gold, bearing the name and official seal of the City of Bacoor on its handle. The design of the Bacoor Ceremonial Key shall be approved by the City Mayor within sixty (60) calendar days after the effectivity date of this Ordinance. When conferred, the Bacoor Ceremonial Key shall be mounted on a certificate evidencing the agreement that was signed by the City Mayor and by the Mayor who shall receive the award in commemoration of the twin city relationship mentioned above. The said design may be revised as the Mayor—with the approval of the Sangguniang Panlungsod by way of Resolution—deems fit.

Section 4. Conferment of the Bacoor Ceremonial Key. The Bacoor Ceremonial Key shall be conferred by the City Mayor on the Mayor of any city or local government that entered into a Twin Sister Agreement or Local Government Unit Partnership Agreement to memorialize the signing of the said contracts and to serve as a reminder to the residents of Bacoor and of the said cities/localities of the lasting bonds of friendship they share.

Section 5. Bacoor Ceremonial Key Benefits. Registered voters of cities whose Mayor has been conferred with a Bacoor Ceremonial Key shall be assisted by the Bacoor City Tourism and Cultural Development Office in obtaining accommodations while they are staying within the City of Bacoor and shall be given a free tour of the Bacoor City Hall and the Bacoor Government Center free of charge. Other forms of assistance may also be granted to them upon the written order of the City Mayor.

Section 6. Appropriation. The amount of P100,000.00 shall be appropriated for the purpose of designing the Bacoor Ceremonial Key.

Section 7. Implementing Rules. The Bacoor City Tourism and Cultural Development Department, with the assistance of the City Legal Services Office, shall submit the Implementing Rules of this Ordinance for the approval of the City Mayor not later than sixty (60) working days from the effectivity date hereof.

Section 8. Effectivity Date. This Ordinance shall take effect immediately after a copy hereof has been posted on at least three (3) conspicuous places within the City of Bacoor, Cavite.
