The above-mentioned proposed ordinance underwent its first reading on June 24, 2024 during the 96th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon, Rowena Bautista Mendiola to the Committee on Tourism, Culture and External Linkages.

The committee on Tourism, Culture and External Linkages sent out invitations to resource persons and conducted a committee hearing on July 19, 2024, 9:30 a.m at the Session Hall of the Sangguniang Panlungsod.

### FINDINGS:

This proposed ordinance will create and award that will give recognition to individuals regardless of whether they hail from Bacoor or not who have done exemplary service, work or performance in public service, sports, arts, science and other fields of human endeavor for the benefit of the City of Bacoor. This will also keep the memory, legacy, and bravery of Gen. Evangelista which will serve as an inspiration to every Filipino.

The Bacoor City Tourism and Cultural Development Department, with the assistance of the City Legal Services Office, shall submit the Implementing Rules and Regulations of the proposed ordinance for the approval of the City Mayor.

Saka po Mr. chair, yung isa pa po, since it is award giving body recognizing the achievements of Bacooreños, parang it is about time na yun pong we got to see po doon sa proposal there are names, these people mostly, they were never honored, they were never recognized by their peers during their time, I think yung pagkakaroon po nito is also a golden opportunity for the city government to educate the present Baccoreños. especially po yung mga nag mimigrate po sa Bacoor, for them to learn more of our history, our culture kaya po pra pong, if it is okay po, ay mag resurface po yun pong mga pangalan nila, para po it can open up conversation with regard to their achievement, na ito pong mga Bacooreños, na nagbigay ng magandang pangalan po sa bayan po ng Bacoor."





WHEREAS, Gen. Edelberto Evangelista was a European educated civil engineer who was born in Manila on 24 February 1862. He was arrested by the Spaniards for being in possession of the writings of Dr. Jose Rizal but he was able to escape prison and he joined the Philippine revolutionary forces under Gen. Emilio Aguinaldo.

WHEREAS, despite not being a native born Caviteño, Evangelista saw action in various battles fought in Cavite including the town of Bacoor where he designed and built several fortifications that helped the Katipuneros become victorious against the colonial Spanish forces.

WHEREAS, on 17 February 1897, Evangelista died during the Battle of Zapote Bridge in Bacoor, Cavite while supervising the maintenance and repair of the fortifications that he built. He died in the service of Bacoor — a town he could not then consider his home.

WHEREAS, the dedication and bravery exhibited by Gen. Evangelista should serve as an inspiration to every Filipino. His exploits should be remembered constantly by teaching them to the young and by giving due recognition to modern-day Filipinos who share the same traits as Gen. Evangelista: service of the common good, excellence, bravery, and hard work.

WHEREAS, Section 16 of Republic Act No. 7160 ("the Local Government Code of 1991") provides in part that local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

WHEREAS, the creation of an award that gives due recognition to individuals regardless of whether they hail from Bacoor or not who have done exemplary service, work or performance in public service, sports, arts, science and other fields of human endeavor for the benefit of the City of Bacoor, Cavite will help keep the memory and legacy of Gen. Evangelista alive.

NOW THEREFOR, be it ordained by the 5th Sangguniang Panlungsod of the City of Baccor, Cavite THAT:

SECTION 1. Creation of the Gen. Edilberto Evangelista Award. The Gen. Edilberto Evangelista Award is hereby created and shall be conferred upon any individual —whether residing in the City of Bacoor, Cavite or not — who have done exemplary work, service, or performance in the fields of public service, sports, arts, the sciences, and other fields of human endeavor that benefited or honored the City of Bacoor or the Philippines.

SECTION 2. Conferment of Award. The said award shall be conferred by the City Mayor once every two years upon the recommendation of a selection committee to be comprised by the following:

The City Mayor, or his/her duly authorized representative as Chairperson;

The Head of the City Tourism and Cultural Development Office as Vice Chairperson;

- 1. The City Schools Division Supervisor of the Department of Education
- The Chairperson of the Committee on Educations, Culture and Sports of the Sangguniang Panlungsod; and

#### 3. The City Administrator.

SECTION 3. Criteria. The various criteria in the selection of the persons who shall be considered for conferment of the said award as well as the process for selection shall be determined by the members of the selection committee who are mandated to meet and to submit their recommendations for the approval of the City Mayor not later than sixty (60) days after the date of effectivity hereof.

SECTION 4. Cash Gift and Plaque of Recognition. Subject to availability of funds and pertinent government regulations, a cash gift of P100,000.00 and a plaque of recognition shall be awarded by the City Mayor to the awardee during ceremonies to be conducted within the City of Bacoor, Cavite.

SECTION 5. Implementing Rules and Regulations. The implementing rules and regulations of this Ordinance shall be prepared by the head of the City Tourism and Cultural Development Office with the assistance of the City Legal Officer to be submitted for the approval of the City Mayor not later than ninety (90) working days following the date of effectivity hereof.

SECTION 6. Repeal. All ordinances, resolutions, or executive orders inconsistent or contradictory to the provisions of this Ordinance are hereby repealed or are modified accordingly.

SECTION 7. Separability. The provisions of this Ordinance not affected by an order issued by a competent court of law declaring parts hereof as void or unconstitutional shall remain valid and enforceable.

SECTION 8. Effectivity. This Ordinance shall become effective immediately after it has been posted on at least three (3) conspicuous places within the City of Bacoor, Cavite.
