Subject: *An ordinance establishing an annual celebration of the importance of public safety, Filipino traditions, resilience, industriousness, kindness and environmental awareness in the City of Bacoor, Cavite to be known as the "Bacoor S.T.R.I.K.E. Festival" and appropriating funds therefor.*

(PCO-2024-212-Date referred: October 07, 2024)

The above-mentioned proposed ordinance underwent its first reading on October 07, 2024 during the 111th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the City Council En Banc with the Committee on Tourism and External Linkages chaired by City Councilor Hon. Reynaldo C. Palabrica as the lead committee.

The City Council En Banc sent out invitations to resource persons and conducted a committee hearing on October 10, 2024, 10:00 a.m. at the Session Hall of the Sangguniang Panlungsod.

FINDINGS:

Pursuant to the General Welfare Act Clause under section 16 of the Local Government Code, it is the duty of the local government units to promote the general welfare, which include maintaining peace and order, ensuring public safety, and preserving the comfort and convenience of all its inhabitants.

The City of Bacoor with its adherence to constitutional and statutory mandates has endeavored to implement programs and initiatives that enhance public safety, foster community resilience, and uphold environmental integrity.





The Bacoor S.T.R.I.K.E. Festival is a series of projects and programs from various departments of the City Government to be conducted annually within the City of Bacoor, commencing on the fifteenth (15) day of November and concluding on the fifteenth (15) day of May of the following year.

These Plans and Programs (PAPs) from various departments of the City Government shall be governed by the guiding principles of Selflessness, Thriftness, Resilience, Industriousness, Kindness, and Environmental Awareness. The City Mayor through the City Administrator shall assume overall supervisory authority over all PAPs to be incorporated in the festival.

The establishment of Bacoor S.T.R.I.K.E. Festival is essential in fostering the spirit of Bacoorenos, deepen the sense of shared responsibility, and institutionalize the culture of preparedness, sustainability, and social responsibility. This will also boost the spirit of resilience and solidarity of Bacoorenos during times of hardship, perseverance, unity, which must be recognized, celebrated, and perpetuated to serve as an inspiration for present and future generations.

RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, the City Council En Banc respectfully recommends that the Sangguniang Panlungsod approve the above subject matter.

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 100th Regular Session.

COUN. REYNALDO PALABRICA "The committee hearing regarding the ordinance declaring the annual celebration or also known as Bacoor S.T.R.I.K.E. Festival to promote public safety, Filipino traditions, resilience, industriousness, kindness and environmental awareness in the City of Bacoor, Cavite and appropriating funds therefore is now called to order."





COUN. REYNALDO PALABRICA "For the opening statement may I recognize the honorable gentleman from District 1 Hon. Councilor Adriel Gawaran."

COUN. ADRIELITO GAWARAN "Good morning, hello, good morning po. Akala ko hindi pa kayo nag memeryenda eh. My fellow colleagues, Committee Chairman Rey Palabrica, department heads, guests, ladies and gentlemen. Thank you po for coming, mabuhay po tayong lahat, God bless."

COUN. REYNALDO PALABRICA "Thank you very much Honorable Gawaran, mabuhay, Next is the gentleman from District 2, Honorable Councilor Bak Nolasco."

COUN. ROGELIO NOLASCO "Good morning, Mr. Chair, sa aking mga kasama at garun din po magandang umaga po sa ating lahat lala na sa ating mga resource persons at lahat ng department heads. Good morning and thank you."

COUN. REYNALDO PALABRICA "Thank you Hon. Nolasco. Next, is the gentleman from District 1 Hon. Councilor Levy Tela."

COUN. LEVY TELA "Good morning, Mr. Chair. Magandang magandang tanghali po sa ating lahat, mabuhay."

COUN. REYNALDO PALABRICA "Good morning, mabuhay. Next, is the gentleman from District 2 Hon. Councilor Simplicio Dominguez."

COUN. SIMPLICIO DOMINGUEZ "Magandang magandang umaga po sa ating lahat, mabuhay."

COUN. REYNALDO PALABRICA "Good morning, mabuhay. Last but not the least our ex-officio member of the Sangguniang Panlungsod, the Liga ng mga Barangay Vice President Hon. Councilor Randy Francisco."

COUN. RANDY FRANCISCO "Good morning, Mr. Chair. Magandang umaga po sa ating lahat."

COUN. REYNALDO PALABRICA "Magandang umaga po sa ating lahat, good morning, mabuhay. Parang wala ngang sigla, tama nga si Konsehal, isang bagsak nga dyan. Good morning, mabuhay!"

RESOURCE PERSONS "Good morning, mabuhay!"

COUN. REYNALDO PALABRICA "Ayan naman pala eh. Ang hindi nag mabuhay may violation sa ating ordinance. Anong penalty non? 1 month suspension without pay."

COUN. REYNALDO PALABRICA "Anyway, we will proceed to the discussion of our proposed ordinance regarding the S.T.R.I.K.E. Festival ordinance. May I know who is the representative from the Office of the City Administrator?"

COUN. REYNALDO PALABRICA "Meron ba tayong representative galing sa City Administrator, wala? Ms. Khei Sanchez of LEDIPO, are you aware of this proposed ordinance from the Office of the Mayor? Would you please enlighten the committee about this ordinance? Briefing lang about what is this all about."

KATHRINA SANCHEZ "Portion of the recording inaudible."

COUN. REYNALDO PALABRICA "Excuse me Ms. Khei, will you please take off your face mask? So, we could hear you loud and clearly. Thank you."

KATHRINA SANCHEZ "So far Konsi Rey if I am not mistaken, we have 2 or 3 meetings po, tama po ba? Para sa mga naka attend po previously. The first meeting was held 2 weeks ago, 1 week ago, a week ago po and then yung pinaka recent po was yesterday. Under the guidance of City





Administrator Atty. Aimee Neri, we have been subdivided into groups, into committees po and yesterday according to the discussion we have supposed to have another meeting after this committee hearing to polish the other details po."

COUN. REYNALDO PALABRICA "You mentioned a meeting regarding the organization of this."

KATHRINA SANCHEZ "Yes po, the S.T.R.I.K.E. Festival."

COUN. REYNALDO PALABRICA "Maybe planning meeting ba yun? Organizing meeting?"

KATHRINA SANCHEZ "The first meeting po. Kasi po humabal lang po ako galing po kasi ako sa isa pang event na pina-attend lang po ni Mayor Strike. Pero yung naabutan ko po parang nagkaroon na po ng groupings Konsi."

COUN. REYNALDO PALABRICA "May I know sino yung nasa meeting na nandito ngayon?"

KATHRINA SANCHEZ "Yung sa first meeting po."

COUN. REYNALDO PALABRICA "Ma'am Naty were you able to attend that mentioned meeting?"

NATIVIDAD LUDWIG OPLE "Your honor during the first meeting I was not included but I was part of the sub-committee. So, with the sub-committee doon po ako naka attend na meeting with regards po doon sa **Godparents Day** and **City Employees General Assembly**. And then the third meeting, dun po kami nakasama."

COUN. REYNALDO PALABRICA "So ito kasing ordinansa na to, gagawa tayo ng parang isang season noh?"

NATIVIDAD LUDWIG OPLE "Yes sir."

COUN. REYNALDO PALABRICA "Parang festival from month of November until month of May. I understand an Executive Order was already issued by the Chief Executive Mayor Strike. Ano pong nakalagay sa EO? Kasi wala kaming kopya nun eh."

NATIVIDAD LUDWIG OPLE "Doon po sa nakalagay sa EO, dalawang beses po kasi nirevised nila yung pang-una kasi merong nagkamali ng pangalan with regards doon sa co-chair. Inidentify po kung ano ano po yung mga committees at tsaka yung mga focus nung festival."

COUN. REYNALDO PALABRICA "May we know Ma'am Naty what is the substance of that particular EO? Para malaman natin kung ano yung objective, ano ano yung pinaka objective ng EO."

NATIVIDAD LUDWIG OPLE "Sir kasi doon po sa EO the main objective is that para mabigyan ang ating mga constituent's ng isang venue at saan mag-gagather, and then mabigay sa kanila yung mga information tungkol sa mga disaster preparedness, yung mga serbisyo na binibigay ng lokal na pamahalaan."

COUN. REYNALDO PALABRICA "So in-short this festival, ipapasok natin lahat ng activities ng lahat ng departments from month of November to month of May."

NATIVIDAD LUDWIG OPLE "Yes sir, para mas makatipid kasi hindi naman bubuulin na yung mga pondo."

COUN. REYNALDO PALABRICA "So lahat ng funds ninyo from different departments CSWD, health. Lahat kayo?"

NATIVIDAD LUDWIG OPLE "Yes sir."





COUN. REYNALDO PALABRICA "Para maifund na ngayon?"

NATIVIDAD LUDWIG OPLE "Exactly po."

COUN. REYNALDO PALABRICA "Tapos mag susubmit na lang kayo ng proposal activities, programs. Tapos implement during this period November to May."

NATIVIDAD LUDWIG OPLE "Yes sir."

COUN. REYNALDO PALABRICA "Kaya ba ninyo? What is your proposal regarding this proposal?"

NATIVIDAD LUDWIG OPLE "Sir saakin naman po nakikita ko naman nung binigyan kami ng overview kahapon, feasible naman po yun kasi karamihan po ng mga Hepe ay enthusiastic about this po and cooperative about it, Yun lamang po syempre meron din talagang mga adjustment lalo na sa mga opisina na sila yung magbibigay ng mga pondo para ma oddment naman yung mga project na hinehead ng iba pang committees."

COUN. REYNALDO PALABRICA "Excuse me point of order, baka pwede namang hinaan ang mga boses natin. Magsenyasan na lang kung nag-uusap kayo dyan kasi medyo may distraction, Atty. Marlus please lower your voice para maintindihan namin yung sinasabi, marinig naming mabuti."

COUN. REYNALDO PALABRICA "Ngayon lahat ng activities ng department ipapasok na natin dito para festive, Para pala tong Bagong Pilipinas Serbisyo Caravan, Pero yung venue nito dito lang lahat satin."

NATIVIDAD LUDWIG OPLE "Yes sir, exactly on what you said para po siyang caravan but this time with one big venue na ang tao ay itatransport sa S.T.R.I.K.E. gym."

COUN. REYNALDO PALABRICA "Siguro ang barangay ang mag tatransport non definitely."

NATIVIDAD LUDWIG OPLE "Yes sir, Tsaka po with regard naman po sa funding ang naemphasize naman kahapon ang mga nagreport na opisina kasama po si Ms. Khei don, Meron po tayong internal and external funds kasi aminado naman po na baka hindi maging sapat, so itatap din po yung mga kompanya na may CSR."

COUN. REYNALDO PALABRICA "I think kayang kaya naman natin with regards to funding of those activities, Sa annual budget naman natin yung regular programs ninyo and activities and funded nasa annual budget naman natin yun, plus magkakaroon tayo ng resources from outside through donations, Maybe mas lalong kaya natin, Kaya lang may tanong lang ako sainyo papaano ang scheduling neto? Sabay sabay ba kayo? Ilan ba kayong departments, 47 departments ata kayo, sabay sabay ba kayong may activities in 1 month? Every month ba ang activities ninyo? How do we schedule your activities?"

NATIVIDAD LUDWIG OPLE "Pinag-usapan na rin po doon kahapon kasi yung mga sub-committees is nakapag meeting na rin, So, nung nag-meeting kami for the third time halos lahat ay kasama, Naka schedule na po, naka plot na po and pinattern din po doon sa mga talagang kailangan na kailangan na nandoon si Mayor, Nagbigay siya ng dates so pinattern na rin po doon naka plot."





COUN. REYNALDO PALABRICA "So it doesn't necessarily mean na monthly may activities ang bawat office or departments? So, halimbawa by November, tatlong departments so may activities. Hindi naman oblige ang mga department to provide activities monthly."

NATIVIDAD LUDWIG OPLE "Yes, exactly sir kasi po katulad ng sa HR nagkagrupa kami ni Ma'am Tess ng LCR atsaka ng CSWD. Nelong October and then December so kung sa HR po magaan naman din po kasi talagang kung ano lang po ang appropriate doon sa function ng opisina."

COUN. REYNALDO PALABRICA "You have mentioned there was a committee, sub-committees doon sa meeting ninyo. Kasi dito sa proposed ordinance from the Office of the Mayor, Office of the City Administrator particular hindi namention dito kung sino yung nasa management team. So, sino sino ba yun? Will you please enlighten us."

NATIVIDAD LUDWIG OPLE "Okay lang po ba basahin?"

COUN. REYNALDO PALABRICA "Sige lang po. Habang hindi mo pa binabasa, yung libreng kasal ba dito buwan buwan na pati binyag? Ma'am Tess ano to, ang libre kasal ba buwan buwan na November, December? Sige Ma'am Naty please proceed."

NATIVIDAD LUDWIG OPLE "Sir pasensya na po medyo mabagal po kasi."

COUN. REYNALDO PALABRICA "Sino ba ang taga MIS dito? May MIS representative ba tayo? Ang bagal daw ng internet natin. Sige di bale Ma'am Naty, kung may committee na we will coordinate with the City Administrators Office for us to include those proposed committee to be included in this ordinance. Kasi dito sa proposed nila wala pang nakalagay kung sino."

COUN. REYNALDO PALABRICA "May tanong lang ako sa bawat department, taas lang ng kamay sa kung sino ang gusto sumagot. Kasi we have **regular celebrations** sa mga **national proclamations** tulad ng **Disaster Resilience Month, Women's Month**. Mandatory yan satin diba? Tama, CSWD? Papaano kung ang date of celebration ay hindi tumapat doon sa November and May? How do we manage that? CSWD muna, marami kayong celebration eh, meron kayong **Kids Day**, madami kayong ganyang klaseng activities."

CHRISTIAN JOSHUA "Yes sir, Konsi regarding po doon since ang ating Women's Month po yung ating mga big activities ay pasok naman po doon sa ating S.T.R.I.K.E. Festival, pasok naman po kasi sa March naman po yun Konsi."

COUN. REYNALDO PALABRICA "May point is papano yung mga regular activities natin, annual activities na hindi pasok doon sa November and December. How do you manage that?"

CHRISTIAN JOSHUA "Sa ngayon Konsi."

COUN. REYNALDO PALABRICA "luorong niyo ba? Sino ba ang taga disaster dito? Any representative from the disaster? Kanina nakita ko si Richard."

COUN. REYNALDO PALABRICA "Tapos November ang sinasabi natin paano yung September? Pag September is Bakood Festival, this is another festival. Meron din tayong set of activities dito aside from S.T.R.I.K.E. Festival. How do you manage this Mr. Edwin Guinto?"





EDWIN GUINTO "Mr. Chair yun po kasing S.T.R.I.K.E. Festival, nakita ko rin po kasi yung EO po is fully concentrating on tapping all sectors. So, daon po sa committee meeting namin kahapon, we identify the activities per sector po para po macover po lahat. But we still implementing the usual festival that we have like September Bakood Festival and the cityhood for June so naincorporate na po yun sa S.T.R.I.K.E. Festival."

COUN. REYNALDO PALABRICA "Papano na incorporate, iurong natin yung mga activities?"

EDWIN GUINTO "Hindi po, same date rin po sir."

COUN. REYNALDO PALABRICA "You'll be having a supplemental or additional activities para dito sa S.T.R.I.K.E. Festival?"

EDWIN GUINTO "Yes po. To cover all sectors."

COUN. REYNALDO PALABRICA "Relevant to the activities being conducted by our city during Bakood Festival?"

EDWIN GUINTO "Yes po, over and above the cityhood and the Bakood festival po."

COUN. REYNALDO PALABRICA "So, meaning halimbawa kasi taon taon meron tayong **National Marching Band competition**, right?"

EDWIN GUINTO "Yes po."

COUN. REYNALDO PALABRICA "Minsan ay may international pa. Pag dating netong S.T.R.I.K.E. Festival ano ang magiging activities mo?"

EDWIN GUINTO "Yun po yung dinedevelop po naming, kung ano po yung participation ng Marching Band during the S.T.R.I.K.E. Festival po."

COUN. REYNALDO PALABRICA "So in short, Ma'am Naty walang babaguhin doon sa mga usual and traditional nating activities?"

NATIVIDAD LUDWIG OPLE "Yes po."

COUN. REYNALDO PALABRICA "So this is an additional activity?"

COUN. REYNALDO PALABRICA "Actually, yung mga activities natin ay pinopondohan yan tapos nagreflect yan sa ating annual budget kaya ang Sangguniang Panlungsod ay properly informed to their activities, naka salansan na yan eh. Halimbawa si Ma'am Naty meron siyang employee's assembly, nandodoon naman yun. In terms of Bakood Festival naka line up na doon sa annual budget natin yung National Marching Band competition. Sa health yung kanilang mga medical mission, sa livelihood yung kanilang mga activities. Yes, lahat yan, with regards of the information to the Sangguniang Panlungsod with every activity of every department. We are properly informed through the annual budget submission, ang ischeduling lang of implementations of course because our duty is about legislation. The implementation of such executive departments yung Mayor delegated to the department heads."





COUN. REYNALDO PALABRICA "So, pagdating naman po doon, nakasalansan na ng mabuti iyon. Kung hinahanap niyo po ang plans and programs iahat ng department including barangays, City Government, Provincial Government and even National Government hindi pwede mag pondo, mag gawa ng budget ng walang plan. Laging merong plans and programs na sina submit, actually their plans and programs submitted to the Sangguniang Panlungsod for our review through our Finance Committee Chairman, Hon. Nolasco, yung tinatawag nating annual investment plan. Kapag meron silang karagdagan doon sa annual investment plan, nagsusubmit naman sila dito satin ng supplemental investment plan. So, iyon po ay submitted naman po sa atin."

COUN. REYNALDO PALABRICA "Ayun nandito si Ma'am Lillian, thank you very much for being here Ma'am Lillian. Medyo hihingi lang kami ng enlightenment about this proposed S.T.R.I.K.E. Festival. Anyway, makikipag coordinate na lang kami para dito, para mabuo namin yung ordinansa."

COUN. REYNALDO PALABRICA "Meron na bang secretariat? Kasi sabi niyo nga kanina, although may Executive Order na kayo na mag organize for S.T.R.I.K.E. Festival, wala pa kayong ordinansa. Kaya ngayon pinag-uusapan natin, so, for us to draft perfectly the ordinance para mas maging magaling yung implementation natin. Meron na bang binuong secretariat ang executive department for this particular organization? Ma'am Naty meron na ba?"

COUN. REYNALDO PALABRICA "Meron ng secretariat? Kasi sinasabi niyo kanina may committees na."

NATIVIDAD LUDWIG OPLE "Yes sir."

COUN. REYNALDO PALABRICA "Over and above there should be a secretariat. To supervise and oversee the implementation. Meron na ba tayo?"

NATIVIDAD LUDWIG OPLE "Sir pinadala ko po sa inyo yung listahan ng committees. Pero ang lumalabas po doon sa EO, wala siyang secretariat."

COUN. REYNALDO PALABRICA "So the supervision will be through the City Administrators Office?"

NATIVIDAD LUDWIG OPLE "Yes po."

COUN. REYNALDO PALABRICA "In behalf of the mayor. Any comments, suggestions, opinions regarding this proposal? May I hear from the barangays? Kasi ganito ang mangyayari, dito sa S.T.R.I.K.E. Festival."

COUN. REYNALDO PALABRICA "Nandito na pala si Mr. Richard Quion, alamin ko lang sa department mo kasi diba may iba't ibang mandatory activities. Kasi diba meron kang **Disaster Preparedness Month**, meron kang mga **earthquake drill**, may **fire prevention month**. Ang tanong ko lang dito sa S.T.R.I.K.E. Festival papano mo imamanage yung mga activities, lilipat mo ba ng pelsa yung mga activities or you will conduct those mandatory activities tapos meron kang additional activities for the S.T.R.I.K.E. Festival?"

RICHARD QUION "Yes, sir good morning po to all the resource persons and to all members of the panel. Sir, bale para po sa S.T.R.I.K.E. Festival, solely we will be conducting community trainings. Yun po yung nakapaloob para sa S.T.R.I.K.E. Festival, yung mga mandatory activities na yan hindi





po kasi natin basta basta malipat kagaya na lang po nung earthquake drill which is quarterly as mandated by the National Government. So, talaga pong ifatollow po natin yun, meron pa rin po tayong icoconduct na drills quarterly sa iba't ibang sectors. Tapos ayun pong observance po natin which is the National Disaster Resilience Month, which is always July by proclamation din po ng National Government. Icoconduct pa rin po natin yun, pero majority po of other activities is yung community trainings be conducted to the duration of the S.T.R.I.K.E. Festival."

COUN. REYNALDO PALABRICA "So, the mandatory celebration will be conducted according to its original schedule."

RICHARD QUION "Yes po."

COUN. REYNALDO PALABRICA "Tapos magdadagdag na lang kayo. So yung regular activities niyo tuloy lang and then magcoconduct na lang ng other activities for the S.T.R.I.K.E. Festival. Ang gusto kasi ng ating alkalde, Hon. Mayor Strike B. Revilla, kailangan during this S.T.R.I.K.E. Festival period kailangan festive masaya ang mga Bacooreño."

COUN. REYNALDO PALABRICA "Ma'am Lilian would you please enlighten the honorable committee. What is this S.T.R.I.K.E. Festival all about."

EMILIANA DR. UGALDE "Magandang umaga po sa ating lahat, kagalang galang na Konsehal ng Bayan, sa ating pong mga Barangay Captains and sa ibang mga kasamahan ko dito sa city hall, magandang umaga po. Una po ako ay humihingi ng paumanhin dahil ako ay nanggaling pa sa ibang seminar event, anyway, the S.T.R.I.K.E. Festival nakasama lang po ako during the initial meeting with the Admin Neri and the concept of the S.T.R.I.K.E. Festival ay mabigyan ng serbisyo at maipaliwanag ang accomplishment and plan of the City Government at the same time maging masaya ang Bacoor. So, dito po sa S.T.R.I.K.E. Festival tatlong bahagi ang nakikita namin dito na pinag-uusapan, ngayong Christmas magkaron tayo ng S.T.R.I.K.E. Christmas Village, ito pa rin ay pag-uusapan pa rin dito. Ito po ay tatagal ng 50 days."

COUN. REYNALDO PALABRICA "So, one of the proposed activities."

EMILIANA DR. UGALDE "Yes po, S.T.R.I.K.E. Christmas Village. Then from January to June yung first half ng 2025 meron tayong 128 events na gagawin."

COUN. REYNALDO PALABRICA "6 months."

EMILIAN DR. UGALDE "Nagkaroon po kami ng dialog with the mayor and under approval pa rin po ito ng buddy. In every week, ang Wednesday, Friday and Saturday yun po ang naka reserve na activity. Ang venue po ay dito po sa loob ng gymnasium, doon po gagawin, centralized. So, kung sa umaga ang target natin ay District 1 sa hapon ay District 2, Friday ganun din po and then Saturday general na yun coming from different barangays. Now this activity po is led by the different department especially yung mga sectors department, dito po sa activity na to lahat ng mga accomplishments, plans and mga ginagawa ng departamento ay ididiscuss lahat doon during 4 hours, 3 hours saamin, 1 hour kay mayor."

COUN. REYNALDO PALABRICA "Maganda pala to, kasi tuloy tuloy ang serbisyo at saya, S.T.R.I.K.E. Festival tuloy tuloy ang serbisyo at tuloy tuloy ang saya."





EMILIANA DR. UGALDE "Opo, and then."

COUN. REYNALDO PALABRICA "Before I recognize Honorable Francisco, I would like to recognize the presence of our Honorable Councilor from District 2, Honorable Councilor Obet Advincula. Also, from District 1 Honorable Councilor General Alex Gufierrez. From District 2, Honorable Councilor Rey Fabian. Before I recognized Hon. Francisco, please Ma'am Lilian proceed."

EMILIANA DR. UGALDE "And then the mandatory activities coming from different departments, itatapat po yun kung saan po dapat. Like yung sinsabi ni Sir Richard, Kung saan month siya doon dapat itatapat. Dito po hindi po kami dito magtatrabaho as CSWD, CHO or as BDDRM but we are under MSBR program. Lahat ng programang yun hawak ng MSBR. So, ayun nga po yung gusto ni Mayor na parang isang pamilyang bababa under the MSBR. Yung detalye po nito Konsehal pwede po kaming magbigay sainyo ng copy furnished para makita niyo."

COUN. REYNALDO PALABRICA "Yes please, kasi dito sa proposed ordinance submitted by the City Administrator masyado pa siyang vade eh. Kaya hindi namin alam kung magkano ang budgetary requirement na nakalagay dito."

EMILIANA DR. UGALDE "When it comes to funding Konsehal kung ano yung existing fund namin for that year na cover that month ayun na po ang pwede naming gamitin. Kung may nakikita po tayo na mas kailangan pa iimprove sa mga susunod na taon doon natin mas kailangan magdagdag. But for now, ang gagamitin muna namin is yung existing within our department."

COUN. REYNALDO PALABRICA "Okay Thank you Ma'am Lilian. Honorable Francisco is recognized,"

COUN. RANDY FRANCISCO "Good morning, Mr. Chair idagdag ko lang po doon sa sinasabi ni Ma'am Lilian na program is yung November 15 po kasi nag utas na po saamin si mayor kasama na po to sa S.T.R.I.K.E. Festival. Mag gagawa po kami ng barangay decoration consisting of 47 barangays, may premyo po na 1.5 million and then I think na sa accounting na po yung pondo, ibibigay po sa mga barangay sa Christmas decoration po kasi yun po yung ibibigay ni mayor na premyo po financial assistance na po siya sa Liga ng mga Barangay. So, by November 15 asahan niyo po yung mga barangay halls po namin ay may decoration na po, dahil yun po yung isa po na sa tingin ko po simula po ng S.T.R.I.K.E. Festival. Thank you, Mr. Chair."

COUN. REYNALDO PALABRICA "It was mentioned by Ma'am Lilian yung mga proposed ordinance will commerce on January until June."

EMILIANA DR. UGALDE "Yung sinasabi po ni Konsehal Randy, November 15 that is the launching of the S.T.R.I.K.E. Festival."

COUN. REYNALDO PALABRICA "It is proposed in the ordinance under Section 4 that this festival will be conducted every 15th of November until May. So alisin na lang siguro natin yung period."

EMILIANA DR. UGALDE "Yes Konsehal kasi po ang sinasabi ko nga po is yung mga program ng mga department heads na January to June, so dapat kapag tinignan yan half-year dapat ang ating proposal."

COUN. REYNALDO PALABRICA "Maybe it will be more appropriate kung ilalagay na lang natin na magkakaroon ng 6 months S.T.R.I.K.E. Festival not mentioning dates. Kasi dito November to May kaya ayun yung pinaguusapan natin kanina, it was manifested that the first ever S.T.R.I.K.E. Festival





celebration will be conducted next year January to June so in conflict with the ordinance. To avoid technicalities maybe we can amend or revise the proposed provision that the S.T.R.I.K.E. Festival be conducted 6 months every year, may conflict nga."

COUN. REYNALDO PALABRICA "So, konti na lang ipopolish dito doon sa nabanggit kanina na January to June na activites ngayong 2025. Clearly stated on the 15th of November that will end on 15th of May 2025. siguro maring may adjustments na lang. Gagawan na lang namin to ng provisions kumbaga pwedeng adjustable, depende kung may kalamidad, wag naman sana. May I ask the barangays kasi as mention earlier by Ma'am Lilian that all the activities regarding the S.T.R.I.K.E. Festival will be conducted here in S.T.R.I.K.E. gym. So, transport of beneficiaries or constituents that be joining the festival or our constituents availing the free services during the festival will be transported to city hall. The transport will be responsibility of our barangays. What is your opinion regarding this?"

COUN. REYNALDO PALABRICA "Makakatulong naman to sa mga constituents niyo, kunyare si Ma'am Lilian isinagawa ang Kids Day, ang mga constituents niyo ang mag eenjoy dito. Dalhin niyo doon, yung mga magulang ng mga batang yan ay matutuwa sa inyo."

COUN. REYNALDO PALABRICA "Halimbawa sa health pap smear. Pwede ba yun, kasama ba yung pap smear Dra. Ivy? Anong activities ang meron sa health?"

DRA. IVY MARIE YRASTORZA "Regarding sa health po more on information dissemination po. Pwede naman po yung pap smear pero we should have a separate area."

COUN. REYNALDO PALABRICA "How about libreng eye glasses, pustiso during this festival? Kasi ang gusto ng mayor masaya ang taong bayan sa festival, Papaano makakangiti kung bungal at walang pustiso."

DRA. IVY MARIE YRASTORZA "Usually po nag papa pre list po sila."

COUN. REYNALDO PALABRICA "Tapos yung activity pwede mo include dito?"

DRA. IVY MARIE YRASTORZA "Pwede naman po during the S.T.R.I.K.E. Festival."

COUN. REYNALDO PALABRICA "What is the opinion of the barangays regarding this proposal?"

COUN. RANDY FRANCISCO "Mr. Chair almost lahat naman po ng programs ng city ay suportado naman po ng barangay. Kahit papano naman po ay natulong naman po kami sa transpo ng mga constituents namin papunta dito sa city. Sa tingin ko naman po, kaya naman po pero depende po kasi sa dami po ng participants per barangay."

COUN. REYNALDO PALABRICA "We will be having 120 activities in 6 months. So, in average there will be 20 activities per month. Meaning 20 times per month you will transporting your constituents papunta dito."

COUN. RANDY FRANCISCO "Hihingi na kami ng tulong kay mayor pag ganyan."

COUN. REYNALDO PALABRICA "Kasi syempre may mga sasakyan naman kayo diba?"





COUN. RANDY FRANCISCO "Meron naman pong sasakyan syempre, pero hindi naman po kasi lahat ng barangay kaya yung gasoline expenses, ayun po yung magiging problema natin. So, sa tingin ko kapag kinulang na kami tsaka na lang kami hihingi ng tulong kay mayor."

COUN. REYNALDO PALABRICA "Okay, thank you. Ma'am Lillian is recognized."

EMILIANA DR. UGALDE "Actually po may meeting kami with regards to those issues. Kahapon po kasi napag usapan na kung dito gagawin yung S.T.R.I.K.E. Christmas Village, paano makakarating yung mga taga ibang barangay? So, during the usop lang with mayor kasama ang ating mga department heads, gusto niya dito lang gawin sa city hall. Magpopopovide siya ng bus and then ioorganize niya ang mga barangay captain kung kelan ang schedule nila per day. Nung binasa ko yung EO, ang laki ng part ng barangay, siguro kung sa delegation ng functions and responsibilities, isama natin sila na maging part ng S.T.R.I.K.E. Festival doon sa implementation nito. Kasi ang tao manggagaling sa kanila eh, although meron kaming mga targeted clients and participants sabi nga ni Dra. Ivy, ang laki ng impact dito eh. Pag ang barangay ang nagsabi ng tayo ang responsible for this day madali na lang tayo makaka produce."

COUN. REYNALDO PALABRICA "The only dilemma na nakikita ko sa mga barangays ay limited ay mga tao at beneficiaries na magpaparticipate on these activities."

EMILIANA DR. UGALDE "Sa 180,000 ba mahihirapan pa rin tayo? Hindi pa rin sila kasama?"

COUN. REYNALDO PALABRICA "Depende yun sa activity na gagawin. Halimbawa pustiso ang ibibigay ay 300 or 1,000 idivide mo sa 47. Anyway, laaddress and isusuplement naman natin to, we will find solutions to address those issues. Legal department, Atty. Marius what is your legal opinion regarding this proposal?"

ATTY. MARIUS SUMIRA "Binabasa ko po yung letter ni mayor papunta kay Atty. Atega. Based po dun sa letter merong proposed ordinance na buo na galing sa SP tapos pinadala lang po sa office ni mayor to provide comments and for review. Napansin ko lang pa kasi doon sa last sections, yung section 6 to 11 naka xxx lang po kasi siya, ibig sabihin wala pong comment yung Office of the City Mayor. Kaya po siguro Konsi sabi niyo kanina hindi identify yung management team, baka po kung makikita yung pinadala sa office ni mayor mas kumpleto yun."

COUN. REYNALDO PALABRICA "Actually the purpose of this hearing is to fill-in the gaps. Kasi tignan niyo yung mga gaps ng proposed ordinance na ito, wala pa lahat eh, management team. This proposed ordinance was prepared by our City Administration as reflected to this document, si Atty. Neri. So, we will call the attention of Atty. Neri para ayusin to, maraming department ang involved dito so there should be a secretariat para mag supervise, mag provide ng resources. Kasi napakalaki ng event na ito, imagine the 120 activities in 6 months, mobilization lang ng tao napaka bigat na neto eh. Dapat meron tayong management team at ang terminology ko dito soaming political we called the management team as secretariat na siyang nag mamanager ng lahat. Also, the most important is the resources, the funding, kanina nabanggit na under one office na lang yung funds for these activities. Okay naman yun para di sabog sabog din, iPPR na lang kasi diba ang budget ninyo kanya kanya, ang magdidiburse mayors office na lang siguro. Definitely kulang yung mga budgets na yan kasi ang budget natin for this year hindi naman included tong S.T.R.I.K.E. Festival so kailangan natin mag outsource."





COUN. REYNALDO PALABRICA "With regards to your opinion babalik sa inyo to, pwedeng kami na ang gumawa we will consult the City Administrator, we will collaborate to come up with the appropriate management team. Si Ma'am Venus De Castro what is your opinion?"

ATTY. VENUS DE CASTRO "Meron lang po akong gustong itanong mag iistart ng November mag eend ng May, ano po yung rational kung bakit yung remaining 5 months hindi kasama sa festival? Considering po na long proposed ordinance all encompassing at buong buo ito eh and knowing na gusto niya talaga eh lahat mabigyan ng masayang serbisyo. Ngayon ang gagawin natin under the leadership of Mayor Strike B. Revilla ay magbigay ng kasiyahan sa pamamagitan ng mga aktibidad na pinoproposed ngayon. Kasi po dito hindi lang kasiyahan, serbisyo pa eh, pagkatapos may binabanggit pa dito na Filipino heritage yung bayanihan, resilience, industriousness, kindness, kaya lahat ay all encompassing. Bakit 7 months lang? How about the remaining 5 months? Supposedly, this will be done for the whole year, ayun lang po yung tanong ko ano po yung rational bakit po naleaveout yung 5 months?"

COUN. REYNALDO PALABRICA "Thank you sa tanong po ninyo, actually po that is also our question but kung huhulaan ko kasi hindi kami ang proponent nito eh. According to my observation January ay hindi pa natin mairerelease ang budget technically kasi merong mga accounts payable pa yan mahirap mag implement ng January hanggang February yan. Tapos ang mga barangays naman syempre kailangan natin ng suporta nila, according to our experience during our time, nakakapag pasa sila ng mga annual budgets nila January, February. Pag napllayan tayo sa barangay may epekto ito negatively doon sa activities natin, March is of course birthday celebration of our bosses, Mayor, Cong Jolo, Ramon Revilla Sr., may other activities yan. That maybe will have a conflict on the festival, then pag dating ng April holy week, Pag dating ng May ay piyestahan ng mga barrio, fiesta sa bayan, fiesta sa Queens Row, fiesta sa Molino at kung saan saan. Pag dating ng May summer time, kung 6 months ma-aalangan naman tayo kung May to December, kaya magiistart tayo ng November para yung budget natin macover na natin yung sa January, Kasi hindi kami ang nag draft ng ordinance ito ay based lamang sa aking assumptions, personal assumptions not committee assumptions."

EMILIANA DR. UGALDE "Kaya lang hindi ho ba kapag election although meron kaming budget for the whole year."

COUN. REYNALDO PALABRICA "May election ban."

EMILIANA DR. UGALDE "Nakikita ko po na tuwing mag eeleksyon ang pinapagawa lang po saamin ay hanggang June."

COUN. REYNALDO PALABRICA "Restrictions sa batas relative to election rules."

ATTY. VENUS DE CASTRO "Yung tungkol sa elections, yan particularly for May 2025 pero yung remaining 2 years wala namang eleksyon. Alam naman ho ng ating pamunuan ang CSWD lahat tayo na sa pag perform ng ating mga activities ay nagoobserve tayo ng thriftiness. Katulad sa OSCA linutulongan kami ng CSWD pero dumidiskarte kami kung sino ang pwede naming hingian ng tulong para hindi naman natin maubos yung budget."

COUN. REYNALDO PALABRICA "Councilor Obet may gusto ka bang sabihin? Councilor Alex, Councilor Rey, Councilor Simplicio, Councilor Gawaran?"





EDWIN GUINTO "Mr. Chair this S.T.R.I.K.E. Festival is targeting all sector, bukod naman po kasi yung ating Bakood Festival dahil ito ay cultural festival. While, S.T.R.I.K.E. Festival focusing on services doon sa all-sectors kaya may differentiation naman po siya. Although pinasok pa rin yung heritage and cultural within the S.T.R.I.K.E. Festival dahil may December part yan because of the Christmas season. On my own opinion, okay po yung proposal ng ating mahal na mayor to conduct this S.T.R.I.K.E. Festival for 6 months starting November 15. Isa nga po sa concept niyan is yung S.T.R.I.K.E. happiness to the Bacoreños."

EDWIN GUINTO "Sa committee meeting po ng S.T.R.I.K.E. Festival kahapon napresent na po yung bawat committee ng mga gagawin nila sa S.T.R.I.K.E. Festival. Ang bottomline po ng presentation ay madetermine kung ano yung cause and resources dahil ayan yung importante kung saan kukunin at saan manggagaling. Sa susunod na meeting po namin we are also given a deadline until Friday to determine the whole budget or resources for this S.T.R.I.K.E. Festival po."

COUN. REYNALDO PALABRICA "Definitely, wala kasing budget but it was mentioned earlier kung ano yung existing budget niyo ngayon, ayun yung working budget niyo muna for this event and eventually by next year properly funded na siya, kasama na sa annual budget."

EDWIN GUINTO "Mr. Chair after po ng submission ng deadline ng Friday, kung ano po yung kulang ayun na lang po idudulog namin sa Sangguniang Panlungsod. Maraming salamat."

COUN. REYNALDO PALABRICA "Titignan din natin kung may pag kukunan. So, it will depend upon the resource's available ng city."

KATHRINA SANCHEZ "Councilor Rey, your honor we actually have a fund-raising group or committee and we are approaching corporations and establishments po, especially the major ones po. Tapos na rin po fiscal year at yung ibang companies na exhaust na rin po yung kanilang budget, while we are hoping na makakatulong po ang private sectors actually the big companies, malaking bagay po talaga. Thank you po."

COUN. REYNALDO PALABRICA "Gagalingan natin mag outsource. Kapag foundation ang ginamit mas mabilis ang disbursement, hindi tayo mahihirapan, kaya titignan natin ang side na yun. Lahat naman ng sides dito ay para sa success ng S.T.R.I.K.E. Festival, gagawin ng Sangguniang Panlungsod."

EMILIE DE CASTRO "Magandang umaga po sa ating lahat, concern lang po with regards po sa funding. Naiintindihan po namin kasi gawa na po yung pondo for 2025, so medyo wala pong nakasulat sa funding source di po ba? Ngayon ang sinabi po ni Ms. Lilian meron pong ipupull out na budget sa bawat department po, para po mag work out po yung festival po na ito. Ang tanong lang po with all due respect po kay Ma'am Lilian, gusto ko lang po malaman na yung ipupull out na pondo sa bawat department ay para lang po ba sa lahat ng department o selective department lang po."

COUN. REYNALDO PALABRICA "I think it will depend on sa icocontribute ng bawat department."

EMILIANA DR. UGALDE "Actually po, pinadala po saakin ni Ma'am Elvie yung fund as per instruction po of the mayor, coming from the different departments na pwedeng pagkuhanan and most of the department coming from the social sectors. Lahat ng mga departamentong humahawak ng tao, nakikipag usap sa tao. As per mayor, lahat ng mga budget na gagamitin sa January to June na magiging part ng activity mo ay ayun lang din naman ang kukuhanin sayo."





COUN. REYNALDO PALABRICA "According to activity you provide ay yung budget na icocontribute mo doon."

EMILIANA DR. UGALDE "Ang target po natin ay 1,500 per event, meron po tayong targeted na participants per event. Kung yung tao doon ay 500, magkano naman yung budget mo doon sa 500 na yun?"

COUN. REYNALDO PALABRICA "Para sa food."

EMILIANA DR. UGALDE "Opo, kaya lang ang sinasabi ni mayor ay para mautilize ng maayos. Lahat tayo ay magbibigay ng budgetary requirements. Sa isang activity pupunuin natin ang isang activity ng 1,500, may mga different activities yun, kumbaga doon lang natin sasamahan."

COUN. REYNALDO PALABRICA "According to your contributed activity."

EMILIANA DR. UGALDE "Opo hindi po mawawala yun, naka linya po. Kung ano yung activity mo, gagawin mo naka base pa rin doon. Hindi tayo pwedeng magbago dahil may auditor tayo tapos may icocomply tayo na mga documents."

COUN. REYNALDO PALABRICA "Meaning all the disbursements are according to government procurement law. Or maaaring mag subsidize ka pag kulang yung isang opisina, halimbawa ang budget mo sa isang opisina ay pang dalawang doang tao, that is not impossible, it may happen."

MA. THERESA CAMEROS "Kahapon nagmi-meeting kami, kung fitignan natin yung proseso bago. So, tingin ko lang po kung sama sama nating mauunawaan yung konsepto ng January to June, gawin natin. Kagaya ng ibigay muna natin yung special request ng mayor, special project. Kaya natin to dahil tayo naman ay mag-uusap palagi, hindi naman tayo gagawa ng idinikta ko lang sainyo."





WHEREAS, these incidents have further demonstrated the resilience, industriousness, and solidarity of the Bacooreños, who, in the face of adversity, have come together to rebuild their lives;

WHEREAS, the spirit of resilience and solidarity of the Bacooreños during times of hardship is a testament to the values of perseverance, unity, and community strength, which must be recognized, celebrated, and perpetuated to serve as an inspiration for present and future generations;

WHEREAS, an annual celebration such as the "Bacoor S.T.R.I.K.E. Festival" serves not only to commemorate the enduring spirit of the people

In the comprehensive planning, management, execution, financing, and evaluation of the various projects and programs (hereinafter referred to as "**PAPs**") within the Festival, the various departments of the City Government shall be governed by the following guiding principles:

1. The aforementioned PAPs shall exemplify the principle of **SELFLESSNESS**, prioritizing the collective welfare of the Bacooreños and ensuring that all initiatives serve the greater good rather than individual interests.
2. All facets of the PAPs shall be conducted in adherence to the principle of **THRIFTINESS**, mandating the judicious and prudent utilization of public resources to maximize efficacy without compromising the integrity or quality of the activities.

3. The PAPs shall be crafted to bolster **RESILIENCE**, fostering an environment where the City of Bacoor is equipped to anticipate, prepare for, and adapt to adverse conditions and challenges.
4. The diverse array of PAPs included in the Festival's celebration shall promote **INDUSTRIOUSNESS**, reflecting the work ethic of the Bacooreños and contributing substantively to the advancement and prosperity of the community
5. The Festival shall serve as a platform to honor and propagate various Filipino Traditions, inclusive of **KINDNESS**, respect for elders, and other cultural values that embody the Filipino spirit and strengthen communal bonds.
6. The Festival shall amplify **ENVIRONMENTAL AWARENESS** among all participants, ensuring that all PAPs incorporate sustainable practices and promote the imperative of environmental protection as integral to community resilience and development.

Section 4. Period of Implementation. The Festival shall be conducted annually within the City of Bacoor, commencing on the fifteenth (15th) day of November and concluding on the fifteenth (15th) day of May of the following year, with the City Mayor possessing the discretion to make necessary adjustments to the schedule to facilitate the effective execution of the event.

Section 5. Formulation of the Calendar of Activities. The City Mayor, through the City Administrator, shall assume overall supervisory authority over all PAPs to be incorporated into the Festival, as well as the formulation of the calendar of activities. Such formulation shall be executed with prior consultation and collaboration with all department heads, barangay officials, and pertinent stakeholders to ensure inclusivity, comprehensive planning, and effective inter-agency coordination.
