Subject: An ordinance abolishing four (4) Dentist 1 positions with corresponding salary grade 14 and creating three (3) Dentist 2 positions with corresponding salary grade 17 under the office of the City Health Services in the City of Bacoor to be appropriated in the supplemental budget of the City of Bacoor, Cavite for calendar year 2025.

(Date referred: November 20, 2024)

The above-mentioned proposed ordinance underwent its first reading on November 20, 2024 during the 117th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Acting Presiding Officer, City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica to the Committee on Ethics, Appointments and Government Re-Organization.

The Committee on Ethics, Appointments and Government Re-Organization sent out invitations to the resource persons and conducted a hearing on December 05, 2024, 10:00 a.m. at the Session Hall of the Sangguniang Panlungsod.

FINDINGS:

To enhance the efficiency of the dental services of the City Health Services, some positions in the Plantilla of the said office should be abolished and various positions should be created.

The proposed ordinance will abolish four (4) Dentist 1 position with salary grade 14 and will create three (3) Dentist 2 with salary grade 17. The qualification standards for the created position include a Doctor of Dental Medicine, one (1)

year relevant experience with four (4) hours of relevant training and an eligibility under Republic Act 1080.

The funding for the created position to cover salaries and benefits of the employees who will be appointed to the positions will be appropriated by the Sangguniang Panlungsod in the Supplemental Budget for calendar year 2025 of the City Government of Baccor.

RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, the Committee respectfully recommends that the Sangguniang Panlungsod approve the foregoing.

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was APPROVED during its 120th Regular Session.



RESOLUTION NO. 10 - 2024

RESOLUTION REQUESTING SANGGUNIANG PANLUNGSOD TO ABOLISH FOUR (4) DENTIST 1 POSITIONS WITH SALARY GRADE 14 AND CREATE THREE (3) DENTIST 2 POSITIONS WITH SALARY GRADE 17

Whereas, Republic Act 7160 known as Local Government Code of the Philippines mandates the provision of Health Care Services including Dental Health Services.

Whereas, at present there are four (4) Dentist 1 position with salary grade 14 and only one (1) is filled.

Whereas, the salary grade 14 of Dentist 1 is much lower to the salary grade of Nurses resulting to lack of applicants.

Whereas, at present there is only one (1) Dentist 2 position which is more enticing to applicants.

Whereas, lack of Dentists to provide public dental care may result to poor oral health services of the city.

Now Therefore, Resolved as it is hereby Resolved, that the abolition of four (4) Dentist 1 positions and creation of three (3) Dentist 2 position be requested to the Sangguniang Panlungsod for appropriate legislative action.
