Subject: ***A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE MEMORANDUM OF UNDERSTANDING BETWEEN THE DOST IV-A AND THE CITY GOVERNMENT REGARDING THE IMPLEMENTATION OF THE FOOD SAFETY PROGRAM IN THE CITY OF BACOR. DATED 20 MARCH 2023.***

Acting on the resolution authorizing the City Mayor to sign the Memorandum of Understanding (MOU) between the Department of Science and Technology (DOST IV-A) the City Government regarding , the implementation of the Food and Safety Programs/activities of the DOST chaired by Hon. Simplicio G. Dominguez respectfully reports that:

On 17 March 2023, the City Mayor endorsed a letter to Sangguniang Panglungsod, addressing Hon. Vice Mayor Rowena Bautista Mendiola, re: REQUEST FOR THE AUTHORITY TO ENTER AND SIGN THE MEMORANDUM OF UNDERSTANDING WITH DOST REGION IV-A.

In the letter dated 13 March 2023 submitted by HON. CARMELITA FABIAN-GAWARAN to HON. City Mayor STRIKE B. REVILLA re: UPDATING OF FOOD SAFETY MOU on DOST IV-A.

Findings:

The City Mayor has the authority to sign a Memorandum of Understanding (MOU) and contracts for the Implementation of the Food and Safety Programs/activities of the DOST on behalf of the City Government subject to prior authorization from the Sangguniang Panlungsod.

The Department of Science and Technology-Region IV-A (DOST IV-A) is legally authorized, to coordinate, monitor, promote and transmit the commercialization of technologies that could be used by micro, small and medium enterprises (MSMEs) to build their own respective businesses. The DOST IV-A has offered to provide technical assistance to MSMEs operating within the City of Bacoor as part of its Food Safety Program.

The Sangguniang Committee finds that the signing of the said Memorandum of Understanding by the City Mayor will benefit of MSMEs operating within the City that are engaged in the food industry.

RECOMMENDATION:

Upon evaluation, the committee respectfully recommends the outright **APPROVAL** of the said resolution. Further, to furnish the office of the City Mayor, the DOST IV-A, the University of the Philippines – Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this resolution.

INVOCATION

The Presiding Officer called the 35th regular session of the 5th Sanggunian Panlungsod to order at **11:45 a.m.** The session started late because the members of the city council participated in the official activities of the city government. Upon instruction of the Chair, the SP Secretary called the roll. All members were present. The Chair declared a quorum. An invocation was recited by Hon. Tela.

E. APPROVAL OF JOURNAL AND MINUTES OF THE 34TH REGULAR SESSION HELD ON MARCH 13, 2023 OF THE 5th SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOR.

The reading of the journal and minutes of the 34th regular session of the 5th Sangguniang Panlungsod dated March 13, 2022, were dispensed with upon motion of Hon. Solis. The journal and minutes were declared **APPROVED** by the Chair upon motion of Hon. Solis which was unanimously seconded by the members.

F. FIRST READING AND REFERRAL TO COMMITTEES OF PROPOSED ORDINANCES, RESOLUTIONS, MESSAGES, COMMUNICATIONS, PETITIONS AND MEMORIALS.
