FINDINGS:

Within their respective territorial jurisdiction, local government units are mandated to ensure and support the promotion of health and safety of their inhabitants, among others. As the gateway to the Metro, Bacoor houses thousands of workers who uses motorcycles as their form of transportation every day, DBDOYC, Inc. doing business as Angkas, the motorcycle taxi-hailing company, proposes to partner with the City in the promotion of Motorcycle Safety by providing of Bacooreño-motorcycle riders with basic training and education.


Dear Hon. Bautista-Mendiola:
