The regular session of the 5th Sangguniang Panlungsod was presided over by Acting City Vice Mayor Catherine Sarino-Evaristo and held on May 2, 2023, at the Sangguniang Panlungsod (SP) Session Hall, Bacoor Government Center. The session was formally opened at 8 p.m.

A letter was submitted to the Office of the Sangguniang Panlungsod on April 11, 2023, re: Application for Accreditation of South Gawaran Residents Association Inc. (SGRAI) as Urban Poor Organization (U.P.O.). The said letter was addressed to Undersecretary Elpidio R. Jordan Jr., Chairperson of the Presidential Commission for the Urban Poor located at 9th Floor, Sunnymede IT Center Building, 1614 Quenson Avenue, Quenson City.

The South Gawaran Residents Association, Inc. confirmed to the fact that they did not submit an accreditation application. They are not requesting any kind of official recognition; they are merely informing the Sangguniang Panlungsod about the aforementioned topic for awareness only.

The chairman motioned that this item be noted and removed from the agenda. The motion was seconded and unanimously approved by the council members in attendance.
