The BTMD Chief Mr. Edralin Gawaran recommend that the One-Way Half-Lane Road Access and the designated Parking Area along Evangelista to be implemented during the operational hours of the Night Market.

The Bacoor Traffic Management Department (BTMD) has prepared the necessary Traffic Plan which will be implemented by the enforcers once the Night Market or the Strike sa Negosyo is operational.

With the indulgence of the council, the SP Secretary stated the City Mayor was given authority to designate the traffic route for the said night market ordinance. Hon. Advincula, Committee Chair on Public Transportation and Traffic Management, to whom the said matter was referred to, moved that the same be **NOTED**. It was unanimously seconded by the members. The motion was declared approved by the Acting Chair.

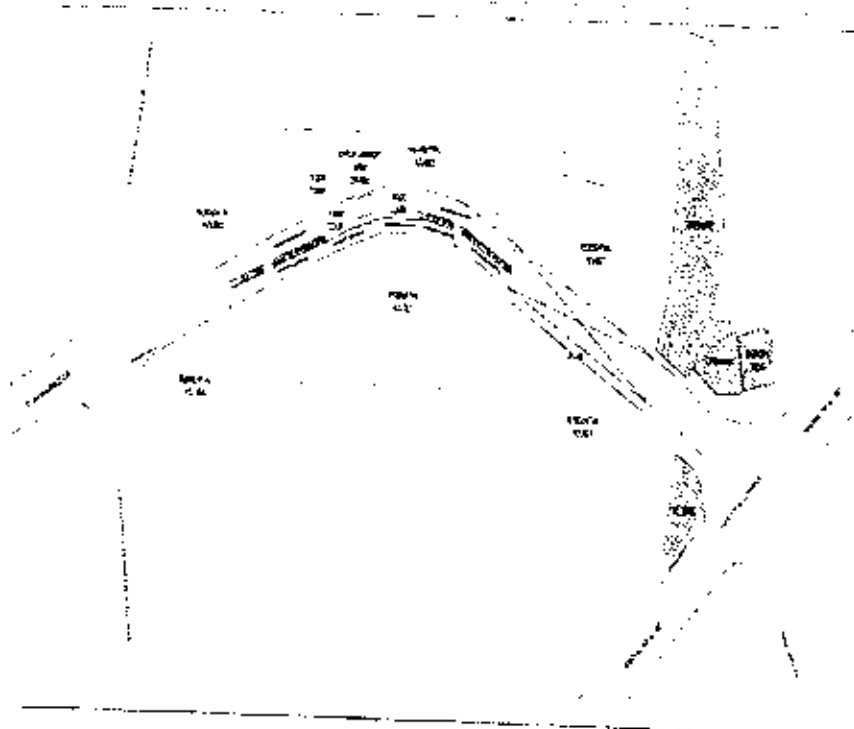

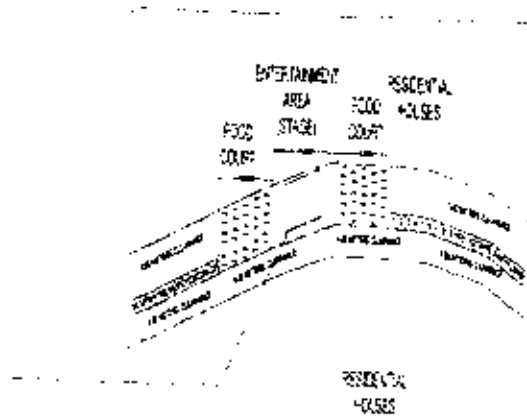
