LDIP is the principal instrument for implementing the Comprehensive Development Plan (CDP) and translates the CDP into programs and projects and selects those that will be picked up by the LGU for funding in the annual general fund budget or through special fund generation schemes.

The LDIP is coterminous with the CDP, it has a time frame of three (3) years broken down into annual streams of fund allocation of projects determined to be a high priority by the incumbent officials in consultation with various stakeholders.

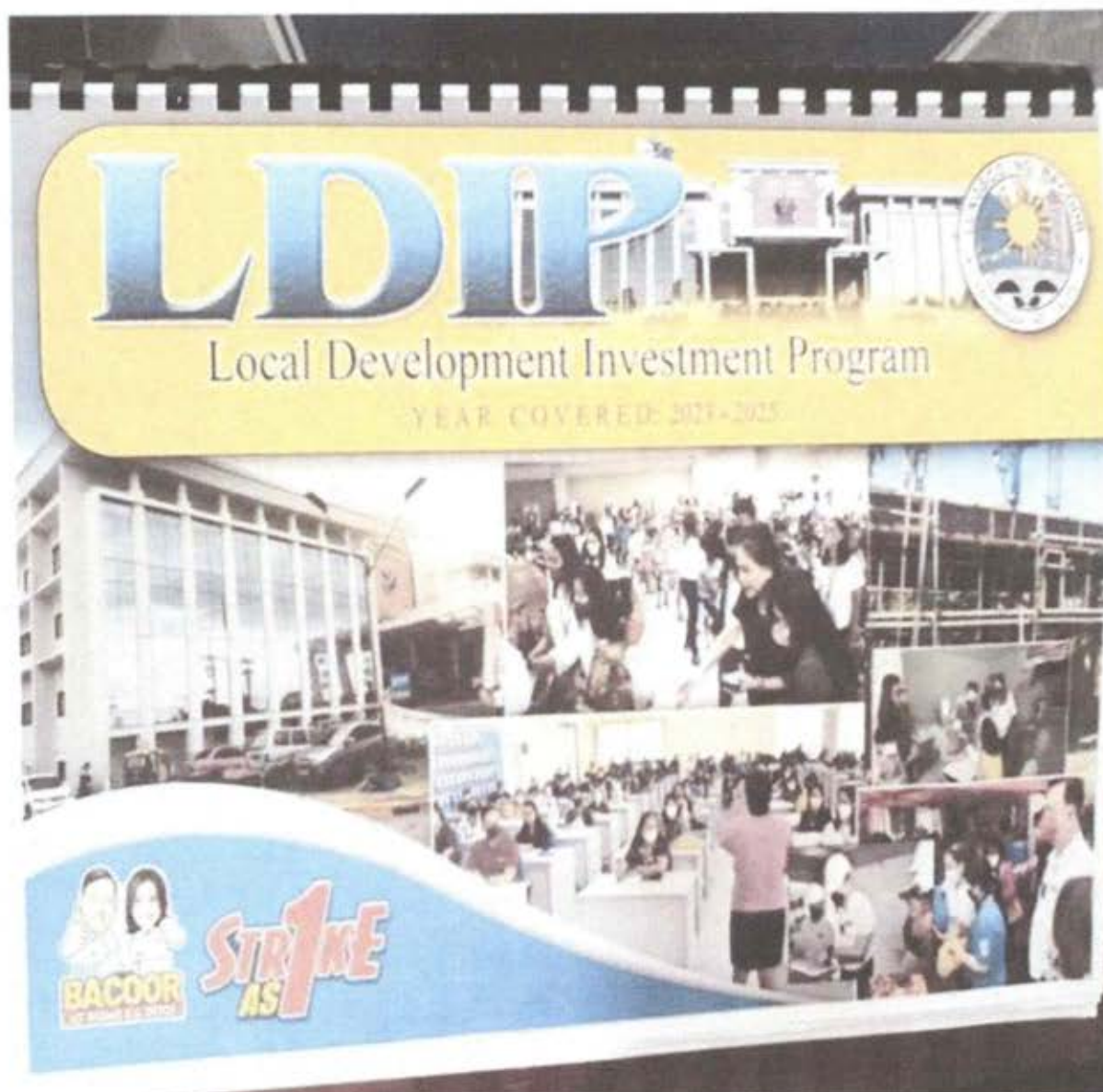
