This report a resolution authorizing the City Mayor, Hon. Strike B. Revilla to sign the urgent petition for the issuance of certificate of exception and authorization to release, disburse and expend public funds with the Commission on Election (COMELEC) in compliance with commission on elections resolution no. 10917, Series of 2023. The said Resolution was referred to the Committee by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, on June 16, 2023.

#### **FINDINGS:**

The foregoing discussion clearly showed that the Resolution will help Barangays. During the "Prohibited Acts" or acts which shall constitute election offense/s under Section 261, Article XXII of Balas Pambansa Big 881 (Omnibus Election Code) period from June 28, 2023 to July 27, 2023, this might delay the completion of various project and activities of the city government.

#### **RECOMMENDATION:**

After a thorough review of all the matters brought before its attention, the Committee recommends that a resolution be passed by the Sangguniang Panlungsod authorizing the City Mayor, Hon Strike B. Revilla to sign an urgent petition for the issuance of certificate of exception and authorization to release, disburse and expend public funds with the Commission on Election (COMELEC) in compliance with Commission on Elections Resolution no. 10917, series of 2023.



**Subject: Request for Authority to Enter Into and Sign the Urgent Petition for the Issuance of Certificate of Exception and Authorization to Release, Disburse and Expend Public Funds**

Dear Hon. Solis:

The City Government of Bacoor, with this Urgent Petition for the Issuance of Certificate of Exception and Authorization to Release, Disburse and Expend Public Funds with the Commission on Elections (COMELEC), is requesting the Sangguniang Panlungsod to issue and authorization for the City Mayor to sign the said Petition.

In line with such, the City Government of Bacoor is requesting the COMELEC to acknowledge the City Government's mandate of having the primary responsibility of delivering basic services under the Local Government Code during the period from June 28, 2023 to July 27, 2023 (the "Election Ban Period"), the similar period when electoral prohibitions might hinder or delay vital and imperative Programs, Projects and Activities (PPAs) of the City Government of Bacoor's departments, units, or offices for the welfare of the marginalized sector in the City of Bacoor.

This Urgent Petition will be submitted to the Honorable Commission in relation to time-specific "Prohibited Acts" or acts which shall constitute election offense/s under Section 261, Article XXII of Batas Pambansa Big 881 ("Omnibus Election Code") and for the issuance of a Certificate of Exception from the prohibition under Section 261(v) of the Omnibus Election Code for the following releases, disbursements and expenditures to be made by the City Government of Bacoor's departments, units and offices on the period of 28 June 2023 to 27 July 2023

In view thereof, I respectfully request the esteemed members of the Sangguniang Panlungsod to perform the appropriate actions that will grant the City Mayor the authority to sign the abovementioned Urgent Petition.
