Subject: A RESOLUTION AUTHORIZING THE PURCHASE OF FIVE (5) UNITS MOTOR VEHICLES BY THE GENERAL SERVICES OFFICE (GSO) IN SUPPORT OF THE PEACE AND ORDER/PUBLIC SAFETY PROGRAM OF THE LOCAL GOVERNMENT OF THE CITY OF BACOOR. – PCR-331-2023 dated June 26, 2023

Referred to this Committee is the above-subject matter for appropriate action and recommendation.

Perusal of the supporting documents attached with the endorsement letter of the Office of the City Mayor, Bacoor City dated June 19, 2023 will readily show that the request for the purchase of (5) motor vehicles are in order and reasonable.

Likewise, the Certification dated April 27, 2023 issued by the Office of the City Accountant and Office of the City Treasurer, Bacoor City certifies that the fund in the amount of FIVE MILLION EIGHT HUNDRED THIRTY THOUSAND THREE HUNDRED FIFTY PESOS (Php5,830,350.00) is available and allocated for the Peace and Order/Public Safety Programs (POPS) as per the approved Annual Procurement Plan for FY 2023-General Fund of Bacoor City.

Further, the Committee finds that the procurement request for the said motor vehicles have complied with the basic conditions and requirements of the DBM and DILG issuances, as follows:

- The requesting office/department of LGU must be qualified.
- The purpose and intended use of the motor vehicle to be purchased.
- The make and type of the motor vehicle must be within the specifications allowed by both DBM and DILG.




