

Upon your kind approval on the matter, we aim to comply with the necessary requirements so that we can commence with our proposed project the soonest possible time.

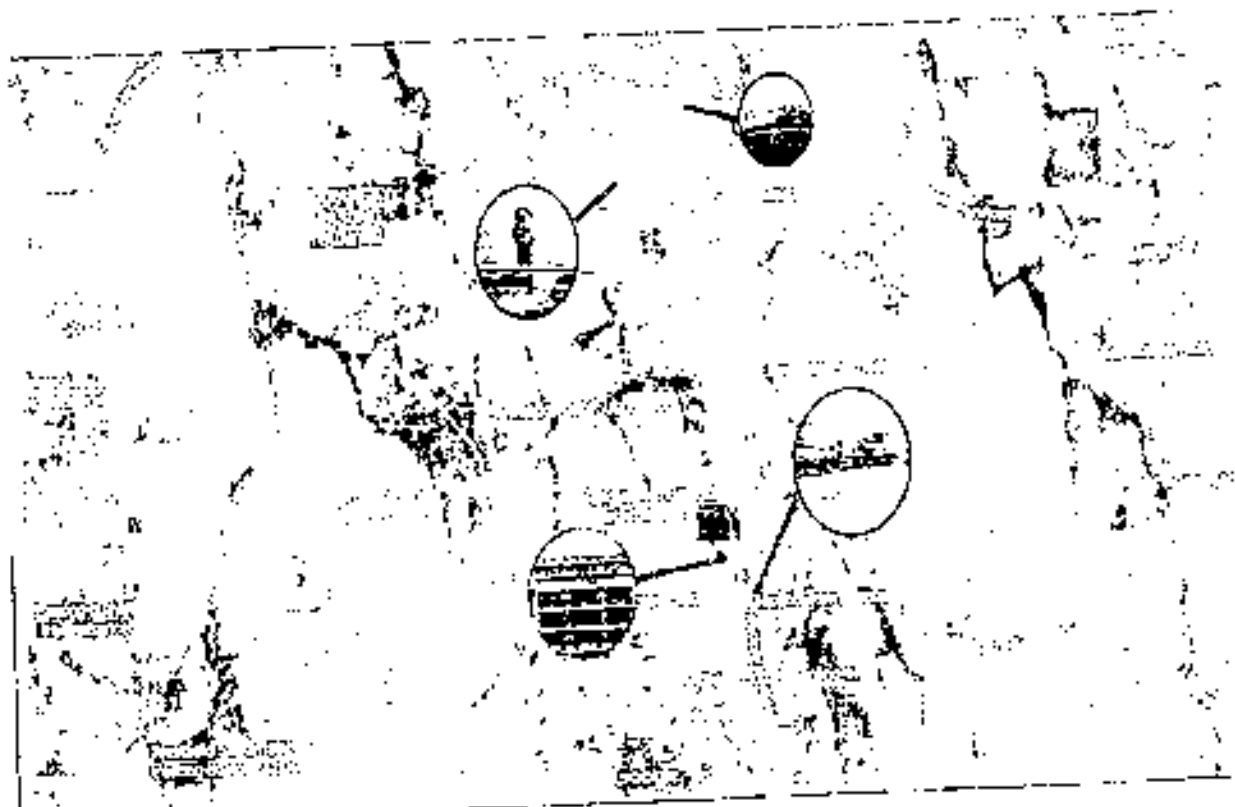

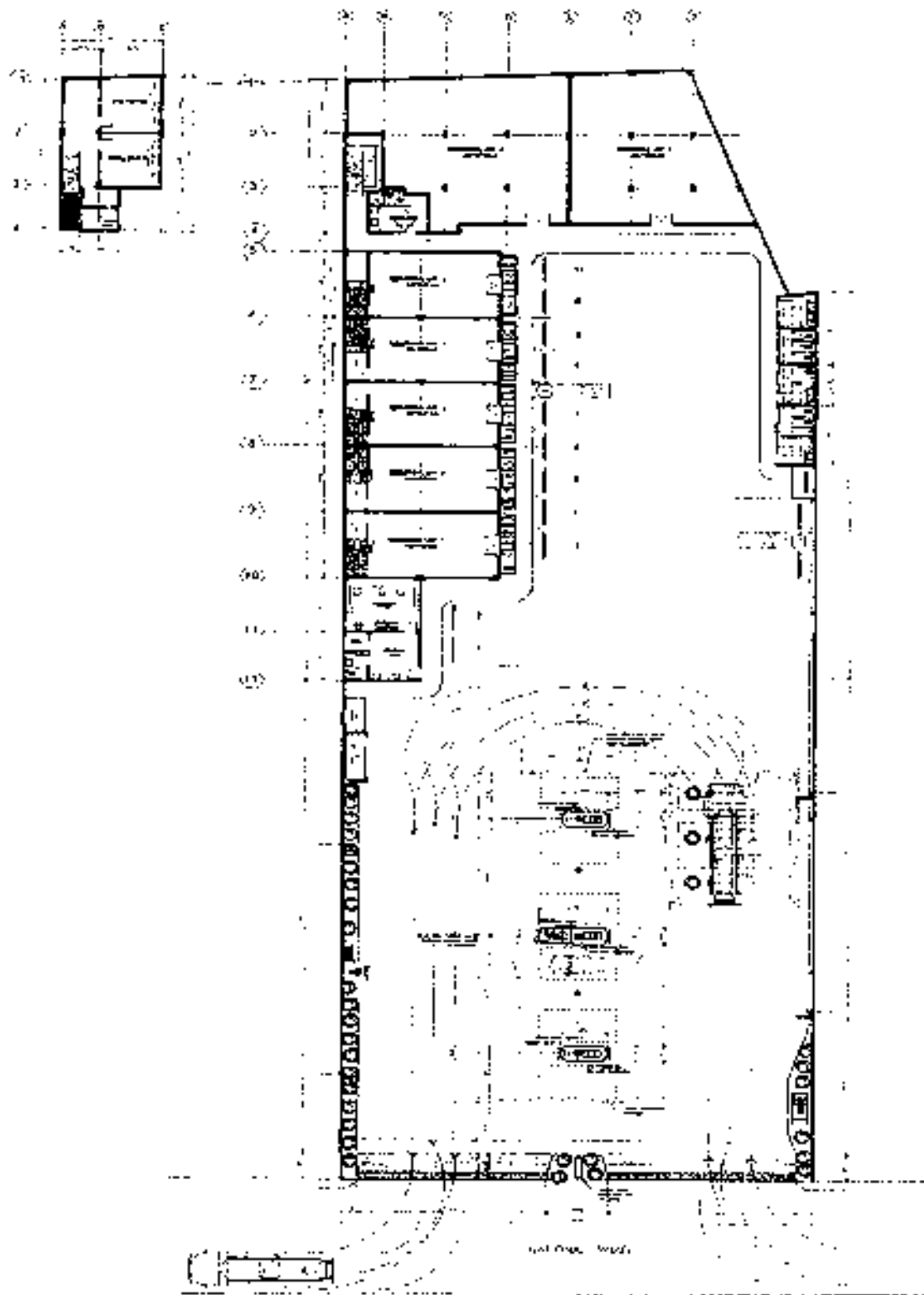
