**AN ORDINANCE GRANTING CASH INCENTIVES TO
RETIRING BARANGAY CHAIRPERSONS AND KAGAWADS.**

Sponsored by Councilor Reynaldo D.C. Palabrica

WHEREAS, the Punong Barangay plays the vital role in the development of the Municipality.

WHEREAS, the members of the Sangguniang Barangay are vital parts of the barangay government machinery.

WHEREAS, a number of Punong Barangays and Kagawads of Bacoor, Cavite are now at the end of their respective terms.

**NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY
ORDAINED** by the Sangguniang Bayan in session duly assembled that

Section 1: All barangay chairpersons who completed three consecutive terms and who will no longer be running in the upcoming barangay elections shall be entitled to cash incentives amounting to One Hundred Thousand Pesos (Php 100,000.00).

Section 2: All barangay chairpersons who finished two consecutive terms and will no longer be running in the upcoming barangay elections shall receive Ten Thousand Pesos (Php 10,000.00) as cash incentives.

Section 3: Barangay kagawads who have completed three consecutive terms and who will no longer be running in the upcoming barangay election shall receive Twenty Thousand Pesos (Php 20,000.00) as cash incentives.


Section 4: This ordinance granting the above-mentioned cash incentives shall only apply to barangay chairpersons and barangay kagawads who were truly elected in any of the 73 barangays of Bacoor, Cavite during the last barangay elections.

Section 5: The implementation of this ordinance is subject to availability of funds and compliance to all pertinent laws, government policies and regulations.

Section 6: Any provision of this ordinance which is declared unconstitutional shall not affect the validity of any other provisions hereof not affected by such declaration.

Section 7: This ordinance shall become effective fifteen (15) days after it has been posted in at least two (2) conspicuous places within the Municipality of Bacoor.

This Ordinance shall be deemed enacted and effective upon approval and publication.
