COMMITTEE HEARING REPORT

CEAGR-PCR-388-2023

Subject: A resolution concurring in the appointment of Atty. Kim Nyca R. Lofranco as the City Government Department Head I (City Legal Officer I) under the City Legal Office.

The above mentioned subject matter underwent its first reading on September 04, 2023 during the 59th Regular Session of the Sangguning Panlungsod. The said subject matter was referred by the Presiding Officer Hon. Rowena Bautista Mendiola to the Committee on Ethics, Appointments, and Government Reorganization.

The Committee on Ethics, Appointments and Government Reorganization sent out invitations to the resource persons and conducted a committee hearing on September 07, 2023 at the Session Hall of the Sangguniang Panlungsod at 8:30 a.m.

FINDINGS:

A City Legal Officer is responsible in formulating measures, develop plans and strategies, investigate on administrative cases, draft or review issuances or instruments, recommend measures related to upholding the rule of law, render legal opinion, and represent the City as counsel as well as prosecute in its behalf. Together with a team of competent attorneys and legal support staff, the Office of the City Legal Service likewise extends legal advice to walk-in visitors/constituents in the interest of justice.

A City Legal Officer is also tasked to perform such other duties and functions and exercise such other powers as provided for under the Local Government Code of 1991, and those that are prescribed by law or ordinance.



Subject: A resolution concurring in the appointment of Atty. Kim Nyca R. Lofranco as the City Government Department Head I (City Legal Officer I) under the City Legal Office.

- The committee hearing was called to order at exactly 8:30 a.m. on September 04 2023, held at the Session Hall of the Sangguniang Panlungsod of the City of Bacoor.
- The committee hearing was presided by City Councilor Hon. Reynaldo C. Palabrica.
- The Presiding Officer introduced the members of the committee and City Councilors present.
- The Presiding Officer asked the resource persons to introduce themselves before the Honorable Committee.
- The Presiding Officer asked Atty. Kim Nyca R. Lofranco the duties and resposibilities of a City Legal Officer.
- 6. Atty. Kim Nyca R. Lofranco enumerated the duties and responsibilities of a City Legal Officer which include the drafting, review and revision of ordinances and executive orders, implementing rules and regulations. She added that reviewing of contracts to be entered in to by the City Mayor is also included in the responsibilities of a City Legal Officer.
- 7. Atty. Kim Nycal R. Lofrance also said that a City Legal Officer is also responsible in formulating measures, develop plans and strategies, investigate on administrative cases, draft or review issuances or instruments, recommend measures related to upholding the rule of law, render legal opinion, and represent the City as counsel as well as prosecute in its behalf. Together with a team of competent attorneys and legal support staff, the Office of the City Legal Service likewise extends legal advice to walk-in visitors/constituents in the interest of justice.
- The Presiding Officer showed his astonishment on the narration and explanation made by Atty. Nyca R. Lofranca.
- The Presiding Officer asked the comments/suggestions of the HRDMD Head, Ms. Natividad Ludwig Ople.
- 10. Ms. Natividad Ludwig Ople manifested that Atty. Lofranca met the minimum requirement of the position including the five years related work experience.




