Subject: A RESOLUTION AUTHORIZING THE ACTING CITY MAYOR, HON. ROWENA BAUTISTA-MENDIOLA, TO SIGN A MEMORANDUM OF UNDERSTANDING WITH SM CITY BACOOR AND SM CITY MOLINO FOR THE IMPLEMENTATION OF LIBRENG SAKAY PROGRAM TO THE COMMUNITY FOR THE CITY OF BACOOR. (PCR. NO. 394-2023 dated September 11, 2023)

The hearing was held an September 14, 2023 [Thursday] at 3:00PM at MSBR Conference Room, 4th Floor, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor City.

FINDINGS:

LCU Bocoor recognizes the plight of the commuter population, as well as the confinuing problem in the increase on the price of gasoline which also greatly affects the local residents of the city of Bacoor.

RECOMMENDATION:

The City government of Baccor recognizes the role of the private sector particularly the shapping matts within the City of Baccor in contributing to the development of the city as well as for the enhancement of the quality of life for its residents.

MINUTES OF HEARING NO. SS-10-S-2023

Subject: A RESOLUTION AUTHORIZING THE ACTING CITY MAYOR, HON. ROWENA BAUTISTA-MENDIOLA, TO SIGN A MEMORANDUM OF UNDERSTANDING WITH SM CITY BACGOR AND SM CITY MOLING FOR THE IMPLEMENTATION OF LIBRENG SAKAY PROGRAM TO THE COMMUNITY FOR THE CITY OF BACGOR. (PCR NO. 394-2023 dated September 11, 2023)

Councilor Adrielito Gawaran, presided over the Joint Committee Hearing held last September 14, 2023 at exactly 3:00PM at MSBR Conference Room, 4th Floor, Bacoar Legistative and Disaster Resilience Building, Bacoar Government Center. He acknowledged the presence of the members of the joint committees and distinguished guests. He introduced the Honorable Councilors Simplicio Dominguez, Michael Salis, Reynaldo Palabrica, Levy Tela, Alejandro Gutierrez and Rogelio Notasco. He requested the attendees to introduce themselves. Bacoar Traffic Management Department representative Mr. Gerordo Foz, City Social Welfare and Development representative Ms. Chrisphina Castillo, and Office of City Legal Service representative Atty. Jesity Darla Moe Gutierrez, were gratefully acknowledged.

Committee Chairman read the written communication sent by the Acting City Mayor Hon. Rowens Bautista-Mendiala to Acting City Vice Mayor Hon. Catherine Sarino-Evaristo thru the SP Secretary Atty. Khalid Atega. Jr., stating the subject: Request for Authority to Enter into and Sign Memorandum of Understanding with SM City Baccor and SM City Molina. Then, he asked the members to state their concern about the Libreng Sakay Program.

Mr. Larenzo Calingasan, Assistant Vice President for Mall Operations of SM Group, introduced his team: Ms. Josephine Arvesu, Mall Manager of SM City Bacoor and Ms. Catherine Omarai, Regional Public Relations Manager of SM Cavile Malls. Mr. Calingasan started to discuss the offer of SM Group of Companies, like SM Malls in Cavite. Mr. Calingasan mentioned about seven [7] SM Mails in the entire Cavite such as; SM Malino and SM Bacoor, SM Dosmarinas (SM Market Mail Dasmarinas), SM Irrus, SM Tanza, SM Rosaria, SM Treae Martires and SM Tagaytay. They have more plans in the city of Bacoor, there is already a plan of constructing a third SM Mall. SM Malls express their sincere partnership with LGU Bacoor as their active participation in the nation building, particularly regarding transportation service.

According to him, with their previous discussion with the City Mayor Strike Revilla, the Honorable Mayor fortified their offer of transportation service at the last stretch of 2023. The LGU supports the SM program for commuters. In connection to the Bakood Festival 2023, on September 29, 2023, there will be an Opening of Bacoor One-Stop Shop (BOSS) at SM City Bacoor, wherein a Libreng Sakay Program is to be launched. This will help the commuter population reduce their continuing problem in moving from one point to another also, the increase on the price of gasoline which affects greatly the residents of Bacoor.

For the period September 29 – December 21, 2023 or more than six 6 months, the Libreng Sakay Program will start with 1 unit 60-seater Airconditioned Bus with Six (6) round trips cycle daily. Inside the bus, the first two(2) seats from the entrance door of the vehicle will be exclusive for Senior citizens, Person with Disability and Pregnant Women. They have contracted bus supplier operating from 10AM – 5PM. As a matter of fact, SM conducted Dry Run (simulation) today (Thursday) before 12noon, only to determine the travelling time. Point to point, like from SM Bacoor to SM Molino (30-45 mins) via Aguinaldo Hiway, St. Dominic, Bacoor Boulevard. Then, from SM Molino to SM Bacoor (22mins), (City Hall to SM Bacoor -12 mins) Via Bacoor Boulevard, Evangelista, Tirona.

Coun. Levy Tela clarified, "Mga empleyado ng City Hall lang ba ang sasakay? How will be the route pick up points?"

SM Representative said, "This is a point to point private transportation system, however, this will still be for review and study subject to changes, considering the no. of passengers."

Coun. Gawaran: As to travelling time problem, may we ask the help of BTMD? Mr. Gerry Foz recommended that they can designate Traffic Enforcers to give priority to the vehicle.

Coun. Reynaldo Palabrica: BTMD is short of enforcers. He also suggested to use a Radio Frequency for Radio Communication to ease the traffic situation. This is also for the benefit of regular commuters and City Hall employees. During pay day, employees usually go shopping or do grocery at SM Malls, Coun. Palabrica added. He suggested to study the no. of trips, assume the exact pick-up time, between 7-7:30 in the morning and 4-5 in the afternoon.

Coun. Gawaran clarified, "wala po ba kaming sasaguting financial sa programa na yan"?

Mr. Calingasan replied, "ang SM ang sasagot sa mga expenses", such as : gasoline expenses, rental of the vehicle, salary of the driver, repairs and maintenance of the vehicle and other expenses.

As to peace and order, Coun, Gawaran also suggested to give attention to the safety and protection of the commuters. "We may assign Uniformed Security Marshall steadily seating in the bus to look after the passengers' security."

Ms. Crisphina Castillo of CSWD is thankful for this program, "It will be of great help to reduce financial burden to the commuters particularly, senior citizens, person with disability and single parents and other PAY OUT recipients."

Atty. Jesily Darla Mae Gutierrez of CLSO said, the office will finalize the Memorandum of Understanding and as strongly emphasized by the body to consider the time element 7:30AM SM Bacoor pick up point going to City Hall, and 4:30PM pick up from City Hall.

Mr. Calingasan reminded the body, that holders of the SBR Card, will be the priority for the Libreng Sakay.

Coun. Rey Palabrica is grateful and even mentioned, "SM Malls is the biggest tax payer". He, then, recommend to pass a resolution regarding the above subject matter.

Coun, Gawaran acknowledged the harmonious partnership of SM Malls to Bacoor LGU.

There are no other matters to discuss, Coun. Alejandro Gutierrez moved for Adjournment, Coun, Palabrica seconded and other members of the council agreed.

The hearing was adjourned at 4:00 P.M.

This Memorandum of Understanding (the "Agreement") is made and executed this day of, 2023 (the "Effective Date"), at the City of Baccor, Province of Cavite, Philippines, by and between:
SM CITY BACOOR, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at Brgy. Gen. Emilio Aguinaldo Highway corner Tirona Highway Bacoor City, Province of Cavite, Philippines, and SM CITY

MOLINO, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Phillippines, with office address at Paliparan Road, Barangay Molino IV Bacoor City.

Province of Cavite, both represented herein

The CITY GOVERNMENT OF BACOOR a local government of the Republic of the Philippines, duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor Gity, Province of Cavite, 4102 Philippines, represented herein by its City Mayor, HON, STRIKE B. REVILLA, pursuant to his authority duly conferred and embodied under City Resolution No.

Series of Association approved by the City Council of Bacoon last ______, and hereinafter referred to as "LGU BACOOR"

The term "Party" shall mean either SM MALLS or LGU BACOOR, while the term "Parties" shall mean SM MALLS and LGU SACOOR, collectively.

्रें MTNESSETH:

WHEREAS, the State in the 1987 Philippine Constitution recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investment;

WHEREAS, Section 3 of the Local Government Code of the Philippines recognizes the participation of the private sector in local governance, particularly in the delivery of basic services, and encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development;

WHEREAS, LGU BACOOR as a local government unit of the State, likewise recognizes the role of the private sector particularly the shopping malls within the city in contributing to the development of the city as well as for the enhancement of the quality of life for its residents;

WHEREAS, the SM MALLS comprises two of the major shopping centers and recreational areas in the City of Bacoor, catering to the local residents, as well as to its neighboring cities;

WHEREAS, LGU BACOOR recognizes the plight of the commuter population, as well as the continuing problem in the increase on the price of gasoline which also greatly affects the local residents of the City of Bacoor:

WHEREAS, LGU BACOOR aims to give SM MALLS a chance to draw customers to their malls white also offering locals a chance to unwind and have fun in their premises without worrying about the cost of traveling there by car or public transportation;

WHEREAS, LGU BACOOR seeks to establish and uphold an agreement with SM MALLS and to enlist their help in implementing the "Libreng Sakay Program" for the citizens of the City of Bacoor, and the general public;

WHEREAS, SM MALLS agrees to cooperate with LGU BACOOR for the successful implementation of the 'Libreng Sakay Program";

NOW, THEREFORE, for and in consideration of the foregoing premises and mutual covenants, stipulations, and agreements hereinafter states, the parties hereto have agreed and do hereby agree as follows:

SECTION 1. OPERATION. The Libreng Sakay Program Vehicle (the "Vehicle") shall operate every day from 8:00 AM to 5:00 PM. The operating hours may vary depending in the mall operating hours of the partner malls.

SECTION 2. BUS ROUTE.

- A LGU BACOOR agrees to dispatch the Vehicle on the designated routes as agreed with SM MALLS. The copy of the official designated route for the *Librarg Sakay Program* is attached herein as Annex. A
- B: The official designated routes may be amended in writing upon recommendation of either, and subject to approval, of the Parties.
- The central point/terminal is where the motor vehicles will load or off-load residents or commuters at the start or end of its operation. The same shall be located at ______
- D. The Vehicle will travel the designated routes as it circles the City of Baccor, loading commuters or passengers on the street and stopping exclusively at each of the designated pick-off points.
- E. The motor vehicle shall stop at each designated pick-up/drop-off points, remain there and wait for passengers for at least ______ minutes and then proceed to the following stop.
- F. The LGU BACOOR consents the designation of the pick-up and drop-off location as determine and agreed upon by both Parties.
- SECTION 3. OBLIGATIONS OF SM MALLS. The SM MALLS undertake to provide and perform the following:
 - A. Provision of the Libreng Sakay Program Vehicle, which is a sixty (60) seater bus.

- B. Solely accountable for the expenses of the Libreng Sakay Program Vehicle, to wit:
 - a. Gasoline expenses;
 - b. Rental of the Vehicle;
 - Salary of the Driver;
 - d. Repairs and maintenance of the Vehicle; and
 - e. Other analogous expenses
- C. Dedicate the first two (2) seats from the entrance door of the Vehicle exclusive for Senior Citizens, Person with Disability, and Pregnant Women
- D. Warrants that the Vehicle sibeing driven by a skilled driver with a valid and legitimate Drivers License, and shall exercise due diligence in transporting the passengers of the Libreng Sakay Program.
- SECTION 4. OBLIGATIONS OF LGU BACOOR The SM MALLS undertake to provide and perform the following:
 - A Provide an LED signage and Gity Government of Baccor seal to be installed in the Library Sakay Program Vehicle; and
 - B Assist the Vehicle, through its Bacoor Traffic Management Department, during its course in the designated routes.
- SECTION 5.

TERM AND TERMINATION. Unless sooner revoked or terminated, the term of this Agreement shall be effective from the Effective Cate as stated in this Agreement and shall expire at midnight of 29 SEPTEMBER 2024. This Agreement may be renewed at the instance of either party, by sending the other party a written notice at least sixty (60) days prior to the expiration thereof, under such terms and conditions as may be mutually acceptable to the Parties.

Either Party may terminate this Agreement without cause by providing the other party a written notice at least thirty (30) days prior to the intentied date of termination, provided all outstanding obligations must be settled prior to such termination.

If either Party commits a material breach of any other terms and conditions of this Agreement, or unjustifiably refuses or fails to perform any of its obligations under this Agreement, the aggrieved Party may terminate this Agreement (i) effective immediately if the breach cannot be remedied; or (ii) if the breach may be remedied, within thirty (30) days from receipt of written notice of the material breach and the Party in breach has failed to cure such material breach or perform its obligations.

SECTION 6. INDEMNITY.

- A. SM MALLS understands and acknowledges that the services it will offer to the patrons of the Libreng Sakay Program and the general public shall be a transaction that is exclusively between the SM MALLS and the pertinent client availing of the services. Thus, all attendant responsibilities and liabilities relating to the services provided by the SM MALLS shall be the sole burden and shall be for the sole account of SM MALLS.
- B. Either Party shall keep, save and hold the other Party free from all liabilities, panalties, losses, damages, costs expenses, causes of action, claims of judgments arising out of or by reason of any injury or liability caused by any person or persons, while in, upon or in any way connected with the Premises during the term of this Agreement.
- C. LGU BACOOR or any of its officials and employees shall not be responsible for any damage, injury error or any complaint, in connection with the performance of services by the SM MALLS employees/driver of the Vehicle.
- D. All employees/staff and driver hired by SM MALES to drive and operate the Vehicle is not in any way connected with LGU BACOOR. Pietice any issue insofar as their safary, compensation benefits, and any other employer-employee concern is strictly between SM MALES and its employees/staff and driver. Furthermore: LGU BACOOR, including its officers, directors, employees and regresentatives, shall not be responsible to answer for or be liable for the death, disability, injury, theft, harassment, sickness, or any accident suffered by the employees? personnel and driver hired or outsourced by SM MALES while in the performance or exercise of their function/s.

SECTION 7.

REPRESENTATION AND WARRANTIES. Each Party to this Agreement hereby represents and warrants to the other that:

- It is an entity organized and existing under and by virtue the laws of the Republic of the Philippines, with full power and authority to enter into this Agreement;
- It has obtained all necessary corporate and/or governmental approvals and/or authorizations for the execution of this Agreement;
- C. This Agreement shall, upon its execution, be valid, binding and enforceable against it in accordance with the terms hereof;
- D. It has obtained the necessary permit/s, license/s, or authorization/s from the proper government agencies or offices to perform its specific obligations under this Agreement and shall maintain said permit/s, ilicense/s, or authorization for the entire duration of this Agreement;

- E. It shall be exclusively liable for any and all taxes, license fees, permit fees, charges and assessments which are imposed or may hereafter be imposed by the proper governmental tax authorities in relation to the performance of its specific obligations under this Agreement; and
- F. It shall faithfully comply with all the obligations, acts, and undertakings required hereunder, and conduct its business and operations in full compliance with all applicable national and local laws.

SECTION 8. MISCELLANEOUS PROVISIONS.

- A. <u>NON-EXCLUSIVITY</u>. SM MALLS agree that nothing in this Agreement shall in any way preclude other shopping mall entities or similar business establishments from entening into an agreement with LGU BACOOR that offers similar or analogous services.
- 8. <u>SEVERABILITY</u>. In the event that any provision of this Agreement is declared in any judicial or competent Government instrumentality to be void, illegal or otherwise unenforceable, the Parties shall amend the provision in such reasonable manner as will achieve the intention of the Parties and the remaining provision of this Agreement shall remain in full force and effect unless the Parties mutually agree that the effect of such declaration is to defeat the original intention of the Parties in which event, by mutual agreement, the parties may decide to terminate this Agreement.
- C. <u>AMENDMENTS</u>. This Agreement and any of the Annex/es to this Agreement may not be modified except in writing signed by the duly authorized representatives of the Parties after reasonable negotiations and discussions.
- D. <u>ENTIRE AGREEMENT AND INTEGRATION</u>. This Agreement and the Annexies to this Agreement constitute the entire agreement between the Parties with respect to the subject matter of this Agreement and supersede all prior agreements, discussions, proposals, whether written or oral on this subject matter.
- E. <u>AUTHORITY</u>. Each party represents and warrants on its own behalf that the individual signing this Agreement on its behalf is fully authorized to sign on behalf of and bind it, and that it has the power and authority to enter into it.
- F. APPLICABLE LAW/VENUE OF SUITS. This Agreement shall be governed by and construed in accordance with the laws of the Philippines. Any action or proceeding arising from or in connection with this Agreement shall exclusively be brought before a court of competent jurisdiction in Bacoor City, Cavite, to the exclusion of all other venues
