Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO PARTNER WITH THE UNIVERSITY OF THE PHILIPPINES-SCHOOL OF URBAN AND REGIONAL PLANNING (UP-SURP) FOR THE PREPARATION OF THE MASTERPLAN FOR THE 35-HECTARE LOT, SITUATED AT MALIPAY, BARANGAY MOLINO 4, BACOOR CITY, CAVITE, AS A MIXED USE COMMERCIAL, INDUSTRIAL, RESIDENTIAL TOWNSHIP DEVELOPMENT PROJECT OF THE LOCAL GOVERNMENT OF THE CITY OF BACOOR, CAVITE. Acting on the proposed resolution authorizing the City Mayor to enter a partnership with the University of the Philippines-School of Urban and Regional Planning (UP-SURP), the matter was referred to the committee by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, during the 63<sup>rd</sup> Regular Session, dated 02 October 2023.

The committee on Housing, Land Utilization and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan, respectfully reports the following:

The City of Bacoor, Cavite, recognizes the importance of holistic urban planning in insuring sustainable development, balanced growth, and the overall well-being of its residents. It owns a 35-hectare lot situated at Malipay, barangay Molino 4, Bacoor City, Cavite. This lot, its strategic location, presents an excellent opportunity to become a mixed use commercial, industrial, and residential township, thereby boosting the local economy and providing a suitable living environment for its residents.

The University of the Philippines-School of Urban and Regional Planning (UP-SURP) is a renowned institution in the field of urban and regional planning, having the expertise, knowledge, and resources to guide local governments in achieving their urban development goals.

In accordance with the Local Government code of 1991, Republic Act No. 7160, The City Mayor is empowered to represent the City in its business transactions and to sign all contracts upon the authority of the Sangguniang Panlungsod.

#### Findings:

It is clearly shown that a partnership with UP-SURP would ensure that the masterplan for the said 35-hectare lot is anchored on sound principles of urban planning and sustainability. It is of utmost importance to tap into the expertise of UP-SURP in preparing a comprehensive


