Subject: A RESOLUTION GRANTING THE ADDENDUM TO THE DEED OF DONATION IN THE CITY RESOLUTION NO. 2015-180 ENTITLED: A RESOLUTION RATIFYING THE DEED OF DONATION SIGNED AND ENTERED INTO BY THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR AND BY HOUSEHOLD DEVELOPMENT CORPORATION REGARDING THE DONATION OF OPEN SPACES LOCATED IN VARIOUS SUBDIVISIONS IN THE CITY OF BACOOR, CAVITE. PCR 406-2023 dated 09 October 2023.

This report hereby resolves to grant the addendum to the deed of donation as per City Resolution No. 2015-180, dated 21 November 2023. The said resolution was referred to the committee by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, during the 69th Regular Session held on 13 November 2023.

The Committee on Housing, Land Utilization, and Urban Development, under the esteemed chairmanship of the Hon. Alde Joselito F. Pagulayan reports the following:

On 20 October 2015, the City Government of Bacoor (City) and the Household Development Corporation (HDC) executed a Deed of Donation whereby the HDC donated in favor of the City, which includes among others, an open space lot at Springville Executive 2 Subdivision particularly described as Block 18 Lot 2 thereof with an area of Two Thousand Ninety-Eight (2,098) Square Meters and covered by Transfer Certificate of Title (TCT) No. T-725703.

On 29 August 2023, the City and the HDC executed a Memorandum of Agreement whereby the HDC, among others, agreed to:

1. To alter, subdivide, and convert the Donated Lot as follows:

And allocated in the following manner:

- a) Lots 2-A and 2-B shall be allocated to the City;
- b) Lot 2-C shall be allocated and transferred to Spouses Almirez; and
- c) Lot 2-D shall be allocated to the Second Party.
- Convert the various residential lots with an aggregate area of Six Hundred Fortyone (641) Square Meters owned by HDC into ("HDC Residential Lots") and the
 residential lot owned by Spouses Edwin Almirez and Theresa Gayle Almirez
 located at Block 1 Lot 4, with an area if One Hundred Fifty-four (154) Square
 Meters and covered by TCT No. T-1113082 into open spaces.

Findings:

The foregoing discussion clearly showed that, in the said MOA the City and HDC agreed within six (6) months following the subdivision, alteration and conversion of the Donated Lot, HDC Residential Lots and Almirez Lot, they shall execute an Addendum to the Deed of Donation to amend the lots covered by the donation.

RECOMMENDATION:

After a thorough evaluation, the committee respectfully recommends the **APPROVAL** of a resolution granting the addendum to the deed of donation in the City Resolution No. 2015-180.



Despite the absence of representatives from the Household Development Corporation (HDC), the committee hearing still proceeded.

Engr. San Jose brought attention to an issue involving a portion of the Brgy. Hall of Molino IV, which was constructed on a portion of a lot owned by Spouses Almirez. He noted that HDC has expressed willingness to realign the affected lots with their intended use and purpose, proposing alterations to their subdivision plans accordingly.

Atty. Mendoza provided legal insights, discussing previous agreements and procedural steps aimed at addressing concerns, including compliance with existing

regulations. This included a memorandum of agreement regarding property exchanges and a prior Sangguniang Panlungsod resolution.

The committee recognized the need for further procedure and outlined plans to inform HDC about compliance requirements.

The hearing adjourned with pending actions, including seeking legal opinions and conducting assessments.





Greetings!

The Sangguniang Panlungsod passed and approved City Resolution No. 2015-180 Series of 2015 entitled, "A Resolution Ratifying the Deed of Donation Signed and Entered into by the City Mayor, Hon. Strike B. Revilla, on behalf of the City Government of Bacoor and Household Development Corporation regarding the Donation of Various Residential Subdivisions in the City of Bacoor, Province of Cavite".

In line with this, a portion of the Barangay Hall of Barangay Molino IV was inadvertently constructed on the lot owned by spouses Almirez located at Block 1 Lot 4 with an area of One Hundred Fifty-Four (154) square meters, and in order to align the affected lots in conformity with their actual use and purpose, the Household Development Corporation proposed to alter the subdivision plans of Springville Executive 2 Homes and convert the portion of the lots donated to the City Government of Bacoor into a residential lot and the remaining HDC residential lots and the Almirez lot into an open space.

ADDENDUM (To the Deed of Donation dated 20 October 2015)

KNOW ALL MEN BY THESE PRESENTS:

This Addendum to the Deed of Donation dated 20 October 2015 ("Addendum") is made and entered into by and between:

The CITY GOVERNMENT OF BACOOR, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, herein represented by its City Mayor, HON. STRIKE B. REVILLA, upon authorization by the City Council of Bacoor for this purpose, hereinafter referred to as the "FIRST PARTY;

HOUSEHOLD DEVELOPMENT CORPORATION?, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at Lower Ground Floor, Bldg. B, Evia Lifestyle Center, Daang Hari Rd., Almanza Dos, Las Piñas City, herein represented by its Chief Finance Officer, BRIAN N. EDANG and Division Head, MARIA TERESA TUMABGA, hereinafter referred to as the "SECOND PARTY".

WITNESSETH: That -

WHEREAS, on 20 October 2015, the FIRST PARTY and the SECOND PARTY executed a Deed of Donation³ ("Deed") whereby the SECOND PARTY donated in favor of FIRST PARTY, which includes among others, an open space lot at Springville Executive 2 Subdivision ("Subdivision"), particularly described as Block 18 Lot 2 thereof with an area of Two Thousand Ninety-Eight (2,098) Square Meters and covered by Transfer Certificate of Title (TCT) No. T-725703 ("Donated Lot").

WHEREAS, On 29 August 2023, the FIRST PARTY and the SECOND PARTY executed a Memorandum of Agreement ("MOA") whereby the SECOND PARTY, among others, agreed to:

1) to alter, subdivide and convert the Donated Lot as follows:

2) convert the various residential lots with an aggregate area of Six Hundred Forty-one (641) Square Meters owned by SECOND PARTY into ("HDC Residential Lots") and the residential lot owned by Spouses Edwin Almirez and Theresa Gayle Almirez located at Block 1 Lot 4, with and area if One Hundred Fifty-four (154) Square Meters and covered by TCT No. T-1113082 ("Almirez Lot") into open spaces.

WHEREAS, in the said MOA the FIRST PARTY and SECOND PARTY agreed that within six (6) months after the subdivision, alteration and conversion of the Donated Lot, HDC Residential Lots and the Almirez Lot, they shall execute an Addendum to the Deed of Donation to revise the lots covered by said donation.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties agree as follows:

- The Donated Lot is removed from the list of Subject Properties in the Deed.
- 2) The donation of the SECOND PARTY to the FIRST PARTY is limited to Lots 2-A and 2-B⁴, of the Donated Lot, with an aggregate area of Eight Hundred Sixtyfive (865) Square Meters.
- It is understood and agreed that this Addendum shall take effect on upon execution hereof.
- 4) Unless otherwise provided in this Addendum, terms used herein shall have the same meanings ascribed to them in the Deed and MOA.
- 5) All the terms and conditions of the Deed and MOA not inconsistent with this Addendum shall remain in full force and effect, and the Deed and MOA together with this Addendum shall be read and construed as a single integrated document.
- 6) In the event of conflict or inconsistency between the provisions of this Addendum and Deed and MOA, the provisions of this Addendum shall prevail.
- 7) This Addendum shall be attached to, and shall form an integral part of the Deed and MOA.
