Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN A MEMORANDUM AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACoor, REGARDING THE TRANSFER OF FUNDS TO THE CITY TO FACILITATE THE DISTRIBUTION OF ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS) -PCR-411-2023 dated October 9, 2023.

Referred to this Committee is the above-subject matter for appropriate action and recommendation.

For ready reference, the Rationale of the Assistance to Individuals in Crisis Situations (AICS) program as stated in DSWD Memorandum Circular No. 16, Series of 2022, as amended, is hereunder quoted:

"The Department of Social Welfare and Development (DSWD), as the leader in social protection, continuously implements the Assistance to Individuals in Crisis Situation (AICS) program to support government efforts in providing aids to individuals, and families seeking assistance. The AICS serves as a stop-gap measure to support the recovery of individuals and families suffering from unexpected life events or crisis."

In the same DSWD memorandum circular, the transfer of funds to Local Government Units for the purpose is specifically provided under **Item IX-Modes of Providing Assistance**, we quote:

"**C. Other Disbursement Strategies**-The DSWD may resort to other expeditious means of distributions by engaging partners/service providers that able and willing to assist the Department.

As may be authorized and if applicable, the following disbursement strategies may be considered:
