Subject: *A CITY RESOLUTION AUTHORIZING THE ESTABLISHMENT AND RENAMING OF FOUR (4) SENIOR HIGH SCHOOLS IN THE TERRITORIAL JURISDICTION OF THE CITY OF BACOOR, PROVINCE OF CAVITE. PCR 414-2023 dated 16 October 2023.*

This report resolves the establishment and renaming of four senior high schools, dated 07 November 2023. The said resolution was referred to the committee by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, during the 65th Regular Session dated 16 October 2023.

The committee on Education, Science and Technology, chaired by Hon. Alde Joselito F. Pagulayan respectfully reports the following:

The City Schools Division of Bacoor is a promising division in Region IV_CALABARZON in terms of academic and non-academic performances and is fast-growing. The establishment and renaming of several public schools in the City of Bacoor aims to fully address the educational needs of the students and faculty members by giving each public schools an autonomy to implement the K-12 program as well as improvement of its facilities and programs; and

The Local School Board requested for the establishment and renaming of four (4) Senior High Schools in the City of Bacoor, Province of Cavite. Below is the table of present school name and a proposed new school name:

Coun. Pagulayan Good Morning. We now move on to the second item on our agenda. BCR 414-2023. A City Resolution Authorizing the Establishment or Renaming of Four Senior High Schools in the Territorial Jurisdiction of the City of Bacoor, Province of Cavite. Atty. Sumira you are recognized.

Atty. Sumira It was based on the Local School Board (LSB) Resolution. They are requesting for the change of the school names of existing Senior High School (SHS) in Bacoor.

Dr. Pambid This based on LSB Resolution No. 5 Series of 2023 presented during the board meeting (24 May 2023). The background is we have existing schools now for SHS. The problem is, they are not yet established. So along with establishment, the naming of their schools. For example, our **SHS Dulong Bayan will be renamed as MARIANO NORIEL SHS**, the **SHS in Sinaguelasan will be renamed and established as SINBANALI SHS**, the **SHS in Bacoor Elementary School will be renamed as EDILBERTO EVANGELISTA SHS**, and then the **SHS in San Nicolas will be renamed as REVILLA SHS**. And its acronym is Relevant Education Venue for Innovative Learners and Laudable Achievements. So that is the main reason for the renaming.

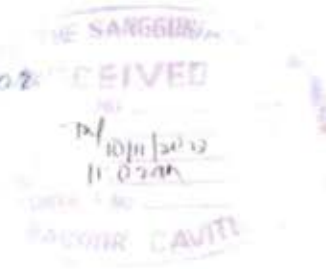

NOW, THEREFORE, ON MOTION DULY MADE AND SECONDED, the Board:

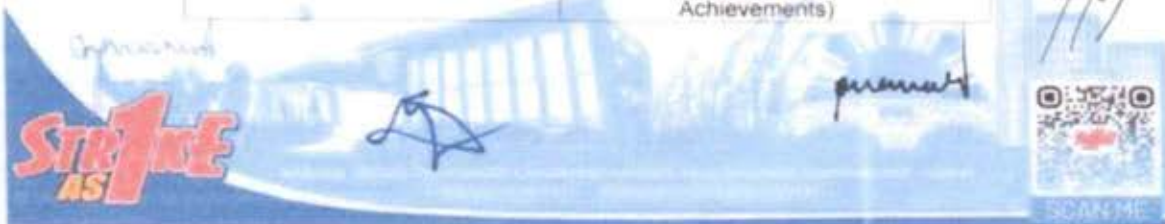




