### COMMITTEE HEARING MINUTES NO. PTTM-027-2023

Subject: - A RESOLUTION APPROVING AND RATIFYING THE CONSOLIDATION OF THE VARIOUS AMENDMENTS MADE BY THE SANGGUNIANG PANLUNGSOD ON CITY ORDINANCE NO. 2013-047 (THE ,REVISED TRAFFIC CODE OF THE CITY OF BACOOR') MADE BY THE SANGGUNIANG PANLUNGSOD SECRETARIAT AND THE BACOOR TRAFFIC MANAGEMENT DEPARTMENT PURSUANT TO SECTION 45 OF CITY ORDINANCE NO. 11-2019. The 65th Regular Session of the 5<sup>th</sup> Sangguniang Panlungsod was presided over by the Presiding Officer Hon. Rowena Bautista Mendiola held on October 16, 2023 at 10:00am at the Sangguniang Panlungsod Session Hall, 6<sup>th</sup> Flr. City of Bacoor Legislative and Disaster Resilience Building, Bacoor Government Center. The Presiding Officer declared a quorum.

The Revised Traffic Code of the City of Bacoor (the "Revised Bacoor Traffic Code") first came into being in 2013 with the approval of City Ordinance No. 2013-047. Since its approval, the Sangguniang Panlungsod has passed no less than 15 ordinances from 2013 to 2023 amending the various provisions of the Revised Traffic Code.

On October 10, 2023 the Sangguniang Panlungsod Secretariat and the BTMD got the opportunity to work jointly to comply with Section 45 of City Ordinance No. 11-2019.

On October 12, 2023, the final draft of the consolidation of various amendments to the Revised Bacoor Traffic Code was completed by the Sangguniang Panlungsod Secretariat.

The Sangguniang Panlungsod reviewed the said draft and found that it is faithfully reproduced and consolidated the various amendments made by the city council on City Ordinance No.2013-047.

The proposed resolution was declared approved by the Chair upon motion of Hon. Palabrica which was unanimously seconded by the members.

## PROPOSED CITY RESOLUTION NO.420-2023 Series of 2023

A RESOLUTION APPROVING AND RATIFYING THE CONSOLIDATION OF THE VARIOUS AMENDMENTS MADE BY THE SANGGUNIANG PANLUNSGOD ON CITY ORDINANCE NO. 2013-047 (THE "REVISED TRAFFIC CODE OF THE CITY OF BACOOR") MADE BY THE SANGGUNIANG PANLUNGSOD SECRETARIAT AND THE BACOOR TRAFFIC MANAGEMENT DEPARTMENT PURSUANT TO SECTION 45 OF CITY ORDINANCE NO. 11-2019.

#### Sponsored by:

WHEREAS, the Revised Traffic Code of the City of Bacoor (the "Revised Bacoor Traffic Code") first came into being in 2013 with the approval of City Ordinance No. 2013-047.

**WHEREAS,** since its approval, the Sangguniang Panlungsod has passed no less than 15 ordinances from 2013 to 2023 amending the various provisions of the Revised Traffic Code.

WHEREAS, Section 45 of City Ordinance No. 11-2019 provides that:

"Section 45. Review and Reprinting of the Revised Traffic Code. Due to the extensive changes made to the Revised Traffic Code by virtue of this Ordinance, the Sangguniang Panlungsod Secretariat and the BTMD are hereby directed to jointly review and reprint the Revised Traffic Code as amended hereby and to submit a report on any possible additional amendments that may be needed to be passed by the Sangguniang Panlungsod within thirty (30) working days after the date of effectivity of this Ordinance. A copy of the amended Revised Traffic Code shall be attached hereto as Annex "A" and shall be deemed a part of this Ordinance.xxx"

WHEREAS, due however to the work disruptions caused by the COVID-19 pandemic and the various additional duties that the Sangguniang Panlunsgod Secretariat and the Baccor Traffic Management Department had to perform in the effort to control the effects of the said public health emergency, it was only on 10 October 2023 that the Sangguniang Panlungsod Secretariat and the BTMD got the opprotunity to work jointly to comply with the aforequoted provision of City Ordinance No. 11-2019.

WHEREAS, on 12 October 2023, the final draft of the consolidation of the various amendments to the Revised Baccor Traffic Code was completed by the Sangguniang Panlungsod Secretariat.

**WHEREAS**, the Sangguniang Panlungsod reviewed the said draft and found that it faithfully reproduced and consolidated the various amendments made by the city council on City Ordinance No. 2013-047.

NOW THEREFORE, upon motion of Hon. \_\_\_\_\_\_, duly seconded by \_\_\_\_\_\_, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Baccor, Cavite in regular session assembled to approve and ratify the final draft of the consolidation of the various amendments to the Revised Baccor Traffic Code, a copy of which is attached hereto and made an integral part hereof as Annex "A".

**RESOLVED FURTHER**, to direct the Sangguniang Panlungsod Secretary and Mr. Adel Udarbe of the BTMD to submit a report to the Sangguniang Panlungsod on any additional amendments to the Revised Traffic Code that needs to be done.

**RESOLVED MOREOVER**, to direct the publication of the aforementioned consolidation of the various amendments to the Revised Bacoor Traffic Code and its posting in the official websites of the Bacoor City Government and of the Sangguniang Panlungsod.

**RESOLVED LASTLY**, to furnish the BTMD, all of the barangays of the City of Baccor, all homeowners associations in the City of Baccor, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and all other government agencies concerned with copies of this Resolution and its Annex "A".
