Subject: A RESOLUTION INTERPOSING NO OBJECTION TO TRES SUERTES GAMING CORPORATION TO OPERATE ALL PAGCOR APPROVED GAMES INCLUDING ELECTRONIC BINGO AND ELECTRONIC GAMES AT THE RFC MOLINO MALL, CITY OF BACCOOR, CAVITE. PCR 426- 2023 dated OCTOBER 23, 2023.

During the 68th Regular session of the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite, the Committee on Games and Amusement chaired by Hon. Michael E. Sais discussed the above-mentioned subject matter.

FINDINGS:

The Committee respectfully reports that:

1. Tres Suertes Gaming Corporation with an office address located at the 2nd Floor, MTR Petron Service Center Aguinaldo Highway, Dasmariñas City, Cavite is a domestic corporation duly organized and existing under the laws of the Republic of the Philippines;
2. Section 447(3) of the Local Government Code of the Philippines grants the Sangguniang Panlungsod the power, among others, to grant franchises, enact ordinances levying taxes, fees, and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality and to regulate any business, occupation, or practice of profession or calling which does not require government examination within the municipality and the conditions under which the license for said business practice of profession may be issued or revoked.

Dear Hon. Mayor Revilla,

I hope this letter finds you well and in high spirits. I am writing to you as the operator of Bingo Xtreme and Instant gaming located in RFC Malina Mall, Malina Road City of Bacoor Cavite. We currently have an existing Resolution of No Objection (RONO) with City Resolution No. CR2016-127 series of 2016, signed October 24, 2016 approved by Lante Meraño-Revilla's administration. I would like to emphasize that our gaming site which has been operational since 2017, has always adhered to the local laws and regulations set forth by the Local Government Unit (LGU) and Philippine Amusement and Gaming Corp (PAGCOR). We have consistently complied with all the guidelines and requirements, ensuring a professional playing environment. Important to note that we have a strict registration system that only registered players can enter and play, and only 21 years old and above can register.

After the ordered closure on May 19, 2023, the Office of the Building Official inspected our gaming site and found very minor issues which were immediately rectified and received approval after their second inspection.

With the closure of our gaming sites since May, we have encountered 1 million worth of payables in rent to our lessor. The extended closure not only impacted the loss of revenue of the company but also resulted in financial hardships of our employees and their families.

Considering the aforementioned factors, we respectfully request your assistance in allowing the re-opening of our gaming site. We are confident that, with your support, we can resume our operations responsibly.
