COMMITTEE HEARING REPORT

CRPLO-PCR-432-2023

Subject: *A resolution authorizing the donation of various motor vehicles registered under the name of City Government of Bacoor to other Local Government Units in the Province of Cavite.*

The above-mentioned subject matter underwent first reading on October 23, 2023 during the 66<sup>th</sup> Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Presiding Officer Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

**FINDINGS:**

In accordance with the Memorandum of Agreement between the City Government of Bacoor and Municipality of Naic, duly executed in November 2019, for the grant of assistance to the latter LGU for the relocation of 2,472 Informal Settler Families from Bacoor danger zones to a housing project in Rancho Verde, Naic, Cavite, two (2) mini-dump trucks and one (1) unit of ambulance for the use and benefit of the relocatees in Naic will be provided by the Bacoor LGU.

The City Government of Bacoor is the registered owner of two (2) units of mini dump trucks (high side) – HUDDRD, amounting to Two Million Seven Hundred Sixty Thousand Pesos (P2,760,000.00), and an ambulance with dual aircon complete with medical equipment and accessories – HUDRD, amounting to One Million Three Hundred Forty-Two Thousand Nine Hundred Fifty Pesos (P1,342,950.00), the motor vehicles particularly described as follows:

The 74<sup>th</sup> Regular Session was held last January 15, 2024 at the Session Hall of the Sangguniang Panglungsod. Due to the absence of the City Vice Mayor Hon. Rowena Bautista Mendiola because of an official business, City Councilor and President Pro-Tempore Hon. Reynaldo Palabrica presided the Regular Session and was called to order at exactly 10:00 a.m.

City Councilor Hon. Alejandro Gutierrez moved for the suspension of the internal rules duly seconded by the members of the Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of agenda item No. G.2-PCR-432-2023 – “A Resolution Authorizing the Donation of Various Motor Vehicles registered under the name of City Government of Bacoor to other Local Government Units in the Province of Cavite”, City Councilor and Acting President Pro-Tempore Hon. Alejandro Gutierrez moved for the approval of the above-mentioned subject matter.

The motion was unanimously seconded by all the Honorable Members of the 5<sup>th</sup> Sangguniang Panlungsod. A resolution authorizing the donation of various motor vehicles registered under the name of City Government of Bacoor to other Local Government Units in the Province of Cavite was **APPROVED**.
