Since the Sisterhood Agreement between the City Government of Bacoor and the City of Manila will foster friendship and goodwill, nurture closer relationship among their people and closer social and cultural exchange and economic ties, leading to growth and andvancement and eventually improve local autonomy, the Honorable Committee recommends that the Sangguniang Panlungsod approve the above subject matter.
