Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF PARTITION IN RELATION TO THE LOT 1-B CONSISTING OF SEVEN HUNDRED EIGHTEEN (718) SQUARE METERS DONATED BY THE LIGHT RAIL TRANSIT AUTHORITY (LRTA). (PCR 457-2023 dated 28 November 2023)

This report resolves to authorize the City Mayor, Hon. Strike B. Revilla, to sign a deed of partition donation by the Light Rail Transit Authority (LRTA), dated 30 January 2024. The aforementioned resolution was referred to the committee by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, during the 70th Regular Session held on 28 November 2023.

The LRTA is the registered owner of a parcel of land located in Barangay Zapote V. Bacoor City, consisting of ONE THOUSAND TWO HUNDRED AND EIGHTY-NINE SQUARE METERS (1,289 sq. m.) with the Transfer Certificate of Title No. 005-2022—3809. The City Government of Bacoor became the co-owner of a portion of this land, comprising SEVEN HUNDRED AND EIGHTEEN SQUARE METERS (718 sq. m.) through a DEED OF DONATION dated 29 January 2024.

The parcel of land was subdivided into two (2) lots in accordance with Psd-E2019008246. The Parties involved have mutually agreed to terminate their existing community of ownership and adjudicate their respective shares and participation.

FINDINGS:

It is evident that the Parties involved have voluntarily agreed to partition and adjudicate the parcel of land as described above.

RECOMMENDATION:

After a further evaluation, the committee recommends the APPROVAL of the above-mentioned subject regarding the deed of partition.


