The regular session of the 5th Sangguniang Panlungsod was presided over by City Vice Mayor Rowena Bautista-Mendiola and held on December 5, 2023, at the Sangguniang Panlungsod (SP) Session Hall, 6th Flr. City of Bacoor Legislative and Disaster Resilience Building, Bacoor Government Center. The session was formally opened at 10:30 a.m.

A letter from the Office of the Mayor was forwarded to the Vice Mayor's Office through the SP Secretary Atty. Khalid Atega Jr. The letter mentioned was sent by Bagong Bansang Maharlika Regional Director, Jovelyn G. Tibuasan, dated November 20, 2023.

Mr. Arnold Paras, the organization's president, submitted the identical request on June 22, 2023. The lack of requirements resulted in the application for accreditation being denied.

The Chairman of the Committee on Non-Government Organization, Hon. Reynaldo M. Fabian moved to archive this item due to a lack of requirements. The motion was seconded and unanimously approved by the council members in attendance.
