WHEREAS, the Parties agreed to hold the Workshop on 20 January 2024 at 1:00 PM at the Revilla Hall, Bacoor Government Center, Molino Blvd., Bacoor City, Cavite, which shall cater at least 100 participants ("Project");

WHEREAS, the Project shall contribute to the fulfillment of one of the missions of the Parties, that is, to educate aspiring content creators on the values of content creation, fundamentals of being a content creator, introduction to tools and equipment used relative thereto including audio and video editing;

WHEREAS, the Project shall contribute to FIRST PARTY's aim of promoting the value of quality media content in Philippine setting, given the current trend in media reception;

WHEREAS, the Project shall be considered as part of the CSR of the SECOND PARTY in educating the public youth about the advantages and disadvantages, benefits and dangers of social media content creation;

NOW, THEREFORE, the Parties hereto mutually agree to undertake, execute, and implement the Project in close collaboration and coordination with each other, subject to the following terms and conditions:

Section 1. Undertakings of the FIRST PARTY. – The FIRST PARTY, in support of this Project, shall provide the following:

- Program for the Project;³
- Venue for the Project, which shall be the Revilla Hall in Bacoor Government Center, Molino Blvd., Bacoor City;
- c. Meals for the members of the SECOND PARTY;
- d. Technical requirements for the Project (if any);
- Coordination of the Project with the SECOND PARTY's relevant teams (e.g., production, marketing, etc.);
- f. Project Coordinator who shall work with the SECOND PARTY's relevant teams, which shall be the City Information Office (CIO);
- Audience mobilization;

- h. Marketing publicities and advertisements;⁴
- i. Certifications
- Applicable permits and licenses; and
- k. Health and safety protocols, such as but not limited to, marshals, ushers, safety officers, and stand-by medic, if necessary.

Section 2. Undertakings of the SECOND PARTY. – The SECOND PARTY shall provide the following:

- a. Training and workshop services, including the presentation material, resource speakers, hand-outs, and the like;
- b. Transportation of the members of the SECOND PARTY;
- Marketing and publicity support; and
- d. Freebies, raffle prizes, giveaway, and the like, if any.

Section 3. Default. – If for any case, not attributable to fault of either Party, the Project could not be possible on the date scheduled, both Parties shall egree in writing on a mutually acceptable alternate date.

Section 4. Effectivity. - This Agreement shall come into force and become effective upon and as of the date of the signing hereof by the authorized signaturies of the Parties.

Section 5. Entire Agreement. – This Agreement constitutes the entire agreement between the Parties with respect to the transactions contemplated herein. All prior discussions, understandings, or arrangements between the Parties prior to the effectivity date hereof, whether express or implied, concerning the Project, are superseded by this Agreement.

Section 6. Confidentiality. – Each Party shall hold in strict confidence from any other person or entity all documents and information concerning any other Party, including their members, clients, and customers, furnished to it or its advisors, consultants, or agents by the other Party in connection with this Agreement or the transactions contemplated hereby.

Section 7. Severability. – In the event that any provision contained herein shall be declared invalid, illegal, or infirm in any respect by the competent authority, the validity, legality, and enforceability of the remaining provisions contained herein shall remain in full force and effect and not in any way be affected or impaired thereby.

Section 8. Amendment. – Any amendments or additional terms and conditions to this Agreement must be in writing, signed and acknowledged by the Parties.

Section 9. Governing Law. – This Agreement is governed by and construed in accordance with the laws of the Philippines.

Section 10. Venue of Action. – Any action or proceeding arising from or in connection with this Agreement shall exclusively be brought before a court of competent jurisdiction in the City of Baccor, Cavite, Philippines, to the exclusion of all other venues.
