Subject: A RESOLUTION AMENDING CITY RESOLUTION NO. 2023-374 ENTITLED: "A RESOLUTION AUTHORIZING THE PROCUREMENT OF VARIOUS MOTOR VEHICLES BY THE GENERAL SERVICES OFFICE FOR THE BACOOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (BDRRMO) UNDER THE TRUST FUND FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)— PCR-468-2023 dated December 5, 2023

Referred to this Committee is the above-subject matter for appropriate action and recommendation.



Honorable Reynaldo Palabrica Pro Tempore/Acting Presiding Officer called the 71st Regular Session to order.

Upon reading and referral of Agenda Item No. L.24 – PCR-468-2023 – "A RESOLUTION AMENDING CITY RESOLUTION NO. 2023-374 "A RESOLUTION AUTHORIZING THE PROCUREMENT OF VARIOUS MOTOR VEHICLES BY THE GENERAL SERVICES OFFICE (GSO) FOR THE BACOOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (BDRRMO) UNDER THE TRUST FUND FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)" REQUESTING TO CHANGE THE TYPE OF VEHICLE FROM (1) VAN TO A PICK-UP TYPE UNIT AMOUNTING TO PHP1,550,000.00." 


