Subject: *Request from PltCol John Paolo V. Carracedo for the issuance of manifesto in support of the shepherding of Philippine National Police priority legislative measure for 19<sup>th</sup> Congress.*

The above-mentioned subject matter underwent first reading on December 11, 2023 during the 72<sup>nd</sup> Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Presiding Officer Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

**FINDINGS:**

Adopting the current structure of the Philippine National Police including the pay and allowances of PNP personnel, amending for the purpose sections 25, 26, 29, 30, 31, 35, 36, and 67 of Republic Act No. 6975 otherwise known as the "Department of the Interior and Local Government Act of 1990" will enhance police operational efficiency and effectiveness, the Chief of the PNP may constitute, modify, or merge PNP units and offices as may be necessary including the corresponding changes in the number and distribution of ranks, or otherwise implement necessary adjustments in the organizational structure, staffing, functions, and functional relationships subject to the approval of the commission, provided that no PNP units and offices headed by a Police Brigadier General or higher can be created unless provided for by law.

**RECOMMENDATION:**

By motion of the Acting President Pro-Tempore Hon. Alejandro Gutierrez unanimously seconded by all the Honorable Members of the 5th Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 74<sup>th</sup> Regular Session.

The 74<sup>th</sup> Regular Session was held last January 15, 2024 at the Session Hall of the Sangguniang Panglungsod. Due to the absence of the City Vice Mayor Hon. Rowena Bautista Mendiola because of an official business, City Councilor and President Pro-Tempore Hon. Reynaldo Palabrica presided the Regular Session and was called to order at exactly 10:00 a.m.

Atty. Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod proceeded with the roll call, the approval of the Journal and minutes of the 73<sup>rd</sup> Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

Acting Presiding Officer Hon. Reynaldo C. Palabrica asked the members of the Honorable Council to elect among themselves the Acting President Pro-Tempore for the session. City Councilor Hon. Alejandro Gutierrez was elected as the Acting President Pro-Tempore for the session.

City Councilor Hon. Alejandro Gutierrez moved for the suspension of the internal rules duly seconded by the members of the Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of agenda item No. G.21-PCR-474-2023 – "Request from PltCol John Paolo V. Carradedo for the issuance of manifesto in support of the shepherding of Philippine National Police priority legislative measure for 19<sup>th</sup> Congress", City Councilor and Acting President Pro-Tempore Hon. Alejandro Gutierrez moved for the approval of the above mentioned subject matter.

The motion was unanimously seconded by all the Honorable Members of the 5<sup>th</sup> Sangguniang Panlungsod. The request from PltCol John Paolo V.
