Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN A MEMORANDUM OF AGREEMENT WITH "BRING ME HOME PHILS. CORP." FOR THE USE OF "BRING ME HOME: RFID/NDEF WRISTBAND WITH DATA BASE MANAGEMENT THAT WILL MONITOR AND OPERATE DIGITAL SERVICE SYSTEM FOR SENIOR CITIZENS AND MERCHANTS IN THE CITY OF BACOOR.-PCR-384-S-2023 dated August 29, 2023

Referred to this Joint Committee are the two (2) subject matters which are related and consolidated for appropriate action and recommendation.

THE BRING ME HOME PHILIPPINES, CORP. PROPOSALS:

For the record, this Joint Committee have already conducted a committee hearing sometime in September 2023 involving the same Bring Me Home Philippines Corp. (BHM). During the said committee hearing, the company presented their product (the RFID wristband), demonstrated its features and explained on how the product could easily track down and bring home the senior citizens or persons with disabilities who lost their way home due to dementia, Alzheimer and/or caused by any other mental illness.

The request to approve the authority (PCR-384-S-2023) for the city mayor to sign the Memorandum of Agreement with the BHM was held in abeyance and was later archived due to the absence of the draft of MOA. However, the draft of MOA with title "BRING-ME-HOME Draft MOA from the City of Bacoor" was later received by the Joint

Committee. The draft of MOA was reviewed but no further action was taken on the same.

INDORSEMENT DATED DECEMBER 4, 2023:

Come the second proposal of BHM for a joint project ("Project") submitted to the Sangguniang Panlungsod by the Office of the City Administrator thru its Indorsement dated December 4, 2023, with the attached draft of MOA entitled "BRING-ME-HOME Draft MOA from the City of Bacoor". In its indorsement, the Office of the City Administrator also invited the attention of the Honorable Members of Sangguniang Panlungsod to look into the various considerations that may be required in the "Project", as follows:

- Viability of the project considering the internet connectivity/access of senior citizens and PWDs;
- 2. Technicalities of the equipment and system to be used for its implementation;
- 3. Accreditation of BHM; and
- 4. The presence of focal persons from the sectors concerned as resource persons in the discussion meeting.

THE MEMORANDUM OF AGREEMENT (MOA):

Perusal of the present draft of MOA submitted for **the joint project** shows that it is the very same draft of MOA submitted to the Sangguniang Panlungsod to support the first offer of BHM under PCR-384-S-2023. The contents and provisions in the terms and conditions are all the same.

The only difference in the present proposal of Bring Me Home Philippines Corp. (BHM) is **a joint project** with the City of Bacoor for the use of their RFID wristband (with unified data management system) for digitalizing E-Booklet and services for senior citizens and person with disabilities in Bacoor City.

RESPONSIBILITY OF BRING ME HOME (BHM) UNDER THE MOA:

"3.1. Wristband.

BHM will finance the release of 70,000 pieces of wristband $x \times x$ at no initial cost. Payment of the wristband will be through the projected revenue sharing via SCRSS Portal subscription from section 3.3"



THE JOINT COMMITTEE HEARING:

On January 15, 2024, a Joint Committee hearing was conducted to seek the opinion, comments and reactions of focal persons as regards the viability and acceptability of the proposals. The said committee hearing was attended by the resource persons, namely, **Atty Venus de Castro** (Head of the Office of Senior Citizens Administration), **Atty. Salve Salvacion** (Office of the City Legal Service), **Mr. Lodgene Asuncion** (Head of Management Information Service), **Ms. Arsenia Constantino** (President, Senior Citizens Association, District I), **Ms. Tess Domingo** (President, Aniban Senior Citizen Association) and **Ms. Melody Tubice** (PWD Office).

The following facts are well established during the Joint Committee hearing:

- The Office of the City Legal Service maintained that they have no participation in the drafting of the MOA in question, nor they have knowledge of said Memorandum of Agreement entitled "BRING-ME-HOME Draft MOA from the City of Bacoor" prior to its ubmission to the Sangguniang Panlungsod.
- 2. The Office of the Senior Citizens Affairs manifested the following:
 - As per verification with the City Social Welfare and Development Office and senior citizen associations, there is no single report involving the case of missing senior citizen or person with the disabilities in Bacoor City.
 - The City Government of Bacoor is very compliant with the existing laws in regards to the care and monitoring of senior citizens and person with disabilities.
 - The provisions of Republic Act No. 1994 and its Implementing Rules and Regulations (IRR) explicitly mandated for the issuance of Identification Card and Purchase Booklet for senior citizens.
 - The proposed OSCA Plus Portal and PDAO Portal cannot be considered valid for lack of mandate and legal bases.



- The representative of OSCA and PWDs moved to reject the proposal of Bring Me Home Philippines, Corp. particularly the provision of their product (RFID Wristband), digitalization of booklet, integration of senior citizens and PWDs personal data portal into their web/portal, particularly the monitoring of purchases.
- 3. The Management Information Service (MIS) agreed with the manifestation and concurs with the motion of Atty. Venus de Castro to reject the proposals of BHM, citing with among others, the lack of authority and proper clearances of the company from national government agencies relative to the integration with the portal of BHM involving the personal data and information of senior citizen and PWDs.

FINDINGS:

The Joint Committee in its evaluation and deliberation concurs to reject the proposals of Bring Me Home Philippines, Corporation based on the following reasons:

- The enactment of an ordinance, a law, mandating the establishments/merchants in Bacoor City to subscribe with the web/portal of Bring Me Home Philippines, Corporation and to pay the corresponding subscription fee will create doubts and controversies.
- The City Government of Bacoor is compliant with the national laws pertaining to the needs, cares and monitoring of senior citizens and PWDs.
- The personal data and information of senior citizens and PWDs may not and cannot be entrusted to any private entity/ies without the express and written consent of the persons involved.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend to reject the proposals/offers of Bring Me Home Philippines, Corporation for the provision of its product, the RFID Wristband, and TO DENY/DISAPPROVE the request for a City Resolution authorizing the City Mayor, Hon. Strike B. Revilla to enter into and sign on behalf of the City Government of Bacoor the Memorandum of Agreement with the said company







The First in the Philippine market to offer RFID / NFC NDEF ready wristbands to identify a missing person with special needs under Person. With Disability (PWD) with FREE Web application and Senior Citizen Unified Data Management with Office of the Senior Citizens Portal, represented by its CoFounder/President DENIS ORSUA REYES with office and postal address at 10-1, 10F. One Global Tower, 5 Ave. cor 26 St. Benifacio Global City (BGC), Taguig to be known here as the "Second Perty".

-WITNESSETH-

Whereas the Republic Act 7277, 'An Act Providing for The Rohabilitation' Self-Development And Self-Reliance Of Disabled Person And Their Integration Into The Mainstream Of Society And For Other Purposes' and its implementing Rules and Regulations in Section 21.0, stipulates provision of family care services geared towards developing the capability of families to respond to the needs of the disabled members of the family.

Whereas Section 40 provides the Role of National Agencies and Local Government Units. Local government units shall promote the establishment of organizations of disabled persons in their respective territorial jurisdictions. National agencies and local government units may enter joint ventures with organizations or associations of disabled persons to explore livelihood opportunates and other undertakings that shall enhance the health, physical litness, and the economic and social well-being of disabled persons.

Whereas Section 41 provides Support from Non-government Organizations. Non-government organizations or private volunteer organizations dedicated to the purpose of promoting and enhancing the welfare of disabled persons shall, as they, are hereby encouraged, become partners of the Government in the implementation of vocational rehabilitation measures and other rotated programs and projects. Accordingly, their participation in the implementation of said.





measures, programs and projects is to be extended to all possible support by the Government. The Government shall sponsor a volunteer service program which shall hamess the involvement of private individuals in the provision of assistance to disabled persons.

Whereas Section 34 of RA 7160: Local Government Code of 1991 provides that nongovernmental organizations are active partners of the local government units and shall be involved in the plans, programs, projects and activities of the LGU to support delivery of basic services.

NOW THEREFORE, a Memorandum of Agreement has been drawn between the *First Party* and *Second Party* for the Implementation of Bring Me Home RFID/NDEF Wristband with Unified Data Management System for Digitalizing E-Booklet and Services System for Senior Citizens and Persons with Disability (PWD) in Bacoor City.

1. LEGAL BASIS

- 1.1. Section 16 and 34 of Republic Act No. 7160 otherwise known as the 1919 Local Government Code
- 1.2. Section 21D of Republic Act No. 7277 as amended by Republic Act No. 10070 And Republic Act No. 9442. Magna Carta for Disabled Persons, 1992, Republic Act No. 7277: This Act provides for the rehabilitation, self-development and self-reliance of disabled persons and their integration into the mainstream of society.
- 1.3. Expanded Senior Citizens Act of 2010 (Republic Act No. 9994)
- 1.4. Republic Act No. 7432. An act to maximize the contribution of senior citizens to nation building, grant benefits and special privileges and for other purposes.

2. PROJECT DESCRIPTION

In connection to the above background and legal basis, Bring Me Home (BMH) offers the first in the Philippine market, RFID wristbands to electronically identify a Senior Citizen or a person with disability.





Through the integration of the latest technology and owned web applications/portals, BMH devices can connect the whole community to identify the Senior Citizen or fragile loved ones to bring them to their homes, safe and sound.

With the unified data management system through comprehensive existing portals, Baccor City can easily project and analyze data, can digitize Booklets and discount calculations, can securely store its data, and can systematically improve its database management.

Bring Me Home ensures the development and implementation of effective and innovative approaches and methods to address the emerging concerns of the senior citizens.

3.0 PROJECT COST

The agreement a Public Private Partnership(PPP) under Build Own Operate with a projected Profit-Sharing between Bring Me Home and the City Government of Baccor.

3.1 Wristband

The **Second Party** will finance the release of 70,000 pieces of wristband to the **First Party** at no initial cost. Payment of the wristband will be through the projected revenue sharing via the SCRSS Portal subscription from Section 3.3.

The total cost of the wristband is PHP 650.00 per piece. At 70,000 units, the total cost is equal to PHP 45,500,000.00 which can be paid to the **Second Party** within the FIVE-YEAR Revenue projection at Section 3.4.

3.2 OSCA and PDAO Portal

The First Party will subscribe at the OSCA and PDAO Portal at NO COST.

3.3 Senior Citizens Reporting Services Portal (SCRSS Portal)

Through a City Ordinance, the participating establishments/merchants will use the OSCA Plus Portal – Senior Citizens Reporting Services Portal with an annual subscription fee of PHP 3,240.00 per registered merchant, that is a monthly subscription fee of PHP 270.00 per merchant.



3.4 Projected Cash Flow

Section 3.4 details the 20 Year project projection in Bacoor City with the following assumptions: 70,000 units of wristband

From the table above at PHP 270.00 monthly subscription fee of an estimated 5000 registered merchants with a 5% annual increase in the City, the projected revenue is PHP 119,483,825.15 minus the wristband cost of PHP 45,500,000.00. Thus, total amount is equal to PHP 73,983,825 revenue with a yearly average revenue of PHP 3,699,191.25

3.5 Cost planning & Cost reporting (PPP)

The PD will provide cost reports on a fortnightly basis. The cost report will be issued to the City Government fortnightly on Monday together with the progress report.

A summary of this cost control document on current and forecast expenditure together with projected cash flows will form the basis of the Regular Progress Report to be submitted.

The PD will maintain the Variation Register and Report on a regular basis to the City Government. The cost performance of the project including forecast cash flows during implementation stages, addressing the following:

- Original value of the project
- All changes
- Contingency allowed, used and unallocated
- Cash flow forecasts, actual and revised
- Effects of changes in OPEX and Admin costs
- Forecast cost
- Recommended actions available to maintain the project budget

3.6 Change Control Management (PPP)

The Change Control process will be implemented in accordance with both parties' standard processes. For any change from the original proposed cost of the project, a Requisition Variation Order Form (VO) will be issued and submitted for approval before any change is implemented. Any increase to a project budget must be approved by both parties nominated PM prior to being implemented using the VO form.





Contingency sums are not to be used to accommodate scope changes unless written approval from the City Government PM is received. The contingency amount is to be used for unforeseen expenditure caused by events which could not have been covered at the start of the project.

Any change in scope or activities is therefore, to be covered by raising a VO Form. It will be the responsibility of the change requestor to complete the VO; the Project Manager will track the review, approval and the final implementation.

3.7 Payment Management (PPP)

The BMH nominated finance manager will coordinate with the City Government Treasury office and submit the approved monthly financial report including the profit-sharing report.

BMH will remit the approved profit-sharing cost to the treasury office 15 days upon review and approval of the City Government treasury office.

4.0 METHODOLOGY

The purpose of these program is to have a device available for Senior Citizens and Persons with Disability that promotes the provision of family care services geared towards developing the capability of families to respond to the needs of the disabled members of the family, and to provide a database management system and interface with the latest technology for effective and efficient monitoring, control and for the use of the *First Party* for the systematic RA 7277, RA 7432, RA 9994 and RA 7160 promulgation approach as follows:

- 4.1 Registration: To be eligible for an account on the BMH WEB APPLICATION and OSCA Plus Portal, ONE MUST BE A USER of ANY BRING ME HOME PRODUCTS such as wristbands, tags, and other accessories or a registered merchant of the LGU.
 - 4.1.1. Register for an account with the WEB APPLICATION by signing up and clicking on the verification link in the email that the WEB APPLICATION will send.

Through the GO Digital program of Baccor City, a city wide registration will be conducted where participating Senior Citizens and PWDs will be invited to the Registration Period with the help of Bring Me Home team.

- 4.1.2. Users shall not allow any other person to use your account to access the WEB APPLICATION.
- 4.1.3. Users must notify us in writing immediately if you become aware of any unauthorized use of your account.





- 4.1.4. User must not use any other person's account to access the WEB APPLICATION.
- 4.1.5. If a user registers for an account, the user is free to choose whichever username and password.
- 4.1.6. Users are prompted to select whether you want your account to be private or public. Private Account entails to the accounts where the only visible to the tapper of the device is the contact details of the guardians. Whereas Public Account entails to those accounts where the DATA of the user of the BMH accessories are visible. 'DATA' is in accordance with Section 9 and Section 10 of BMH Terms and Conditions.
- 4.1.7. Username must not be liable to mislead and must comply with the content rules set out in Section 10 of BMH Terms and Conditions; user must not use any account or user ID for or in connection with the impersonation of any person.
- 4.1.8. User must keep his password confidential.
- 4.1.9. User must notify us in writing immediately if he becomes aware of any disclosure of your password.
- 4.1.10, User are responsible for any activity on WEB APPLICATION arising out of any failure to keep your password confidential, and may be held liable for any losses arising out of such a failure.
- 4.2 Control Facility: Access for the city /municipality OSCA Plus portals shall be authorized by the user, Non-Disclosure agreement shall be accomplished prior to the creation of access login as part of the Data Privacy Act.
- 4.3 Other Conditions: All applicable general conditions can be added in the system upon discussion and approval from the Second Party.
- 4.4 LGU: Name of the LGU focal person for Persons With Disability and Senior Citizens shall be included in case the user chose the Private Option.
- 4.4 Data Filter: The data can be filtered as per Province, City, Municipality, Barangay or Zone,
- 4.6 Dashboard: The system shall display a shortcut / ad-hoc report showing the total number of registrations per accessory type.
- 4.7 Helpdesk: The Second Party will ensure the availability of their customer's support or help desk from Monday to Friday (8:00pm to 5:00pm) for any questions or inquiries raised by the user.





4.8 Technical Support: Availability of Second Party and Admin staff whenever needed by the City Government of Baccor.

4.9 Data Management: The Second Party shall be acknowledged by the Persons With Disability Affairs Office (PDAO) and Office of the Senior Citizens Affairs (OSCA) of Bacoor City for recording. Data shall be submitted by the Second Party to PDAO and OSCA for a centralized data management center in Bacoor City.

5.0 SYSTEM & TECHNOLOGY

5.1 The System

The system shall be-cloud based to the Baccor City Government, *First Party*, including the development, integration, server, software etc on a subscription basis. The *Second Party* shall be responsible for the development, implementation, update, maintenance, server, redundant server and business continuity & disaster management procedure in relation to the system and technology being offered.

5.1.1 Portal/WEB APPLICATION FOR PWDs: The web system or portal can cater multiple access based on the user type. Access will be provided to the *First Party* designated Staff as admin and other authorized personnel. Only users of any Bring Me Home Product are allowed to use the web application for Persons with Disabilities. Contents of the system are modifiable according to the Bacoor City's needs. This system is free for Local Government Units.

5.1.2 Portal/WEB APPLICATION FOR Senior Citizens: The web system or portal can cater multiple access based on the user type. This shall be called the Office of the Senior Citizens Affairs Portal (OSCAP). Access will be provided to the *First Party* designated Staff as the super admin and other authorized personnel. This person will provide the BMH device and exclusive access to the portal. This system is free for Local Government Units.

5.1.3 Portal/WEB APPLICATION FOR Participating Merchants. The web system or portal can cater multiple access to the establishments, This shall be called the Office of the Senior Citizen Reporting Services Portal (SCRSS). Access will be provided to the *Merchants* designated Staff as the super admin and other authorized personnel. This system will have a monthly subscription fee of PHP 270.00 mandated by the City Government of Baccor and Bring Me Home.

5.2 Technology

In the current design, Bring Me Home wristband uses NFC technology to digitally identify the user in a secured manner with a systematic data management available for authorized persons.
