COMMITTEE REPORT

Subject: *A resolution authorizing the City Mayor to sign a Memorandum of Agreement (Sisterhood Agreement) between the City Government of Bacoor and the Municipal Government of Biri, Northern Samar.*

The above-mentioned subject matter underwent first reading on January 15, 2024 during the 74th Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Acting Presiding Officer Hon. Reynaldo C. Palabrica to the Committee on Tourism, Culture and External Linkages.

FINDINGS:

Republic Act No. 7160 allows local government units to group itself, consolidate or coordinate its efforts, services, and resources for purposes commonly beneficial to it. The Sisterhood Agreement between the City Government of Bacoor and the City of Manila could promote exchange of ideas and experiences in the field of Science and Technology, Culture and Arts, Tourism, Urban Planning and Development and Social Services among others. It will also institute a working avenue of communication in facilitating exchange of Information and Technology, Health Care Facilitation and Public Education leading to its growth and advancement and eventually self-sustainability.

RECOMMENDATION:

Since the Sisterhood Agreement between the City Government of Bacoor and the Municipality of Biri, Northern Samar will foster friendship and goodwill, nurture closer relationship among their people and closer social and cultural exchange and economic ties, leading to growth and advancement and eventually improve local autonomy, the Honorable Committee recommends that the Sangguniang Panlungsod approve the above subject matter.

By motion of Acting President Pro-Tempore Hon. Catherine S. Evaristo unanimously seconded by all the Honorable Members of the 5th Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 75th Regular Session.

EXCERPT FROM THE MINUTES OF REGULAR SESSION

Subject: *A Resolution authorizing the City Mayor to sign a Memorandum of Agreement (Sisterhood Agreement) between the City Government of Bacoor and the Municipality Government of Biri, Northern Samar.*

The 75th Regular Session was held last January 22, 2024 at the Session Hall of the Sangguniang Panglungsod. Due to the absence of the City Vice Mayor Hon. Rowena Bautista Mendiola because of an official business, City Councilor and President Pro-Tempore Hon. Reynaldo Palabrica presided the Regular Session and was called to order at exactly 10:00 a.m.

Khalid Atega, Jr., Secretary of the Sangguniang Panglungsod proceeded with the roll call, the approval of the Journal and minutes of the 74th Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

City Councilor Honorable Alde Pagulayan moved for the suspension of the internal rules duly seconded by the members of the Sangguniang Panglungsod, the internal rules were suspended.

Upon reading and referral of agenda item No. G.26-PCR-480-2023 – "A Resolution authorizing the City Mayor to sign Memorandum of Agreement (Sisterhood Agreement) between the City Government of Bacoor and the Municipality of Biri, Northern Samar", Acting President Pro-Tempore and City Councilor Hon. Catherine S. Evaristo moved for the approval of the above-mentioned subject matter.
