Acting on authorizing the city mayor to sign deeds of Absolute Sale during the 75th Regular Session dated 22 January 2024, the Committee on Housing, Land Utilization, and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan reported the following:

Under Section 16 of the Local Government Code, local government units are empowered to exercise necessary, appropriate, or incidental powers for efficient governance, and the promotion of the general welfare.

The City Government of Bacoor is committed to becoming a model first-class city, promoting the welfare of its constituents, and particularly providing humane housing facilities for the informal settlers and the underprivileged and homeless.

To fulfill this mission, the City Government has acquired adjoining real properties in Barangay Alima for the construction of a low-cost resettlement site. The expansion of existing thoroughfares is required for this project, necessitating the acquisition of portions of private properties directly adjoining the thoroughfare to be expanded.

#### FINDINGS:

The City Government of Bacoor is dedicated in promoting the welfare of its citizens by providing humane housing facilities and undertaking infrastructure projects aimed at enhancing the quality of life.

The acquisition of portions of real properties in Barangay Alima is essential for the development of a low-cost resettlement site and the expansion of existing thoroughfares, which are crucial for urban development and improved mobility.



Greetings in the name of public service!

Under Section 16 of the Local Government Code, local government units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those essential to the promotion of the general welfare.

The City Government of Bacoor envisions itself as a model first-class city. It has a mission to institute and promote the well-being and general welfare of its constituents. To fulfill this noble mission, the City Government positioned itself in the forefront of providing humane housing facilities for the informal settlers, and the underprivileged and homeless.

Currently, the City Government has acquired adjoining real properties located at Barangay Alima and it shall devote the same to the construction of a suitable and low-cost resettlement site. In turn, the project necessitates the expansion of existing thoroughfares leading to the project.

The expansion requires the City Government to acquire portions of real properties owned by private individuals. The said real properties are directly adjoining the thoroughfare sought to be expanded. Below is the enumeration of the titles and their respective owners reflected on each title.


