COMMITTEE HEARING REPORT

CHS-PCR-486-2024

Subject: *A resolution authorizing the City Mayor, Hon. Strike B. Revilla to sign a memorandum of agreement on behalf of the City Government of Bacoor with the Philippine Business for Special Progress (PBSP) relative to its intention to implement the advancing client-centered care and expanding sustainable services for tuberculosis (Access TB) project from 2024-2026.*

The above-mentioned subject matter underwent first reading on January 15, 2024 during the 74th Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Acting Presiding Officer, City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica to the Committee on Health and Sanitation.

The Committee on Health and Sanitation sent out invitations to the resource persons and conducted a committee hearing on February 08, 2024 at the Sangguniang Panlungsod Session Hall at 9:30 a.m.

FINDINGS:

Philippine Business for Social Progress (PBSP) is the principal recipient of the Grant provided by the Global Fund (GF) to fight AIDS, Tuberculosis and Malaria.

One of the key service delivery areas of the GF Project is to support the Philippine Department of Health (DOH) in implementing the National Tuberculosis Program (NTP), particularly the Philippine Acceleration Action Plan for Tuberculosis (PAAAB TB).

The DOH works through Local Government Units, private and public health facilities, hospitals and institutions to effectively and efficiently deliver quality and laboratory services, and Tuberculosis (TB) care treatment among TB patients covered by the GF Project.

The City Government of Bacoor is one of the LGUs that could effectively and efficiently deliver clinical and laboratory services among patients covered by the GF Project and has in fact collaborating with PBSP for many years now to provide quality clinical and laboratory services needed by the GF Project. This is beneficial to the City Government of Bacoor without incurring any expense in the implementation of the said project.

COUN. REYNALDO PALABRICA "Wala kaming idea kung ano itong entity na ito, ano pangalan mo?"

MR. JASON CALEZE "Jason po, Jason Caleze po. So bali wala po akong ibang kasama, so yung iba naming kasama ay nasa activity po, so ako po yung representative. Ako rin po kase yung may hawak ng ano, ahh nitong area pong ito".

COUN. REYNALDO PALABRICA "So ganito para maintindihan namin noh, hihingi kame ng ano, ng ano tawag dito, na ma-inform niyo kame. Ano ba itong PBSP? Ipakilala mo muna sa amin kung ano itong PBSP?"

MR. JASON CALEZE "Bali Philippine Business for Special Progress, isa po itong N.G.O. na..."

COUN. ALDE PAGULAYAN "Boy Morales?"

MR. JASON CALEZE "Boy Morales? Hindi po, bali ang nagsu-support po dito ay global fund po, ayun po. So hindi lang po siya dito sa atin, buong Pilipinas po ito na sinusuport ng global fund"

COUN. REYNALDO PALABRICA "Ahh, parang foundation ang dating nito".

MR. JASON CALEZE "Opo Konsi. Bali hindi lang po T.B. ang program na sinusuport ni PBSP. Actually may mga program pa po silang nakakalat sa buong Pilipinas."

COUN. REYNALDO PALABRICA "Pero concern nyo dito sa Bacoor ay specific muna sa T.B".

MR. JASON CALEZE "Yes po. Bali yun po ang support na binibigay. Actually po ang PBSP ang nanalo uli ng another bidder grant para isuport po yung programa ng T.B."

COUN. REYNALDO PALABRICA "So ang proposal nyo rito ay 2024-2026, three years. Anong tulong ang maibibigay nyo sa amin?"

MR. JASON CALEZE "Yes po, three years po. Ang nakapaloob po sa MOA natin Na ibibigay na support ay yung sa gene expert po, yung sa machine".

COUN. REYNALDO PALABRICA "Ahh, bibigyan nyo kame ng machine?"

MR. JASON CALEZE "Ahh, actually may machine na po tayo".

COUN. REYNALDO PALABRICA "So yung mga ano na lang, yung mga kailangan na lang ng machine sa pag test".

MR. JASON CALEZE "Yes po".

MR. JASON CALEZE "Sa machine po, yung mga cartridges ang ibibigay namin as part ng PBSP and then PBSP rin po ang mag-aayos kapag may diprensya ang machine at ang maintenance nito at no cost in the part of the City".

COUN. ALDE PAGULAYAN "Parts and repair?"

MR. JASON CALEZE "Yes po. Actually may engineer po tayo na umiikot dito buong Cavite para po ayusin yung mga machine natin if ever na magkakaroon ng problema".

COUN. REYNALDO PALABRICA "Aside sa machine or maintenance ng mga machine kung meron na, ano pa ang maibibigay ng foundation relative to this T.B. program natin?"

MR. JASON CALEZE "Yun pong mga cartridges na ibibigay, medyo costly po kase ang mga yun, yun po kase ang ginagamit sa pagpa process sa machine. Yun po ang support na ibibigay ni PBSP".

COUN. ALDE PAGULAYAN "Dito ba sa etibac, ahh sa Cavite, hahaha, marami na ba kayong naibigay na machine?"

MR. JASON CALEZE "Actually, nakakalat na po sa buong Cavite ang mga gene expert machines po natin, sa malalaking bayan, Dasma, Bacoor".

COUN. ALDE PAGULAYAN "Chair, Chair? Ilang test ang kaya nyong gawin sa isang buwan halimbawa?"

MR. JASON CALEZE "Ahh, sa isang araw po, kaya ng machine na magsalang ng 60. Medyo matagal din kase ang process".

COUN. ALDE PAGULAYAN "So 60 times 30 days, ayun yung kaya niyo?"

MR. JASON CALEZE "Actually, kapag nagka problema naman po dito sa area natin ng expert machine, may mga areas naman tayo na pwedeng ipadala ang mga specimen para doon i-process".

COUN. REYNALDO PALABRICA "Walang bayad yun?"

MR. JASON CALEZE "Wala po. Kargo po iyon ng PBSP".

DRA. IVY MARIE YRASTORZA "Sila rin po ang nagta-transport ng specimen from the health center".

COUN. REYNALDO PALABRICA "Doc, matanong ko lang po, anong status natin sa T.B. cases?"

DRA. IVY MARIE YRASTORZA "Hindi ko dala yung record pero mataas po ang cases natin, and also we are concentrating sa drug resistance T.B. Hindi na po ito ordinary treatment, kumbaga, level-up na".



Letter from PRSP

The Globe Fund In Fight Against AIDS, Tuberculosis, and Malaria ("The Globe Fund") awarded a new grant in favor of Philippine Business for Social Progress, Inc. ("PBSP") by the implementation of The Advancing Comprehensive Care and Economic Sustainability (ACCES) TB Project from 2024-2026 (CF Project).

This new grant would allow PRSP to continue its support of the Department of Health nation-wide, the Philippine Association Against Tuberculosis (PAAT) TB hub, consisting of 16 operations and activities of which shall focus on the screening, diagnosis, and treatment of TB patients.

With this, PRSP is able to enter into a new Memorandum of Agreement with the City Government of Bacoor for all three phases of the GS Project. Whereby, the continuance of the Memorandum of Agreement, PBSP wishes to formalize the partnership of PRSP and the City Government of Bacoor for the implementation of the GS Project to ensure its success until 2028-2029. Through this Letter, PRSP guarantees to provide and fulfill its obligations mentioned in 2024-2026. The duration of Agreement including the renewal, warranty and releases for the RDO operation provided by the City Government of Bacoor from 01 January 2024, until the execution of the Memorandum of Agreement.

PRSP represents the City Government of Bacoor signifies his agreement and consent to implement the services it has been rendered for the GS Project for the said commitment to execute the Memorandum of Agreement on or before January 31, 2024 by signing the continuing portion of this letter.

In this forward to receiving the city document signed letter on or before January 15, 2024.


