Referred to this Committee is the above-subject matter for appropriate action and recommendation.

Record shows that under City Resolution No. 2023-374, the Sangguniang Panlungsod authorized the purchase of various motor vehicles for the Bacoor Disaster Risk Reduction and Management (BDRRMO.






