COMMITTEE REPORT

GAA NO. 012 PCR 491-2024

Subject: *A RESOLUTION GRANTING A FRANCHISE IN FAVOR OF MR. ROBERT RAY LACSON TO ESTABLISH, OPERATE, AND MAINTAIN ONE (1) COCKPIT ARENA WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BACOR, CAVITE PURSUANT TO CITY ORDINANCE NO. 321-2023 (ALSO KNOWN AS THE "BACOR GAMING REGULATION ORDINANCE OF 2023 (PCR 491-2024 DATED JANUARY 22, 2024)*

After a thorough review of all the documents submitted by Mr. Roberto Ray Lacson, the committee found out that he complied with all the Laws involving all forms of business.

FINDINGS:

Thus, the committee found out that;

1. Blue Diamond Arena (OPC) has been operating for more than a decade;
2. Currently operating two (2) cockpit particularly the Silang Sports Arena located in Tubuan 3, Silang Cavite and Cavite Coliseum located in Bacoor City, Cavite.
3. That Mr. Lacson is applying for a cockfighting franchise located in Molino IV City of Bacoor, Cavite.

RECOMMENDATION:

In view thereof, the Committee respectfully recommends to pass a resolution granting a franchise in favor of Mr. Robert Ray Lacson to Establish, Operate, and Maintain one (1) cockpit arena within the territorial jurisdiction of the City of Bacoor, Cavite particularly in Barangay Molino IV pursuant to City Ordinance no. 321-2023 (Also known as the "Bacoor Gaming Regulation Ordinance of 2023.

COMMITTEE MINUTES

GAA NO. 012 PCR 491 – 2024

Subject: *A RESOLUTION GRANTING A FRANCHISE INFAVOR OF MR. ROBERT RAY LACSON RO ESTABLISH, OPERATE, AND MAINTAIN ONE (1) COCKFIT ARENA WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BACOR, CAVITE PURSUANT TO CITY ORDINANCE NO 321-2923 (ALSO KNOWN AS THE "BACOR GAMING REGULATION ORDINANCE OF 2023.. (PCR 491 – 2024 DATED JANUARY 22, 2024).*

During the 75th regular session of the 5th Sangguniang Panlungsod, the presiding Officer Pro-tempore Hon Reynaldo Palabrica referred the above-mentioned subject matter to Hon. Roberto Advincula vice chairman on committee on Games and Amusement.

Councilor Advincula informed the body that Mr. lacson already has two (2) cockpit operating in the City of Bacoor.

After a thorough review of the letter submitted by Mr. Roberto Ray Lacson the owner of the Blue Diamond Arena (OPC), Councilor Advincula then moved that the request of Mr. Lacson should be approved but instead of a typical cockpit arena, the franchise to be given to him should to establlish, maintain, and operate a Traditional Gaming Arena where traditional competitive filipino games such as arnis, sepak, takraw and sabong may be played for the enjoyment of Filipino and Tourism alike so that spectators shall have a better appreciation of Filipino culture and traditions.

The motion was seconded by Councilor Gutierrez, Councilor Francisco, Councilor Tela, Councilor Nolasco, and Councilor Fabian.

Hon. Gawaran suggested to the council to indicate the exact location of the Cockpit Arena in the resolution. The acting Chair declared the said item as APPROVED,
