COMMITTEE HEARING REPORT

CHS-PCR-499-2024

Subject: *A resolution integrating the Local Nutrition Action Plan (LNAP) 2023-2025 to the Local Development Plan of the City of Bacoor, Province of Cavite.*

The above-mentioned subject matter underwent first reading on January 15, 2024 during the 74th Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Acting Presiding Officer, City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica to the Committee on Health and Sanitation.

The Committee on Health and Sanitation sent out invitations to the resource persons and conducted a committee hearing on February 08, 2024 at the Sangguniang Panlungsod Session Hall at 10:15 a.m.

FINDINGS:

The City Nutrition Council (CNC) of Bacoor has formulated Local Nutrition Action Plan (LNAP) 2023-2025, a consolidated plans and programs of the council during the seminar workshop on the formulation of Local Nutrition Action Plan last October 24-25, 2023. As mandated through the Memorandum Circular 2028-42 of DILG is should be integrated in the Local Development Plan.

The City Nutrition Action Plan 2023-2025 of the City of Bacoor is the line of defense for continuous improvement of malnutrition problem existing in the city. The creation of the Local Nutrition Action Plan will ensure that malnutrition prevalence significantly decrease its target number. Presently, City of Bacoor is facing triple burden of malnutrition due to high magnitude of overnutrition and prevalence of undernutrition specifically, stunting and wasting.

The City Nutrition Action Plan contains key elements expected to improve quality of life through:

- **Sustainable Nutrition**

Ensure development of health by promoting nutrition programs that support long-term health and well-being for all Bacooreños, focusing on access to adequate, affordable nutritious food and sustainable food systems.

- **Bridging Nutritional Disparities**

Work towards implementing initiatives that address disparities in nutrition, considering the needs of vulnerable and under-served communities, promoting equal access to nutrition resources leading to holistic well-being and influencing individuals to adapt better lifestyle habits and practices.

- **Resilience in Nutrition**

Foster nutritional resilience within the city by establishing strategies that enhance the population's ability to adapt and recover from nutritional challenges especially during emergencies.

RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, the Committee respectfully recommends that the Sangguniang Panlungsod approve the above subject matter.

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 78th Regular Session.

COUN. REYNALDO PALABRICA "The proposed resolution integrating the Local Nutrition Action Plan (LNAP) 2023-2025 to the Local Development Plan of the City of Bacoor, Province of Cavite is now called to order."

COUN. REYNALDO PALABRICA "In attendance to this committee hearing are Councilors Levy Tela, Bok Nolasco, Alde Pagulayan and Simplicio Dominiguez"

COUN. ALDE PAGULAYAN "Ano po yung LNAP? Paki paliwanag po".

MS. CRISTINA ELALTO "Ano po, Local Nutrition Action Plan po".

COUN. REYNALDO PALABRICA "Ahh, nagawa na nila yan, so I brief na lang tayo ni Tintin, i-adopt na lang natin at aprubahan".

MS. CRISTINA ELALTO "Okey po. So ayán...."

COUN. REYNALDO PALABRICA "Actually, sa laki ng tiwala namin sa kakayanan nyo, hindi na naming babasahin yan, ano naman, performer naman tayo".

MS. CRISTINA ELALTO "Okey, good morning po ulit. Ang ating Local Nutrition Action Plan, ito yung idinulog naming sa SP, ito po ay plans and projects ng lahat po ng members ng City Nutrition Council, consolidated po ito, at ito po yung ating mga three-year plan, ano po. So consolidated po siya, kung saan ang target po nito ay kahit paano po ay maibsan yung mga proyektong, ah mabawasan ang prevalence ng malnutrition ng City of Bacoor, magtuloy-tuloy po siya. Ito po ay ina ano po naming na ma-implement. Although ini-implement naman namin talaga ito, part lang po, kailangan din po sa ating evaluation na dapat po talaga yung ating plan ay integrated po sa atin local development plan and ELA, so ayun po".

COUN. REYNALDO PALABRICA "May napansin lang ako dito, kase 3-year plan ito, nakalagay dito 2023-2025, eh 2024 na ngayon".

MS. CRISTINA ELALTO "Opo, yung 2023 po ay ano po yun ay talagang naka submit naman na sa kanila, ah parang formality, na late lang po talaga tayo sa formulation, pero talagang submitted na sa kanila yung ating AIP 2023, so parang ina attached lang nila".

COUN. REYNALDO PALABRICA "Included na ba ito sa annual budget sa 2024?"

MS. CRISTINA ELALTO "Opo, included na po, kumbaga yung naka ano naman dun na PPAs natin ay yung na-implement natin for 2023. So yung 2024 at 2025 ay continuous projects na implemented nung 2023. So ayun po, bali ang target po natin dyan ay ma work-out natin at magkaroon ng total reduction of about 20 to 30 percent sa ating prevalence sa malnutrition".

COUN. REYNALDO PALABRICA "So yung nasa AIP na ito, inapubahan na natin ang budget for 2024 diba?"

MS. CRISTINA ELALTO "Opo, integrated din po yan sa ating mga projects na submitted dun po sa ELA natin, kase usually yung sa ELA, ito yung mga PPAs na cinall-out dun sa mga target na PPAs po ng bawat opisina na may koneksyon po sa nutrition".

MS. CRISTINA ELALTO "Mahalaga po yan Konsi upang mapanatili natin ang ano, ang ating award".

COUN. REYNALDO PALABRICA "Oo naman. May mga comments pa ba kayo. Mga Konsehal baka meron pa kayong idadagdag or itatanong.

COUN. LEVY TELA "Wala na, malinaw naman ang presentation ni Mam Tintin"


