Subject: *A RESOLUTION AUTHORIZING THE CITY MAYOR , HON. STRIKE B. REVILLA, TO SIGN A DEED OF USUFRUCT AND EXPRESSING NO OBJECTION IN FAVOR OF DepEd-Bacoor, RELATIVE TO THE ESTABLISHMENT OF GEORGETOWN ELEMENTARY SCHOOL IN MOLINO IV. PCR 510-2024 dated 05 February 2024*

Acting on the resolution authorizing the City Mayor to sign a Deed of Usufruct and expressing no objection in favor of DepEd-Bacoor, the committee on education, science, and technology chaired by Hon. Alde Joselito F. Pagulayan respectfully reports that:

On 31 January 2024, the City Mayor endorsed a letter to Sangguniang Panlungsod, addressing Hon. Vice Mayor Rowena Bautista-Mendiola, re: REQUEST FOR ISSUANCE OF CITY RESOLUTION OF NO OBJECTION AND FOR AUTHORIZATION OF THE CITY MAYOR TO EXECUTE AND SIGN A DEED OF USUFRUCT.

In the letter dated 30 January 2024 submitted by Hon. Congresswoman Lani Mercado-Revilla to Hon. City Mayor Strike B. Revilla re: ENDORSING THE CITY SCHOOLS DIVISION SUPERINTENDENT, DR. BABYLON PAMBID, THE REQUEST OF THE PRINCIPAL AND COMMUNITY OF THE GEORGETOWN ELEMENTARY SCHOOL IN MOLINO IV FOR THE ESTABLISHMENT OF THE SAID SCHOOL BY LEGISLATIVE FLAT. Quoted hereunder is the content of the said letter requesting the following legal requirements for such an act of Congress:

1. *"City Resolution of no objection thereto, and for the authorization of the City Mayor to execute and sign a Deed of Usufruct in favor of DepED-Bacoor of the on which the said school is located;*
2. *For a Certification by the Zoning on the location of Georgetown Elementary School and for the details of the status of the said lot;*
3. *For a Local School Board resolution seeking for such establishment."*

Findings:

It is clearly shown that one of the legal requirements of the said bill to be approved by Congress is that the land on which the said school would be established should be owned by the government.

RECOMMENDATION:

Upon evaluation, the committee respectfully recommends the **APPROVAL** of the said resolution. However, the following pertaining documents, such as the Transfer of Certificate of Title (TCT) and Deed of Usufruct, shall be submitted to the Sangguniang Panlungsod Secretariat with the assistance of the good Office of the City Legal Services.



A. NAME

The school will be called GEORGETOWN ELEMENTARY SCHOOL, and will be known under the name, Bacoor III District of Bacoor City, Region IV A CALABARZON.

B. THE LOCATION OF THE SCHOOL

The school is located at Georgetown Heights Subdivision, Molino IV, Bacoor City, Cavite. It is an open space beside Bacoor National High School-Georgetown Annex located within the said village.

The area was chosen because it is very strategic since it is beside the secondary school and it is an open space for the construction of school buildings. It has an area of . This place is convenient and conducive for learning since it is located inside the subdivision. There are lots of transport services to and from the area. The tricycle transport service composed of more than 50 tricycle units providing 24-hour service.

C. JUSTIFICATION ON THE NEED TO ESTABLISH SCHOOL

The establishment of Georgetown Elementary School is in line with the Educational Extension and Expansion Program of the government. This is also congruent with the objective of the Department of Education (DepEd) to decongest the enrolment in Likha Molino IV Elementary School.

The establishment of the school will be a great move by the barangay for the constituents of Molino IV. At present there are seven (7) private schools in the area, where some of the low income cannot send their children in school. Poverty is one of the major problems that they encountered. Parents will have the opportunity to send their children in school without the burden of paying high tuition fees and other school fees.

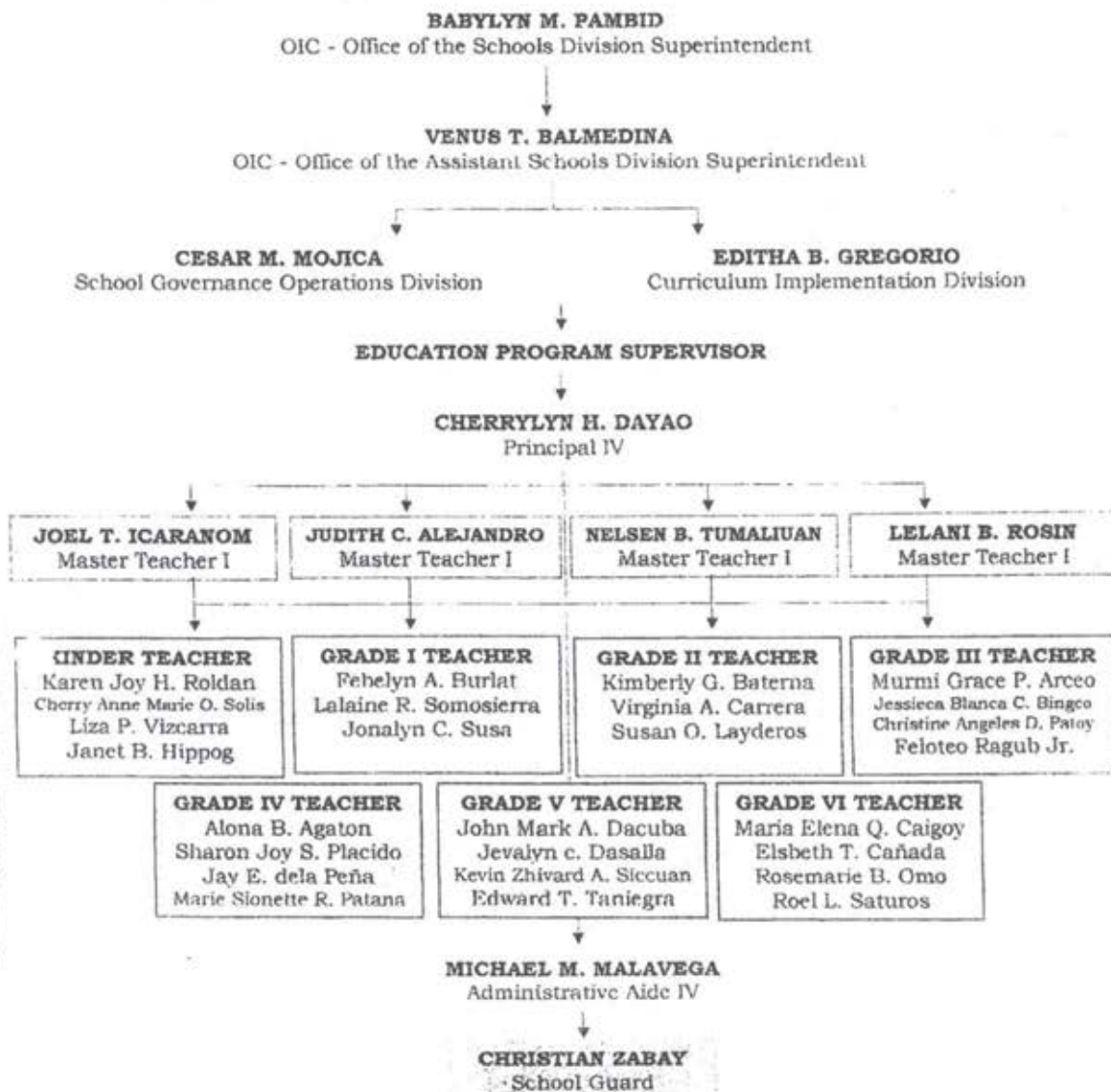

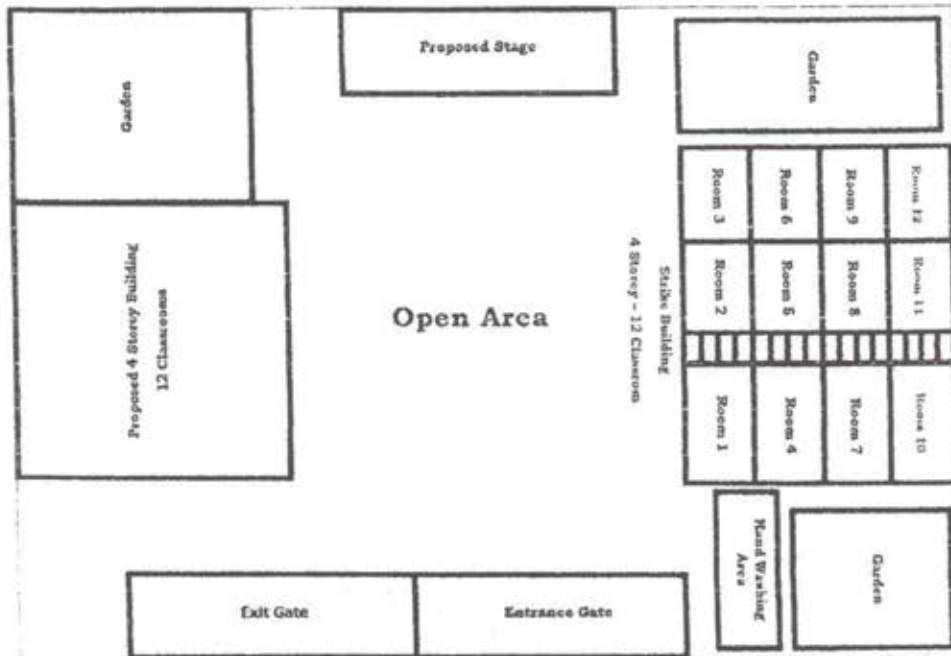

WHEREAS, Education is a fundamental human right and a foundation upon which people can build better lives, achieve their aspirations and contribute to society;

WHEREAS, The Philippine government has recognized the importance of education by enshrining the right to education in the 1987 Constitution which provides that the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, Republic Act 9155 declared the policy of the State to protect and promote the right of all citizens to quality basic education and to make such education accessible to all by providing all Filipino children a free and compulsory education in the elementary level and free education in the high school level;

WHEREAS, Sometime in June 2021, Georgetown Elementary School was inaugurated with four sections per grade level from Kinder to Grade 6;
