Subject: A resolution declaring the existence of a state of calamity at Manggahan St., Barangay Niog, City of Bacoor, Cavite and authorizing the release of Five Million Pesos (Php 5,000,000.00) from the City Disaster Risk Reduction and Management Fund for financial assistance, relief goods, and other incidental expenses related to relief and rehabilitation operations.

(Date referred: February 12, 2024)

The above-mentioned proposed resolution underwent its first reading on Febraury 12, 2024 during the 78th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice-Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

A letter from the Office of the City Mayor was received by the Sangguniang Panlungsod, requesting for a resolution declaring the existence of a state of calamity at Manggahan St., Barangay Niog, City of Bacoor and to authorize the release of Five Million Pesos (Php 5,000,000.00) from the City Disaster Risk Reduction and Management Fund (CBDRRMC) for financial assistance.

A fire broke out in a house at Manggahan St. in Barangay Niog, City of Bacoor, which rapidly spread to adjacent houses in the afternoon of February 10, 2024 resulting in massive damages to property and the displacement of around 150 families whose houses were destroyed. The requested fund from the CBDRRMC will be used in providing relief good, and other incidental expenses in relation to the relief distribution operations.
