# COMMITTEE HEARING REPORT

CBA-PCR-515-2024

Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN DEEDS OF DONATION REGARDING THE DONATION OF BICYCLES AND RADIOS TO THE 47 BARANGAYS OF THE CITY OF BACOOR, CAVITE ON BEHALF OF THE CITY GOVERNMENT. (PCR-515-2024 dated February 19, 2024)

### Findings;

On 79th Regular Session, the Sangguniang Panlungsod ng Bacoor received a request for authority to enter into and sign deeds of donation for the donation of bicycles and radios to the 47 barangays of Bacoor.

Under Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, local government units are empowered to exercise the powers essential to the promotion of the general welfare. This includes taking measures necessary for the efficient and effective governance of the city.

### Importance of Bicycles:

**Mobility**: Bicycles will significantly improve the mobility of barangay officials, enabling them to respond more quickly to community needs, emergencies, and public safety concerns.

**Environmental Impact**: Encouraging the use of bicycles supports eco-friendly practices and reduces the carbon footprint of the city government.

Cost Savings: Bicycles offer a cost-effective mode of transportation, with lower maintenance costs compared to motorized vehicles.

Importance of Radios:

Communication: Radios ensure reliable communication among barangay officials, especially during emergencies and disaster response efforts.

Coordination: Effective communication facilitated by radios enhances coordination and information dissemination within the barangays.

**Security**: Improved communication contributes to the overall safety and security of the community by enabling quick reporting and response to incidents.


