Referred to this Committee is the above-subject matter for appropriate action and recommendation.

Record shows that on November 13, 2023, the Sangguniang Panlungsod approved City Resolution No. 2023-377, Series of 2023 which authorized the City Treasurer, Atty. Edith Napalan, to open a separate bank account on behalf of the City Government of Bacoor for the financial grant to be provided by the Department of Agriculture (DA) in relation with City Resolution No. 2023-228, Series of 2023 entitled "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND THE DEPARTMENT OF AGRICULTURE RELATIVE TO THE LAUNCHING OF THE ENHANCED "KADIWA NI ANI AT KITA FINANCIAL ASSISTANCE PROGRAM"."

It appears that there is a change in the official title of the grant for financial assistance under the Kadiwa Financial Assistance Program of the Department of Agriculture (DA).
