
We would like to respectfully remind your office that certain conditions must be observed where eviction and/or demolition would involve underprivileged and homeless citizens before removal of their dwellings as provided under Section 28 of Republic Act 7279 otherwise known as Urban Development and Housing Act (UDHA) of 1992.

We do not intend to delay the implementation of the project, but we humbly recommend that a Certificate of Compliance (COC) pursuant to Executive Order 708 implementing rules and guidelines, certifying that mandatory requirements provided under UDHA, be secured first by the DPWH from the concerned LGU before any demolition and/or eviction involving underprivileged and homeless is undertaken. This is to ensure that the statutory entitlements of the qualified affected families of the project will be observed. Further, A Pre-Demolition Conference (PDC) is also a mandatory requirement based on the directive of the Department of the Interior and Local Government (DILG) to the Philippine National Police (PNP) prior to the approval of police assistance to such cases. 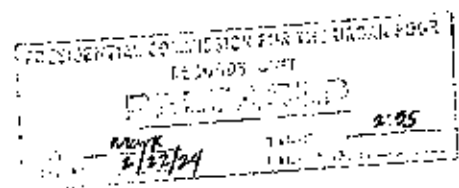

In light of these egregious violations of human rights and the continued disregard for legal authority, we implore you to intervene on behalf of our barangay. We humbly request your assistance in halting the illegal demolition activities, ensuring the safety and welfare of our residents, and safeguarding our access to essential services. We believe that your intervention will not only bring immediate relief to our community but also uphold the principles of justice and respect for human rights. Your prompt attention to this matter is greatly appreciated, and we look forward to your swift action in addressing this urgent issue.

**CITY GOVERNMENT OF BACCOOR
STOPS DPWH UNAUTHORIZED DEMOLITION IN MALIPAY**

The City Government of Bacoor has enforced an immediate suspension of the demolition activities currently in progress in Barangay Molino 4, specifically in the area of Malipay, due to a lack of coordination with the City Government of Bacoor, as mandated by City Ordinance No. 307-2023.

On February 8, 2024, it came to the attention of the City Government that the Department of Public Works and Highways (DPWH) had initiated demolition operations without the requisite coordination with the City Government of Bacoor headed by Mayor Strike B. Revilla. This action is in direct violation of the "Intergovernmental Relations Ordinance of the City of Bacoor," which requires all national agencies to work in cooperation with the city for any project planning and implementation within its jurisdiction.

Mayor Strike B. Revilla confirmed that there was no coordination and prior approval for the demolition and emphasized the need for the DPWH to adhere to the established ordinance by coordinating with the city prior to executing operations that impact local communities.

The ordinance seeks to ensure that all national projects, including demolitions, are carried out with proper notification and collaboration with the City Government to ensure the safety and well-being of affected residents. The housing team dispatched to the site confirmed the absence of coordination with the City's housing department.

Moreover, if the demolition is related to a court case, it is required to undergo a Pre Demolition Conference (PDC) conducted by the Presidential Commission for the Urban Poor (PCUP), in compliance with the Department of the Interior and Local Government (DILG) Circular. This aims to fulfill provisions stated in the Urban Development and Housing Act (UDHA) for the proper assistance of affected families, as assessed by the City Social Welfare and Development (CSWD).

The City Government of Bacoor remains firm in its commitment to the welfare of its citizens and will continue to enforce City Ordinance No. 307-2023 to prevent unauthorized activities and safeguard the rights of its constituents. The City is calling for the DPWH to coordinate with the local government immediately to resolve the situation in compliance with the legal requirements and to ensure that all future projects uphold the principles of cooperation and collaboration as laid out by the ordinance.
