Subject: A resolution confirming the assumption of Hon. Randy C. Francisco and Hon. Palm Angel S. Buncio as Chairpersons, Vice-Chairpersons, and members of various standing committee.

(Date referred: March 12, 2024)

The above-mentioned proposed resolution underwent its first reading on March 12, 2024 during the 82nd Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice-Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

On 14 November 2023, the Department of the Interior and Local Government (DILG)-Bacoor City conducted an election among the Sangguniang Kabataan (SK) Presidents of 47 barangays to represent the SK Federation President in the City of Bacoor. Hon. Palm Angel S. Buncio got the highest number of votes thus she became SK Federation President.

On 15 December 2023, the Liga ng Barangay (LnB) conducted an election for the officers of the Liga ng Barangay of the City of Bacoor. Hon. Rafael Paterno III was elected as LnB President while Hon. Randy C. Francisco as LnB Vice President respectively.

On 15 January 2024, Hon. Paterno won as Liga ng Barangay Provincial Chapter President and thus automatically became a member of the Sangguniang Panlalawigan.


