Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE PROVINCIAL GOVERNMENT OF CAVITE FOR THE GRANT OF FINANCIAL ASSISTANCE TO AID IN THE BACOOR TOURISM PROJECTS AND PROGRAMS. - PCR-546-2024 dated March 25, 2024

Referred to this Committee on the 84th Regular Session is the above-subject matter for appropriate action and recommendation.

BACKGROUND:

The City of Bacoor is spiced with generous dose of service-oriented and fun-filled events guaranteed to boost tourism and in promoting the rich cultural heritage of the people of Bacoor with which remarkably highlighting the talents of the local marching bands.

The City Government through the City Tourism and Cultural Affairs Department in pursuit of its tourism-related programs, projects and activities have sought the facilitation of financial assistance from the Provincial Government of Cavite. In turn, the Provincial Government expressed its willingness to provide the necessary financial assistance in accordance with its mandate under Republic Act No. 7160 otherwise known as the "Local Government Code of 1991".

Hence, the present request for a city resolution authorizing the City Mayor, Hon. Strike B. Revilla, to enter into and sign the Memorandum of Agreement (MOA) with the Provincial Government of Cavite relative to the financial assistance to be extended to the City Government of Bacoor in relation with the implementation of the tourism-related projects, programs and activities.

EXCERPT FROM THE MINUTES OF REGULAR SESSION NO. FBA-291-S-2024

Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR HON. STRIKE B. REVILLA TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE PROVINCIAL ASSISTANCE TO AID IN THE BACOOR TOURISM PROJECTS AND PROGRAMS. – PCR-546-2024 Dated March 25, 2024.

Honorable Rowena Bautista Mendiola, Presiding Officer called the 84th Regular Session to order.

Atty. Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod, proceeded with the roll call, the approval of the Journal and Minutes of the 83rd Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

On motion by Honorable Rogelio M. Nolasco which was unanimously seconded by the majority of the Honorable Members of Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of Agenda Item No. F.1.3 – PCR-546-2024 – "A RESOLUTION AUTHORIZING THE CITY MAYOR HON. STRIKE B. REVILLA TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE PROVINCIAL ASSISTANCE TO AID IN THE BACOOR TOURISM PROJECTS AND PROGRAMS." Honorable Rogelio M. Nolasco moved the approval for the Resolution authorizing the City Mayor to sign the Memorandum of Agreement to facilitate the financial grant by the Provincial Government of Cavite to the City Government of Bacoor for the implementations of priority programs including tourism related projects and activities.

The motion was unanimously seconded by the majority of Honorable Members of the 5th Sangguniang Panlungsod. A Resolution authorizing the City Mayor Hon. Strike B. Revilla to sign a memorandum of agreement on behalf of the city Government of Bacoor with the provincial assistance to aid in the Bacoor Tourism projects and programs was **APPROVED**.

The regular session was closed and adjourned at 12:29 P.M.

Under Section 17 (a) (4) (ix) of RA 7160, otherwise known as the Local Government Code of 1991, local government units are encouraged to be self-reliant and continue exercising the powers and discharging the duties, functions and responsibilities as are necessary, appropriate, or incidental to the efficient and effective provision of the basic services and facilities, such as public markets, slaughterhouses, and other city enterprises.

The City Government of Baccor, in its effort to promote the local culture and heritage of the City of Bacoor and highlight the remarkable talents of local marching bands, intends to implement priority projects and programs aimed at tourism development and tourism promotion. In line with the principles of cooperation under R.A. 7160, LGUs may coordinate their efforts, services and resources for purposes commonly beneficial to them. Considering that the City needs support in implementing its projects, and the Provincial Government of Cavite expresses commitment to render financial support to the City, this agreement has become necessary. Attached herewith is the draft Memorandum of Agreement for reference.

In view thereof, I respectfully request the esteemed members of the Sangguniang Pentungsod to perform the appropriate actions that will grant me the authority to enter into and sign the Memorandum of Agreement with the Provincial Government of Cavite.

MEMORANDUM OF AGREEMENT

The PROVINCIAL GOVERNMENT OF CAVITE, a political subdivision of the Republic of the Philippines, with an official address at the Provincial Capitol Compound, Trece Martires City, Province of Cavite, represented herein by its Governor, JUANITO VICTOR C. REMULLA, duly authorized for the purpose, hereinafter referred to as the "FIRST PARTY".

The CITY GOVERNMENT OF BACOOR, a local government unit created and existing under the laws of the Republic of the Philippines, with an official address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite, represented by its City Mayor, STRIKE B. REVILLA, duly authorized for the purpose, hereinafter referred to as the "SECOND PARTY".

WITNESSETH:

WHEREAS, the Local Government Code of 1991 declares as a State policy that local government units shall enjoy genuine and meaningful autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in attaining national goals LGUs may coordinate their efforts, services, and resources for purposes commonly beneficial to them;

WHEREAS, the Local Government Code further empowers the EGUs to exercise such other powers and discharge other functions and responsibilities as are necessary, appropriate, or incidental to the efficient and effective provision of the basic services and facilities essential to the promotion of the general welfare;

WHEREAS, these powers include the implementation of priority programs and projects for provision of the basic services and facilities including the tourism development and promotion programs as embodied under the Local Government Code of 1991;

WHEREAS, the SECOND PARTY seeks financial support for the implementation of its priority programs and projects/trainings;

WHEREAS, the SECOND PARTY has the necessary administrative and technical capabilities to successfully implement these programs including tourism development and promotion endeavors in close coordination with the FIRST PARTY;

WHEREAS, the FIRST PARTY has expressed its commitment to extend financial assistance to the SECOND PARTY in implementing these priority projects and programs;

WHEREAS, the Sangguniang Pantalawigan of Cavite passed Resolution No. _____, Series of 2024, duly authorizes Governor JUANITO VICTOR C. REMULLA to enter into a Memorandum of Agreement with local government units within the Province of Cavite for the grant of financial assistance for the latter;

WHEREAS, the Sangguniang Panlungsod of Bacoor, Cavite passed Resolution No. ____, Series of 2024, duly authorizes City Mayor STRIKE B. REVILLA to enter into a Memorandum of Agreement with the Provincial Government of Cavite for facilitating the grant of financial assistance for the former and ensuring compliance with the needed fund requirements;

NOW, THEREFORE, for and consideration of the above premises and the terms and conditions hereunder enumerated, the PARTIES to this Agreement hereby agree as follows:

COVENANT.

- The PARTIES shall take the necessary action to communicate and cooperate with each other and to perform their respective duties and responsibilities in order to achieve the objectives of this Agreement;
- The FIRST PARTY shall grant financial assistance to the SECOND PARTY to support the latter in the delivery of basic services and for the implementation of its priority programs, projects and activities;
- The SECOND PARTY shall promptly submit the approved project expenditures or estimated expenses indicating the project objectives and expected output for approval by the FIRST PARTY;
- 4. The SECOND PARTY shall exclusively utilize the fund granted for the implementation of its programs and projects in accordance with existing government budgeting, procurement, accounting, and auditing rules and regulations:
- The SECOND PARTY shall keep track of and make an accounting of its disbursements of the financial assistance received from the FIRST PARTY;
- 8. Within fifteen (15) days after the fund utilization, the SECOND PARTY shall submit to the FIRST PARTY a written summary and accomplishment report of the implemented activity/project, and liquidation report. The same shall include the certified true copies of the supporting documents for the implementation of the said priority programs and projects and such other pertinent information required by the FIRST PARTY;
